VETERANS-COMPETITIVE EXAMINATIONS FOR PUBLIC EMPLOYMENT.

AN ACT relating to veteran preference in competitive examinations; and amending section 1, chapter 189, Laws of 1945.

Be it enacted by the Legislature of the State of Washington:
