## State Elected Officials

---



**GARY LOCKE**  
**Governor**

Gov. Gary Locke was elected Washington's 21st governor on Nov. 5, 1996, winning a 58-percent majority. As governor, his goal is to make Washington schools the best in the nation.

The Locke family's history in Washington dates back to his grandfather. Around the turn of the 20th century, his grandfather worked as a house boy in Olympia, not far from the state capitol. His grandfather later returned to China to marry and start a family.

Locke's father, James, was born in 1917 in China. When he was 13 years old he and his parents returned to Washington and settled in Seattle. James Locke served in the 10th Armored Division of the U.S. Army under General Patton in World War II, and took part in the Normandy Invasion in 1944.

After WWII, James Locke met his wife, Julie, in Hong Kong and settled in Seattle. Gary Locke is the second of five children. He was born Jan. 21, 1950, and for the first six years of his life his family lived in Yesler Terrace, a public housing project for the low-income and the families of WWII veterans.

Growing up in Seattle, Locke worked at his father's restaurant and later at a small grocery store his father owned for 20 years. He became an Eagle Scout and graduated with honors from Seattle's Franklin High School in 1968. Then, through part-time jobs, financial aid and scholarships, Locke attended Yale University. He received a bachelor's degree in political science from Yale in 1972, and a law degree from Boston University in 1975.

After he received his law degree, Locke worked several years as a deputy King County prosecuting attorney. He also worked as a community relations manager for U.S. West.

In 1982, Locke won a seat in the Washington House of Representatives. During his 11 years in the Legislature, Locke served on the House Judiciary and Appropriations committees, and for his final five years was chairman of the Appropriations Committee. Locke negotiated budgets with Republicans and Democrats that increased college and university enrollments, improved children's health-care services and strengthened environmental protection.

In 1993, Locke was elected chief executive of King County, the largest county in Washington and the 13th largest in the nation. During his term, he cut the budget, established a savings incentive program that rewarded county departments for saving money, developed a nationally acclaimed growth management plan for King County, streamlined the government permit process and expanded bus service.

As governor, education is Locke's number one priority. He has worked with the Republican controlled Legislature to increase funding for education, health care and job training. He created the Washington Reading Corps to provide tutoring for an estimated 27,000 elementary students who need help meeting the state's new reading standards. Locke also helped provide funds to address the state's declining salmon runs and signed into law a landmark welfare reform bill which puts work first. The governor's first session also was the first on-time adjournment for a budget-writing session in 40 years.

Locke and his wife, Mona Lee Locke, a former news reporter for KING Television in Seattle, were married on Oct. 15, 1994. The Lockes have two children, Emily Nicole and Dylan James.

### **BRAD OWEN**

#### **Lieutenant Governor**

**Democrat.** Prior to his election as Lieutenant Governor he served four years as Finance Commissioner for the City of Shelton, six in the House of Representatives, and fourteen years in the Washington State Senate. Lieutenant Governor Owen is a prominent member of his community and was a small businessman for twenty-two years. He is a member of the Governor's Substance Abuse Prevention Committee, State Capitol Committee, State Finance Committee, Washington Higher Education Facilities Authority, Washington Health Care Facilities Authority, and the Washington Public Deposit Protection Commission. Lieutenant Governor Owen founded and is the President of Strategies for Youth, a drug and alcohol awareness education program that he presents in schools and conferences throughout the State of Washington. He is an avid outdoorsman and sportsman. Brad and his wife, Linda, live in Shelton. They have six children and seven grandchildren.



### **RALPH MUNRO**

#### **Secretary of State**

**Republican.** First elected in 1980, serving fifth term as 13th Secretary of State of Washington. Past President of the National Association of Secretaries of State. Lifelong resident of Washington; born and raised on Bainbridge Island. Graduate of Western Washington University. Was Special Assistant to Gov. Dan Evans and Washington's first volunteer coordinator. Served as Director of Guardianship Program at the Foundation for the Handicapped; founded several organizations for the disabled. Active in elections reform, voter outreach, historic preservation, environmental protection and international trade development. Munro, his wife, Karen, and son, George, make their home in Olympia.



### **MICHAEL J. MURPHY**

#### **State Treasurer**

**Democrat.** Elected in 1996. He is third in line of succession to the governor. Chairman of the State Finance Committee and Public Deposit Protection Commission. Member of the State Investment Board. Recently elected President of the Western State Treasurers' Association and vice president of the National Association of State Treasurers. A graduate of Seattle University, Mike received his Masters degree in Business Administration from Pacific Lutheran University. Mike worked with the State Treasurer's Office from 1972-1987. He served as the Thurston County Treasurer for over nine and a half years. He previously served as President of Washington Municipal Treasurers Association. Mike is a member of the Olympia Country and Golf Club, South Sound Sailing Society and the Olympia Yacht Club. Mike and his wife, Teri, who is a school teacher with the Olympia School District, live in Olympia on their sailboat.

### **BRIAN SONNTAG**

#### **State Auditor**

**Democrat.** Serving as Washington's eighth elected State Auditor. He has been in public service for 24 years, and was elected Pierce County Clerk in 1978 at age 26, the youngest elected official in county history. Eight years later, Brian was elected County Auditor, an office once held by his father. Since his election as State Auditor in 1992, the office advocates for greater government accountability. For example, in 1993 Brian requested and successfully won legislative approval of the Performance Based Government Act. The law is considered landmark legislation that put in place strategic planning and internal auditing as well as laying the groundwork for performance measurement in state government. Brian holds a professional certification as a Certified Government Financial Manager (CGFM) by the Association of Government Accountants. The official designation recognizes him as an expert in financial management. Presently, he serves on the State Productivity Board as a gubernatorial appointee. Brian also serves on the Performance Audit Task Force of the National State Auditors Association to help develop strategies for measuring the performance and efficiency of state governments. He attended Tacoma Community College and the University of Puget Sound, and completed a graduate program in public affairs at the University of Washington. He is active in his community. Brian serves on the boards of United Way and the Boys and Girls Clubs, is a YMCA volunteer and coaches youth baseball and basketball. He enjoys weight lifting, baseball and his family.



### **CHRISTINE GREGOIRE**

#### **Attorney General**

**Democrat.** Now in her second term, Christine Gregoire is Washington's first woman to serve as State Attorney General. Lifelong resident of Washington. Raised in Auburn. A graduate of the University of Washington, she received her law degree from Gonzaga Law School. She became an Assistant Attorney General in 1977 and in 1981 became a Senior Assistant Attorney General in charge of the Spokane office. She later became the first woman to serve as Deputy Attorney General. In 1988 Gregoire was appointed Director of the Washington State Department of Ecology where she served on the Puget Sound Water Quality Authority. Chris and her husband, Mike, have two daughters and live in Olympia.

**TERESA "TERRY" BERGESON, Ph.D.**  
**Superintendent of Public Instruction**  
**Nonpartisan Office.** Serving her first term. Terry began her career as a teacher and junior high school guidance counselor, working in Massachusetts, Alaska, and Washington. In 1985, she was elected President of the Washington Education Association, during which time she promoted the association's commitment to children and public education. She was hired in 1989 as an Executive Director of the Central Kitsap School District, where she supervised nine schools and several special programs. In 1993, Terry was appointed Executive Director of the Washington Commission on Student Learning, which is developing statewide standards for students and a series of tests students must pass prior to graduation. Terry has a B.A. in English, a master's in Counseling and Guidance, and a Ph.D. in Education. Throughout her career, Terry has focused on what is best for students and has worked tirelessly to build partnerships between legislators, educators, parents, and community leaders.



**JENNIFER M. BELCHER**  
**Commissioner of Public Lands**  
**Democrat.** Serving her second term. The Commissioner administers the Department of Natural Resources, the state's management agency for forest, agricultural, range, tidal and shore lands. Chair of Board of Natural Resources; Forest Practices Board; Harbor Lines Commission; and a past president of the Western States Lands Commissioners' Association. Jennifer served five terms as State Representative from District 22, was Chair of the House Natural Resources and Parks Committee from 1988-1992 and was a member of the Appropriations, Judiciary, and Revenue committees. She is an active member of the community, serving on various boards of directors, and was previously president of her own management consulting firm.



**DEBORAH SENN**  
**Insurance Commissioner**  
**Democrat.** The state's seventh Insurance Commissioner and the first woman elected to the office. Now in her second term, she has underscored her longtime commitment to consumer protection and greater access to insurance through strong regulatory oversight. Commissioner Senn has focused on consumer concerns in auto, home, and life insurance, and she has implemented tough new financial requirements for insurance companies. In health insurance, she is working for stronger consumer protection and quality-of-care standards in an era of managed care. Commissioner Senn and her husband, Rudi, live in Seattle.

### **GOINGS, CALVIN**

#### **Majority Assistant Floor Leader**

**Democrat.** Senator from the 25th District, representing the cities of Puyallup, Sumner, Edgewood, Milton, Pacific, and the communities of Summit/South Hill and Alderton/McMillin. A lifelong resident of Puyallup, he has served in the Senate since 1995. Also served as an elected Pierce Co. Fire Commissioner. A graduate of Pierce College and Pacific Lutheran University. Works as an executive director of a non-profit foundation. Is a past member of the Bd. of Directors of the Eastern Pierce Co. Chamber of Commerce, is a member of the Pierce College Foundation Bd. of Trustees, is the President of the American Heart Assoc.-Eastern Pierce Co. Chapter, and a past member of the Pierce Co. ### **HALE, PATRICIA S.**

#### **Republican Caucus Chair**

**Republican.** Pat serves the citizens of the 8th District which encompasses most of Benton County, including Richland and Kennewick. She is employed as director of strategic initiatives for Fluor Daniel Hanford. After moving to the Tri-Cities in 1983, ran her own small business before going to work at Hanford in 1985. 

## How A Bill Becomes A Law

---

1. A bill may be introduced in either the Senate or House of Representatives, but the procedure by which a bill becomes a law is much the same, wherever the bill originates.

In this story, the bill is introduced in the Senate by a member, or members, of that body. After the bill is filed with the Secretary of the Senate, it is given a number and, unless a majority demands it be read in full, it is read the first time by title only in open session of the Senate. It is then referred to a standing committee of the Senate.

2. The committee studies the bill and often holds public hearings on it. The committee will then meet to consider the information it has gathered. It may approve the bill with or without amendments, draft a new bill on the same subject incorporating the desired changes, or take no action.
3. The committee is now ready to report back to the Senate. If the majority is in favor of the bill as introduced or with certain amendments, the chair recommends the bill for passage. The committee report is read in open session of the Senate, and the bill is then referred to the Rules Committee.
4. After the bill has been recommended for passage by the standing committee to which it was originally referred, the Rules Committee can either place it on the second reading calendar for debate before the entire body, or take no action.
5. When the bill appears on the calendar for second reading, it is subject to amendment. It is then returned to the Rules Committee where it must receive a favorable vote before being placed on the third reading calendar for final passage. This referral to Rules is often bypassed by vote of the Senate and the bill placed on final passage immediately following its second reading. Depending upon the degree of controversy, debate may last a few minutes to several hours or even several days.
6. After passing in the Senate, the bill will go through an almost identical procedure in the House.

If the bill is passed by the House, but is amended by that body, the Senate must concur in the amendments. If the Senate does not accept the change in the bill, a conference committee may be requested on the differences.
7. If the conference committee cannot agree, a conference committee may be appointed with power to rewrite the amendment or even write an entirely new bill. When the conferees reach agreement, they report to their respective houses. Their report is either accepted or rejected without any changes.
8. If the report is accepted by both houses, the bill is signed by the President of the Senate and the Speaker of the House in open sessions of each body, and then is sent for the governor's signature.
9. Within five days, if the Legislature is still in session, or 20 days after its adjournment, the governor may sign the bill or veto all or any section of it. The Legislature can override the veto by a two-thirds vote of both houses. If the governor fails to act on the bill, it becomes law without a signature.

---

## Visitors Tour Information

---

The Tour Guide program was initiated to benefit both the legislator and the constituent.

Busy legislators frequently find it difficult to be on hand to greet guests arriving from their home district. The Tour Office will assign a staff member to meet the visitors and welcome them in the name of the district legislator. Arrangements will be made for a time and place for the legislator to speak with the group or the individual guest. Seating space will be reserved in the House and Senate galleries.

Visitors may be escorted to places of interest on the Capitol Campus: State Library, Temple of Justice, and State Museum. Appointments can be made to visit the offices of the Governor, Lieutenant Governor, Treasurer, Auditor, and Secretary of State.

Requests from constituents often come directly to the Tour Guide Office which then informs the legislators from the district. Many times the request comes first to the legislator who will then call the office with the name of the group and a contact phone number.



# State Capitol Parking Information

There are six parking locations available to visitors at the Capitol:

1. **Visitor Information Center Parking.** Located at the Visitor Information Center at 14th and Capitol Way. There is a \$.50 per hour charge. The phone number is (360) 586-3460.
2. **North and South Diagonal Parking.** Located along the North and South Diagonal roads on the Capitol Campus. There is a \$.50 per hour charge. South Diagonal parking is not available for public parking during legislative session.
3. **General Administration Parking Garage** (upper level) off of 11th Avenue. There is a \$.50 per hour charge.
4. **Natural Resources Building.** Visitor entry is from Washington and 11th. \$.50 per hour charge.
5. **The Satellite Visitor Parking Lot** at Jefferson Street and 16th Avenue (access at Jefferson). Parking is metered and there is a free shuttle bus to the legislative campus which runs every ten minutes, Monday through Friday. Wheelchair accessible. During interim, this parking lot is designated as leased parking only.
6. Parking on the **Deschutes Parkway along Capitol Lake** (for legislative staff only and satellite visitor parking lot overflow). Parking is free and there is a free shuttle bus to the Capitol Campus Monday through Friday (during session only). See the additional instructions and map on next page.




# State Capitol Parking Information

**Deschutes Parkway from I-5 Southbound:** Take exit 103 and proceed on 2nd Avenue to the Tumwater Fire Station; turn left onto the Custer Way overpass; turn right on Boston, proceed downhill to Deschutes Parkway; turn right (north) onto the Parkway and proceed to the designated parking area along Capitol Lake (see map below).

**Deschutes Parkway from I-5 Northbound:** Take exit 103 and proceed north on Deschutes Parkway through the stop sign to the designated parking area along Capitol Lake (see map below). For more information, call the Visitor Information Center at (360) 586-3460.

**Persons with Disabilities:** Those needing auxiliary aids or services for purposes of attending hearings or participating in legislative activities should call the House at 786-7101 or the Senate at 786-7400 for further information. TTY 1-800-635-9993.

**Tour and School Buses:** Buses may unload and reload passengers on the Capitol Campus at the Winged Victory statue (at the junction of the North and South Diagonals). Buses should then repark in the bus parking area at the Satellite Parking Lot.
