**Project Title: Balance Sheet and Other Updates**

**Project Goal:**

**Monitor other studies and issues.**

**Project Description:**

The general fund balance sheet will be updated to reflect revenue forecast changes, gubernatorial vetoes, and other updates, and the updated balance sheet will be presented to the Committee.

A variety of committees, councils, and studies were created by the 2005 Legislature that have implications for the operating budget. This project will monitor these and be prepared to update the Committee as needed.

Other items of significance to the budget will be monitored during the interim, including caseload forecasts, legal issues, and budget implementation in general.

**Project Title: State Information Technology (IT) Projects**

**Project Goal:**

**Review major state IT projects and discuss strategies to improve the process for approving and completing major IT projects.**

**Project Description:**

Designing, approving, funding, completing, and operating major IT projects is a challenge for both the public and private sectors. The state currently has several major projects in process, some of which face significant problems including OMNI in the Department of Corrections and HRMS in the Department of Personnel. This interim project will review the status of existing IT projects, get an update on the JLARC evaluation of the budget process used for IT projects, and discuss strategies to improve the process for approving and completing major IT projects.

**Project Title: Savings Assumed in the Budget**

**Project Goal:**

**Monitor implementation of various budget saving initiatives assumed in the operating budget.**

**Project Description:**

The 2005-07 operating budget assumed savings from a variety of initiatives. These include: the 1,000 position middle management reduction, the strategic sourcing initiative, proactive measures to manage General Assistance-Unemployable (GAU) caseloads and costs, estate recovery changes, savings in crisis residential centers as well as others across state government. Appropriations Committee staff will monitor implementation of the savings initiatives and may report back to the Appropriations Committee during an interim work session on implementation of these items.

**Project Title: Health Care Cost Containment Efforts**

**Project Goal:**

**Review and update the Committee on efforts to contain health care costs.**

**Project Description:**

Escalating health care expenditures have been an area of concern at both the state and national level. The 2005-07 budget includes a variety of reports and studies on different aspects of state-purchased health care services and cost containment opportunities. In addition, the budget assumes savings associated with efforts to control utilization of medical services by adopting evidence-based standards, promoting the use of the least costly but equally effective formulations, providing increased access to alcohol and drug treatment services, and working with clients to control over-utilization and inappropriate use of medical services. Finally, the Governor has established a team to take a coordinated, statewide approach to reducing health care cost increases. At the national level, the administration, governors, and legislators are working on recommendations regarding changes to Medicaid eligibility, benefits and financing.

**Project Title: Chemical Dependency Treatment Expansion**

**Project Goal:**

**Monitor implementation and outcomes of DSHS' expanded chemical dependency treatment efforts.**

**Project Description:**

The 2005-07 operating budget included a total of \$39 million in new funding for a phased-in expansion of drug and alcohol treatment for adults and teens with chemical dependency problems. This represents a significant expansion to the public chemical dependency treatment system; in the case of adults, approximately 11,800 more treatment slots will be available by FY 07 than were available in FY 03 (a 76% increase). Based on the results of a 2002 cost offset study by the DSHS Research and Data Analysis Division, and with additional input from the Joint Legislative Audit and Review Committee, the budget assumes that the treatment expansion for SSI-related and General Assistance-Unemployable (GAU) clients will result in cost offsets in medical assistance and long-term care of \$16.5 million in General Fund-State and \$14.7 million in General Fund-Federal during the FY 2005-07 biennium due to reduced utilization of nursing homes and medical services. The Committee will receive a status report on the Chemical Dependency Treatment Expansion.

**Project Title: Health Care Initiatives Impacting the Operating Budget**

**Project Goal:**

**Monitor other health care related studies and bills with fiscal impacts.**

**Project Description:**

There are a variety of health care related bills and studies adopted by the Legislature that impact the operating budget. This project will monitor these bills and studies, including studies of (1) the Basic Health Plan (BHP); (2) Residential Habilitation Center (RHC) clients; (3) the Regional Support Network (RSN) allocation formula for non-medicaid services; (4) the hospital reimbursement system; (5) the health technology assessment pilot project; and (6) strategies for early detection of breast and cervical cancer.

**Project Title: Progress on Restructuring Child Protection/Neglect Programs in DSHS**

**Project Goal:**

Monitor progress made on restructuring child protection/neglect programs in DSHS.

**Project Description:**

The 2005-07 operating budget included \$23.1 million in new funding to implement reform efforts in the DSHS Children's Administration, including a redesigned Child Protective Services/Child Welfare Services (CPS/CWS) model, a new CWS in-home model, chemical dependency specialists, education specialists, and expanded neglect services. Children's Administration must report to the appropriate legislative committees by December 1st of each year regarding the implementation status of these enhancements and regarding outcomes. The Committee will be updated on the status of these efforts.

**Project Title: Education Finance Study**

**Project Goal:**

Monitor the Education Finance Study.

**Project Description:**

Education finance is a major portion of the operating budget. E2SSB 5441 establishes a study involving early learning, K-12, and higher education. This project will monitor and update the Committee on the study, which is to provide an in-depth review of policy and funding issues and make recommendations in the areas of finance, governance, efficiency, and accountability.

**Project Title: Select Committee on Pension Policy's (SCPP) Study of Gain Sharing**

**Project Goal:**

Review the Select Committee on Pension Policy's gain-sharing recommendation.

**Project Description:**

The Select Committee on Pension Policy (SCPP) is required to study the options available to the Legislature for addressing the liability associated with future gain-sharing benefits. A wide range of options will be examined, and the findings and recommendations must be reported to the legislative fiscal committees no later than December 15, 2005. The Committee will review the SCPP's recommendations.

**Project Title: State Actuary Retire-Rehire Program Analysis**

**Project Goal:**

Review the State Actuary's analysis of the retire-rehire program.

**Project Description:**

A budget proviso requires the State Actuary to conduct an analysis of the fiscal impact of the retire-rehire program, and to report the findings to the Select Committee on Pension Policy, the Senate Committee on Ways and Means, and the House Appropriations Committee by December 1, 2005. The analysis will be accompanied by a range of legislative alternatives to the retire-rehire program. The Committee will review the State Actuary's analysis.

**Project Title: Joint Legislative and Executive Task Force on Long-Term Care Financing and Chronic Care Management**

**Project Goal:**

**Monitor the activities of the Joint Legislative and Executive Task Force on Long-Term Care Financing and Chronic Care Management (Task Force).**

**Project Description:**

The Task Force will be developing recommendations for public and private mechanisms for financing long-term care and review efficient payment models, disability prevention interventions, chronic care management strategies, and laws and regulations that would reduce the need for long-term care services. The Task Force must submit an initial report no later than January 1, 2006, a report of recommendations no later than January 1, 2007, and a final report no later than June 30, 2007. The Committee will receive a status report on the work of the Task Force.

**Project Title: Mental Health Task Force**

**Project Goal:**

Engrossed Second Substitute House Bill 1290 extended the Joint Legislative and Executive Task Force on Mental Health Services Delivery and Financing (Task Force) until June 30, 2007. The Task Force was originally established in the FY04 supplemental budget. The Task Force will make recommendations on the following topics: (1) reorganization of the mental health administrative structure; (2) implementation of the RSN procurement process established in E2SHB 1290; (3) Regional Support Network (RSN) funding distribution methodology; (4) services to non-Medicaid clients; and (5) inpatient psychiatric hospital and community residential bed capacity. The Committee will receive a status report on the work of the Task Force.

**Project Title: Stewardship Comparison of Public and Private Lands and the Fiscal Impact of Payments in Lieu of Taxes**

**Project Goal:**

Research and develop recommendations and findings comparing the stewardship costs to properly manage public lands compared to private lands and the fiscal impacts on counties of purchasing additional public lands.

**Project Description:**

Section 930 of the 2005-07 Capital Budget (ESSB 6094) directs the Committee to research and develop recommendations and findings comparing the stewardship costs to properly manage public lands compared to private lands and the fiscal impacts on counties of purchasing additional public lands. The Committee will work with the Interagency Committee for Outdoor Recreation, the Department of Fish and Wildlife, the Department of Natural Resources, and counties to obtain the necessary information to complete the report. The stewardship comparison component of the report is to include, but not be limited to: weed control, diking and drainage, fencing, signage, and other land management activities. The county fiscal impact component is to include, but not be limited to: a financial analysis determining the difference by county of assessing property taxes on lands acquired under the Washington Wildlife and Recreation Program statutes (Chapter 79A.15 RCW) compared to assessing property as open space under Chapter 84.34 RCW.

**Project Title: Review of the Predesign Process**

**Project Goal:**

Examine the role of predesign in the capital budget process for major facility projects valued over \$5 million.

**Project Description:**

Sections 908 and 924 of the 2005-07 Capital Budget (ESSB 6094) direct the Office of Financial Management and the Higher Education Coordinating Board to place a greater emphasis on the early critical review of capital project proposals at the predesign phase, rather than deferring this review to the design or construction phases of a project. According to JLARC's "Performance Audit of Capital Budget Processes," the maximum ability to influence project costs and outcomes occurs in the early planning and design stages of projects. This work session topic will include a discussion of the purpose of a predesign study, requirements, funding standards, benefits of a quality predesign, master plan and policy coordination, as well as a review of select predesigns studies submitted by state agencies.

**Project Title: Ten-Year Capital Plan and Projected Resources**

**Project Goal:**

Review the ten-year capital planning process and projected resources available to fund future capital budgets, including bond capacity under the nine percent constitutional debt limit.

**Project Description:**

The Washington State Budget and Accounting Act (chapter 43.88 RCW) mandates a long range approach to capital budget planning. The Act requires state agencies and institutions to submit a plan of proposed capital spending for a ten-year period. This long range planning is designed to identify future issues and capital projects proposed to address those issues. The Governor then proposes a ten-year capital plan based on agency proposals and policy considerations. This work session topic will analyze agency ten-year capital plans and review the impact of 2005-07 capital budget decisions and a projection of available resources.

**Project Title: "Performance Audit of Capital Budget Processes"**

**Project Goal:**

Review OFM's plan to address JLARC's "Performance Audit of Capital Budget Processes."

**Project Description:**

Section 924 of the 2005-07 Capital Budget (ESSB 6094) directs the Office of Financial Management (OFM) to develop a plan, in consultation with the fiscal committees of the Legislature, to address weaknesses identified in the 2005 Joint Legislative Audit and Review Committee's (JLARC) "Performance Audit of Capital Budget Processes." This work session topic will review the JLARC study conclusions and OFM's plan to strengthen and refine their capital budget processes in response to JLARC's recommendation.

**Project Title: Housing Trust Fund Update**

**Project Goal:**

Review and report on the status of the Housing Trust Fund managed by the Department of Community, Trade and Economic Development.

**Project Description:**

The Housing Trust Fund supports community efforts to ensure the availability of safe and affordable housing by providing loans and grants for construction, acquisition and rehabilitation of low-income multi-family and single-family housing. Since 1989, the Legislature has appropriated over \$565 million for the program through the state's Capital Budget, including \$100 million in the 2005-07 Capital Budget. This project will review and report on the implementation of the Housing Trust Fund program.

**Project Title: Farm Worker Housing Update**

**Project Goal:**

Review and report on the status of the Farm Worker Housing program managed by the Department of Community, Trade and Economic Development.

**Project Description:**

The Farm Worker Housing program provides loans and grants to local governments and nonprofit organizations for the development of housing for migrant and seasonal farm workers. Since 1999, the Legislature has appropriated \$33 million for the program through the state's Capital Budget. This project will review and report on the implementation of the Farm Worker Housing program.

**Project Title: North Seattle Community College: Employment Resource Center Update**

**Project Goal:**

Monitor the predesign and design of a colocated one-stop office on the North Seattle Community College campus with the Employment Security Department (ESD), the Department of Social and Health Services (DSHS), and WorkSource partnering agencies.

**Project Description:**

Section 852 of the 2005-07 Capital Budget provides \$520,000 for the predesign and design of a facility on the North Seattle Community College campus that will provide integrated services and training to shared clients/students of the two-year college, the DSHS, and the ESD. This project will monitor and report on the progress of this capital project.

**Project Title: Study Committee on Outdoor Recreation**

**Project Goal:**

Monitor and staff the Study Committee on Outdoor Recreation. Research and develop findings and recommendations pertaining to outdoor recreational facility needs and funding options.

**Project Description:**

Section 928 of the 2005-07 Capital Budget created a study committee on outdoor recreation to: (1) review local government responses to accommodating population growth and the resulting recreational facility needs; (2) study infrastructure funding issues pertaining to recreational facilities; (3) compile and review information about publicly owned properties that may be suitable for recreational use; and (4) compile an inventory of youth athletic fields and facilities purchased with revenues connected to major league sports stadiums. This project will be staffed jointly by OPR and SCS. A report is due to the Legislature by January 1, 2006.

**Project Title: 63-20 Financing**

**Project Goal:**

**Project Description:**

Section 934 of the 2005-07 Capital Budget directs the State Treasurer to conduct an evaluation of IRS revenue ruling 63-20 relating to bond financing contracts for capital construction projects. This project will monitor the work of the State Treasurer's office and an advisory committee consisting of 4 legislators, an OFM representatives, and 1 person appointed by the Governor. Based on the evaluation, the State Treasurer will make recommendations on the use of 63-20 financing to the Legislature and Governor by December 1, 2005.

**Project Title: Snohomish, Skagit, and Island County Higher Education Needs Assessment and Siting Study**

**Project Goal:**

**Monitor the work of the Higher Education Coordinating Board and its advisory committee in assessing the higher education needs in Snohomish, Skagit, and Island counties and in developing solutions to address the identified needs.**

**Project Description:**

Section 615 of the 2005-07 Capital Budget directs the Higher Education Coordinating Board to: 1) assess the higher education needs in the Snohomish, Skagit, and Island counties; 2) evaluate alternative organizational models for meeting identified needs and recommend the type of institution(s) to be established; 3) assess sites for establishment of an institution; and 4) identify costs and process for completing a master plan for higher education expansion in the study area. The HECB will provide an interim report to the Legislature and the Governor by January 15, 2006, and a final report by December 1, 2006.

**Project Title: Foster Care**

**Project Goal:**

**Consider recommendations from the public concerning the state's foster care system.**

**Project Description:**

The Committee will hold a public hearing in central Washington to hear from residents of the state about issues of concern relating to the state's foster care system. Foster care is one of the most important elements of the state's child welfare system, as it provides children and youth, who are unable to live with their families as a result of child abuse or neglect, with the family connections essential to child and adolescent development. There are a total of nearly 6,300 foster homes available across the state to care for children and youth, which is inadequate to the level of need, particularly in some communities, and represents a decrease in recent years of the number of available foster homes.

**Project Title: Foster Care Licensing by Tribes**

**Project Goal:**

**Make recommendations for possible legislation relating to the authority of Indian tribes to license foster and adoptive homes.**

**Project Description:**

The Committee will consider policy options relating to the authority of Indian tribes to license foster and adoptive homes. State law recognizes the authority of Indian tribes within the state to license foster and adoptive homes located within the boundaries of a federally recognized Indian reservation, and provides that the Department of Social and Health Services and state licensed child-placing agencies may place children in tribally licensed facilities if background checks are completed. HB 2148 (2005), which was heard in the House Children and Family Services Committee, would have expanded the authority of Indian tribes to include homes located on or near the boundaries of a reservation.

**Project Title: Aging Out of Foster Care**

**Project Goal:**

Make recommendations for possible legislation addressing issues facing youth "aging out" of foster care.

**Project Description:**

The Committee will consider issues facing youth "aging out" of foster care. Children and youth may be placed in out-of-home care as a result of abuse, neglect, abandonment, or family conflict. If and when children and youth become dependents of the state, they remain state dependents until they move to a permanent placement or until they reach 18 years of age. In 2002, 470 youth "aged out" of foster care.

**Project Title: Racial Disproportionality in Child Welfare**

**Project Title: Judicial and Prosecutorial Discretion in the Determinate Sentencing Scheme**

**Project Goal:**

**Monitor SB 5477 and review the current practices surrounding judicial and prosecutorial decisions used in determinate sentencing under the Sentencing Reform Act.**

**Project Description:**

Washington has used determinate sentencing since the Sentencing Reform Act (SRA) went into effect in 1984. Under this system, an offender's sentence is calculated based on the seriousness level of the crime for which he or she was convicted and on the offender's criminal history (or "offender score"). This calculation results in a standard sentencing range, and any sentence imposed that falls within that range may not be appealed.

Until 2004, a judge could impose a sentence above the standard sentence range (an aggravated exceptional sentence) based upon aggravating circumstances the judge found by a preponderance of the evidence. In 2004, in *Blakely v. Washington*, the U.S. Supreme Court ruled that imposing aggravated exceptional sentences in this manner violated an offender's constitutional right to a jury trial. According to the Court, an aggravated exceptional sentence may only be imposed based on circumstances found by a jury beyond a reasonable doubt. The Legislature enacted SB 5477 in response to the *Blakely* decision. The legislation creates a statutory mechanism under which aggravated exceptional sentences can be imposed based on circumstances found by a jury beyond a reasonable doubt. The legislation also requires the Sentencing Guidelines Commission to study the SRA as it relates to the sentencing grid, all provisions providing for exceptional sentences both above and below the standard sentencing ranges, and judicial discretion in sentencing.

The Committee will monitor the work of the Sentencing Guidelines Commission as it studies whether changes need to be made to the current determinate sentencing structure as it relates to the sentencing of felony offenders.

**Project Title: Criminal Background Check Processes**

**Project Goal:**

**To review and make recommendations regarding how to improve the state's criminal background check process.**

**Project Description:**

The Joint Task Force on Criminal Background Check Processes (Task Force) was created by the passage of ESHB 2556 during the 2004 legislative session. During the 2005 legislative session, the legislature passed SHB 1681 which extended the work of the Task Force for one additional year. The Task Force must review the following issues:

- What state and federal statutes require regarding criminal background checks.
- What criminal offenses are currently reportable through the criminal background check program.
- What information is available through the Washington State Patrol and the Federal Bureau of Investigation criminal background check systems.
- What are the best practices among organizations for obtaining criminal background checks on their employees and volunteers.
- What is the feasibility and costs for businesses and organizations to do periodic background checks.
- What is the feasibility of requiring all businesses and organizations, including nonprofit entities, to conduct criminal background checks for all employees, contractors, agents, and volunteers who have regularly scheduled supervised or unsupervised access to children, developmentally disabled persons, or vulnerable adults.
- What are the benefits and obstacles of implementing a criminal history record information background check program created by the National Child Protection Act of 1993.
- What is the feasibility of establishing a state registration program for private youth sports coaches under which some or all of such persons are required to obtain and disclose to prospective clients and employers a copy of the results of their fingerprint-based criminal background checks.
- A review of the practices of the Department of Social and Health Services with respect to checking the backgrounds of its employees, applicants for employment, and candidates for promotion.

The Committee will monitor the work of the Joint Task Force on Criminal Background Check Processes and will request the Task Force to provide a report on its review and recommendations regarding how to improve the state's criminal background check processes.

The Task Force is charged with studying the: 1) Effectiveness of community protection zones and other strategies to promote community safety, including recommendations on proactive and reactive approaches to sex offender residence locations and any statutory, constitutional, or practical limitations on the state's ability to address sex offender housing requirements; 2) standardization of the community sex offender notification process; 3) applicability of the Public Disclosure Act to sex offender information sharing; 4) training needs of law enforcement, criminal justice staff, and school personnel to increase community safety in relationship to sex offender notification and management strategies; and 5) impact and advisability of pre-notification of local government officials related to sex offender residence location.

The Committee will monitor the work of the Joint Task Force on Sex Offender Management and will request the Task Force to provide a report on its review of the issues surrounding the management of sex offenders released from prison.

The issue is complex due to the technical nature of nutrient management, the similarities and differences between state and federal laws and regulations, and the transfer of responsibilities from DOE to WSDA. Although the Governor vetoed Section 2 of SSB 5602, the Committee will have two members on the program's Development and Oversight Committee (DOC) to monitor the program transition, emerging issues, and potential legislation. It is anticipated that there will be three or four meetings of the DOC during the interim.

Interest in state-level COOL during the 2005 session was impeded by these issues and by unanswered questions of state versus federal authority. Staff will research and report to the Committee on: COOL concepts, pros and cons, federal program status, and applicability at the state level.

**Project Title: Local Government Finance**

**Project Title: Fraud in the Insurance Industry**

**Project Goal:**

**Determine what, if any, changes in law are necessary to more effectively fight insurance fraud.**

**Project Description:**

Insurance fraud is inimical to public safety, welfare, and order within the state of Washington. Insurance fraud increases insurance premiums, to the detriment of individual policyholders, small businesses, large corporations, and governmental entities. Law abiding citizens ultimately bear the societal burdens and costs caused by those who commit insurance fraud. The Financial Institutions and Insurance (FII) Committee will follow-up on HB 1977 in order to study the extent of insurance fraud in Washington and the current laws which are in place to combat insurance fraud.

The FII Committee will work with all parties to further understanding and develop options. The Office of the Insurance Commissioner has expressed interest in working on this subject also. Other interested parties include the insurance industry and prosecutors.

**Project Title: Credit Reports and Freezes**

**Project Goal:**

**Explore additional options to protect personal credit information.**

**Project Description:**

In 2005 the Legislature passed ESB 5418, which allows victims of identity theft to "freeze" their credit report. Once a freeze is requested by a consumer, his or her credit reports cannot be released unless the consumer allows access or removes the freeze. Some states allow any consumer to freeze their credit. Businesses have raised concerns that this may have unexpected and adverse consequences.

Staff will review the experience in other states and research possible alternative mechanisms that may restrict access to credit reports.

Mortgage brokers expressed concern that it takes the Department of Financial Institutions (DFI) an inappropriately long period of time to license new branch offices for existing licensees. HB 1244 (2005), this legislation regarding the timeliness of the license process for mortgage brokers/loan offices, was introduced to address this issue. This legislation was not pursued at the request of the DFI and the interested parties. The DFI and the interested parties asked if this legislation could be held to allow for a collaborative effort to address the issue in the interim.

The DFI and interested parties have begun efforts to address the subject. These efforts will be monitored. Legislation may be required.

**Project Goal:**

Currently life insurers may use health information, including genetic information, to make decisions about whether or not to insure applicants. The subject was the topic of legislation and ESSB 5452 (2005). The bills on the subject did not pass the Legislature.

Staff will research issues, review legislation from other states, discuss the 2005 bill language, and possibly develop alternate approaches with industry and interested parties.

Until a few years ago, a health insurer owned by St. Joseph's hospital in Bellingham offered this product in their local area, including the San Juan Islands. Currently no health insurer offers this product and none seem interested in offering this product in the future. Some states have exempted this product from their insurance code.

Staff will monitor the feasibility study by the Office of the Insurance Commissioner (OIC) on subscription air ambulance services. The study is required by ESSB 5736 (2005).

Staff will also research states that have addressed this issue and review their experience and approaches.

**Project Title: Auto Insurance and Steering**

**Project Goal:**

Possibly draft legislation.

**Project Description:**

Auto insurers are not prohibited from owning autobody shops in Washington. HB 1620 (2005) would have prohibited automobile insurers from owning an interest in auto body shops, but did not pass.

In testimony, autobody shops expressed concerns about the possibility of "steering" or insurers requiring policyholders to use certain shops. Autobody shops raised questions about the cost and quality of repairs if insurers own or have an interest in autobody shops. Auto insurers testified that insurer-owned shops are an option that can reduce claims costs and ensure quality.

Staff will research the issue of insurer-owned autobody shops. The research will include a review of legislation and regulatory approaches from other states.

The subject of insurance broker compensation and the disclosure regarding that compensation has been a prominent subject nationally over the last several months. It has lead to criminal charges in New York state and to discussions about possible legislation around the United States.

Legislative models are being developed by the National Association of Insurance Commissioners and the National Conference of Insurance Legislators. Interested parties include the Office of the Insurance Commissioner, insurers, and insurance agent and broker associations.

**Project Title: Insurance Market Analysis**

**Project Goal:**

The Office of the Insurance Commissioner requested funding to study market analysis regulations. The "market analysis" process uses market information to target possible problem areas. The insurance regulator does a limited, focused examination of insurers on the subject areas of concern. The intent of market analysis is to better utilize resources.

Oregon has implemented this process. Oregon Department of Insurance (DOI) staff indicated that the DOI used this process to shift resources from "front-end" regulation (using staff time to try to avert problems by detailed review of the insurance contracts for example) to "back-end" regulation (using staff time to try to address specific problems after they are detected). The DOI believes that this approach has been more effective given their resources.

The National Association of Insurance Commissioners has a model law that has been adopted by some states. The OIC study may lead to possible legislation.

**Project Title: Higher Education Initiatives in Southwest Washington**

**Project Goal:**

Legislation enacted in 2005 (E2SHB 1794) permits WSU Tri-Cities to admit freshmen and sophomores in the future, but only for a degree in biotechnology. The Higher Education Committee will convene work sessions regarding "Higher Education Partnerships in the Tri-Cities and Southeast Washington" to facilitate communication among the stakeholders about the education and training needs in the region, and to explore additional possible partnerships. One work session will include roundtable discussions with local educational, community, and business leaders. The House Technology, Energy & Communications Committee and the Economic Development, Agriculture & Trade Committee will also participate in the PNNL portion of the meeting. The Higher Education Committee will also explore joint efforts between Walla Walla Community College and WSU in expanding nursing, viticulture, enology, and other regionally-focused workforce training and education programs.

Eastern Washington University continues to maintain a strong presence in Spokane, with nearly 650 full-time equivalent students enrolled in various programs. The Spokane Intercollegiate Research and Technology Institute (SIRTI) is seeking to expand its facilities and mission. The Spokane Community Colleges serve the largest geographic area of any college in the system with a broad range of transfer, basic skills, and workforce training programs, but in recent years has also tried to focus on a cluster strategy to better meet regional educational priorities. The House Higher Education Committee will convene work sessions regarding "Higher Education and Economic Development in Spokane" to explore opportunities to improve the collaboration among various state entities and higher education institutions in the region. Topics include program planning, service delivery, priorities, needs assessment, and support of economic development.

**Project Title: Increasing the Washington Homeownership Rate**

**Project Goal:**

**To investigate challenges faced by Washington residents in purchasing homes and to identify opportunities to increase homeownership opportunities through legislation.**

**Project Description:**

Washington lags behind the national average in its homeownership rate (64.6% compared with a national average of 66.2%). A recent study ranks Washington 45th in the nation for the percentage of families that own a home. This project will bring together housing stakeholders from the private, non-profit and state sectors to look at the homeownership rate statewide as well as by county, explore the primary challenges and barriers facing individuals and families who strive for homeownership, set goals to increase the Washington homeownership rate by a specific percentage within a defined period of time by defining appropriate performance measures and by assigning responsibility to specific parties, and explore possible solutions to challenges associated with homeownership which could be addressed through legislative action in order to accomplish established goals.

Issues to be discussed include:

- The impacts of the cost of housing development on homeownership, including cost determinants such as impact fees, land costs, labor and material costs, and financing options.
- Barriers to obtaining reasonable financing for low-income individuals and families.
- Proven methods to address homeownership challenges such as downpayment assistance programs, land trusts, mixed use and in-fill housing developments, other homeownership assistance programs, non-profit supported housing development, tax exemption initiatives, and others.

Vancouver was chosen as the location for this work session because it is a very rapidly growing community which adds complexity to efforts to provide housing across the continuum from homelessness to homeownership. Vancouver also has a very active affordable housing and housing development community which has adopted innovative strategies to lessen barriers to homeownership and provide opportunities across the income spectrum. Due to the fact that Clark County represents an area of the state which contains both rural towns, farming country, and more urban developing cities, the location also provides a unique opportunity for Committee members to experience what can be accomplished in both types of communities through panel discussions and the subsequent tour. The tour will highlight initiatives such as the "Homeownership Center" which manages the successful "First Home Downpayment Assistance Program." This program is an excellent example of a collaborative effort between local non-profit agencies working with low/middle-income families and the private sector (e.g., realtors, for-profit developers, and lenders).

By promoting a substantive dialogue among housing stakeholders related to the Washington homeownership rate, exploring the primary challenges and barriers facing individuals and families who strive for homeownership, and exploring possible solutions to the identified challenges, the Committee intends to leave Vancouver with substantive concepts for potential legislation to promote Washington homeownership during the 2006 session.

**Project Title: Affordable Housing #1: Challenges to Achieving Adequate Affordable Housing in Washington and Goals for Improvement**

**Project Goal:**

Solutions may include the promotion of successful affordable housing models and best practices, as well as ideas for pilot programs borne from collaborative efforts among stakeholders. Selected solutions are intended to become the basis for legislation to achieve affordable housing goals and performance measures (identified during the first affordable housing interim work session).

**Project Title: Rural Housing Challenges & Solutions**

**Project Goal:**

To identify housing challenges specific to rural areas. To set goals and specific performance measures to meet identified housing needs and address identified challenges. To investigate and analyze potential solutions to accomplish rural housing goals and to designate appropriate responsible parties to be involved in the implementation and on-going management of such solutions.

**Project Description:**

Rural areas face a variety of unique housing challenges, including a relatively high percentage of substandard housing stock, inadequate rental housing stock, limited housing assistance resources for low-income families and homeless populations, farm worker housing shortages, and others. This project will bring together stakeholders representing all rural housing sectors including for and non-profit developers, local governments, landlord associations, farm worker housing advocates, farmers and other business owners, in order to identify the many challenges faced by rural communities. The work session will also establish appropriate performance measures for improving the affordable housing availability in rural areas, and identify promising solutions (and corresponding responsible parties) to the challenges in order to reach identified goals through legislative action.

**Project Title: Addressing Homelessness in Washington**

**Project Goal:**

**To analyze the state's progress in addressing the homelessness challenge through the Homeless Housing and Assistance Act and identify future changes to the legislation in order to increase the effectiveness of the Act.**

**Project Description:**

The Homeless Housing and Assistance Act enacted by the 2005 Legislature represents a substantial step forward in addressing goals to reduce homelessness in Washington. This project is intended to provide the committee with an update on how the Department of Community, Trade, and Economic Development (DCTED) and individual counties are progressing in their creation and implementation of plans to reduce homelessness by fifty percent within ten years. The Committee will look at potential changes to the Act to make it more effective, including the possible addition of components of successful models from other parts of the country. The Committee will also discuss with stakeholders the increasing need for state agencies to work together (for example, the Department of Social and Health Services, the Department of Corrections, and the DCTED) and also work with local communities to combine support services with housing services in order to assist homeless individuals obtain and retain stable housing.

Seattle was chosen as host site for this work session for a variety of reasons, among which include the following:

1. The greatest number of homeless people in Washington are in Seattle.
2. The greatest number of chronically homeless people in Washington are in Seattle.
3. Seattle providers and local government are center of several key partnerships:
  - a. Seattle Housing Levy with State Housing Trust Fund.
  - b. Taking Health Care Home. (This is a collaborative initiative by Seattle, Spokane, and state agencies which focuses on chronically homeless persons.)
  - c. Sound Families. (This is a partnership between King, Pierce, and Snohomish counties that develops and supports transitional housing for homeless families.)
  - d. Safe Harbors, Homeless Management Information System (HMIS). (This project was originally developed in Seattle-King County, and is now being developed statewide by partners working closely with the DCTED.)

**Project Title: DCTED's Role in Washington Housing Initiatives and Corresponding Performance Outcomes**

**Project Goal:**

To conduct an in-depth examination and analysis of the Department of Community, Trade, and Economic Development (DCTED) Housing Division's budgets, strategic plan, goals, and performance measures in order to determine if the agency is performing according to legislative mandates.

**Project Description:**

The Housing Committee will analyze the DCTED's strategic plan, with a critical eye towards identifying appropriate, measurable goals and performance measures (which correspond to appropriate state laws) by which the DCTED may be monitored and evaluated. The Housing Committee will analyze the DCTED strategic plan, the DCTED organizational chart, and actual reported performance towards accomplishing stated goals, in order to determine how the DCTED is complying with and accomplishing legislative housing mandates.

The DCTED will provide a detailed balance sheet budget for its housing division which clearly shows all revenue and expenditures. The Committee will use this information to evaluate how the DCTED's expenses and overall budgeting strategies translate into achieving the stated housing performance goals.

**Project Title: Driving Under the Influence (DUI)**

**Project Goal:**

Review and evaluate the effectiveness of the state's DUI laws.

**Project Description:**

The Committee will have a work session to review all significant legislation enacted over the past 10 years dealing with the issue of persons driving under the influence of alcohol or drugs (DUI) and evaluate the effectiveness of these DUI laws. The Committee will also explore potential additional measures that may be effective in dealing with the DUI problem. In conducting this review and assessment, the committee will receive a report from the Washington Traffic Safety Commission on its research relating to DUI incidence and its findings and/or recommendations relating to DUI laws or potential legislation. In addition, the Committee will receive input from other interested stakeholders, such as the Washington State Patrol, the Washington Association of Prosecuting Attorneys, the Washington Defender's Association/Washington Association of Criminal Defense Lawyers, Mothers Against Drunk Driving, and chemical dependency treatment professionals.

After the work session, the Committee will hold a public hearing on HB 1451, which establishes a felony offense for repeat DUI offenders.

**Project Title: Courts of Limited Jurisdiction**

**Project Goal:**

**Evaluate the current structure and operation of courts of limited jurisdiction and identify improvements that can be made to the provision of district and municipal court services.**

**Project Description:**

The Committee will study the current structure and operation of the courts of limited jurisdiction and evaluate whether improvements can be made to the provision of court services. Courts of limited jurisdiction are authorized by statute for both counties (district courts) and cities (municipal courts). District courts are independent courts with elected judges that operate county-wide. Municipal court services may be provided in one of three ways: (1) through an independent full-time or part-time municipal court; (2) by filing cases directly with the district court pursuant to interlocal agreement; or (3) by creating a municipal department within the district court.

Some cities have recently formed regional municipal courts, also called "community courts," where one or more cities contract with a host city to provide municipal court services. Legislation to specifically authorize this type of arrangement was introduced in 2003 but did not pass. Other proposals have been made to consolidate courts of limited jurisdiction or regionalize court services.

Last session the Legislature passed E2SSB 5454 with a stated goal of improving trial courts in the state. E2SSB 5454 increased certain court fees and allocated the revenue from these fee increases to funding of: a portion of the salaries of district court judges and elected municipal court judges; civil legal services; trial-level criminal indigent defense; and parent representation in dependency and termination cases.

The Committee will review and evaluate proposals for consolidation or regionalization of court services and other options with a goal of improving the court system to provide more efficient and accessible court services to the citizens of local jurisdictions. The Committee will have work sessions in three diverse areas of the state to learn about the different needs and court structures in different parts of the state. These work sessions will be held in: Port Orchard, Aberdeen, and Bellevue. The Committee will also consult with other jurisdictions around the state as needed to identify court systems and practices that work efficiently and effectively and those that do not.

In addition, the Committee will hear a report at the September Committee Assembly on the implementation of E2SSB 5454 and the status of funding for civil legal services, indigent defense, and parent representation in dependency cases.

**Project Title: Health Courts**

**Project Goal:**

**Review proposals for creating specialized health courts and evaluate their potential viability as an alternative method of handling medical malpractice cases.**

**Project Description:**

Medical malpractice issues have been important issues in Washington and nationally for the last several years. Numerous proposals have been before state legislative bodies and the Congress with a variety of approaches to improving the medical malpractice system through measures to increase patient safety, reform the insurance industry, and improve the operation of the civil justice system in handling medical negligence cases. An extensive amount of research and studies have been conducted looking at the problems with the current medical malpractice system and potential new approaches to improving the system. One of the latest proposals is the creation of specialized health courts to handle medical negligence cases. Legislation has been introduced in the U.S. House of Representatives that would authorize funding for states to create specialized health courts on a pilot project basis.

The Committee will hold a work session to review the research and various proposals for creation of specialized health courts, including how they would be set up and operate, and to evaluate whether health courts would serve as a viable alternative to the current system of handling medical negligence cases.

**Project Title: Hydraulic Project Approval (HPA) Reform**

**Project Goal:**

Prepare reform legislation for the hydraulic approval reform system.

**Project Description:**

The Legislature passed 2SHB 1346 in 2005, which was a policy neutral rewrite of the Hydraulics Code that regulates the hydraulic project approval (HPA) system. Passing the rewrite laid the foundation for a policy bill in the 2006 session that addresses issues surrounding the HPA program including the scope of jurisdiction of the hydraulic permit, the role of hydraulic permits in flood control, civil enforcement of hydraulic permits, funding options for the program, judicial remedies, consistency with other regulatory programs, and the applicability of the program to recreational gold panners. The Committee will explore these issues and develop any necessary legislation.

**Project Title: Human and Wildlife Interactions**

The Committee will study these wildlife management policy issues, see the end result of wildlife interactions, and gain a deeper understanding of the cultural issues that effect wildlife management policy decisions. The Committee will develop legislative proposals addressing some of these current wildlife management issues facing the state.

The project includes a work session and a public hearing in Colville regarding the Department of Fish and Wildlife's cougar control project and other cougar management issues. The project also includes work sessions in September and December on potential legislation regarding animal trapping.

**Project Title: Natural Resource Agencies Management Structures**

**Project Goal:**

**Assess the various management structures at the natural resource agencies.**

**Project Description:**

There are three primary agencies that manage and regulate the state's natural resources: the Department of Ecology, the Department of Fish and Wildlife, and the Department of Natural Resources. Among these agencies there are three different leadership models. The Department of Natural Resources is led by a statewide elected official, the Department of Ecology has a director appointed by the Governor, and the director of the Department of Fish and Wildlife is appointed by a commission that is in turn appointed by the Governor. The committee will examine each model and, if appropriate, advance legislative proposals revising the models used.

The project includes a work session in September to discuss findings and potential legislation.

The Pollution Liability Insurance Account (PLIA) was established in 1989 in response to federal regulations adopted by the Environmental Protection Agency requiring owners of underground storage tanks to demonstrate financial responsibility for accidental releases of petroleum. The PLIA account is scheduled to sunset on June 1, 2007.

The project will review the current status of programs and activities supported by these dedicated accounts, and includes a work session in December to review potential legislation.

**Project Title: Alternative Public Works Contracting**

**Project Goal:**

Very few state agencies and several large local governments, ports, public utility districts, school districts, and hospital districts are authorized to use alternative public works and every year more public entities seek authority to use these procedures or to increase the number of projects allowed under the procedures.

The 2003-05 Capital Budget directed the Joint Legislative Audit and Review Committee (JLARC) to review the GC/CM procedures. More recently, ESHB 1830 established the Capital Projects Advisory Review Board to evaluate public capital projects construction processes and to advise the Legislature on policies related to alternative public works delivery methods.

A work session during September Assembly is planned for alternative public works and will include: 1) a presentation of the JLARC study on GC/CM; 2) an overview of the design-build, GC/CM, and job order contracting procedures; and 3) alternative delivery methods, including competitive negotiation contracts.
