<b>Purpose</b>	Comprehensive functional assessment for individuals being admitted to and receiving services from an ICF/ID	Comprehensive Standardized Assessment (Resident Assessment Instrument-RAI) of each resident's functional capacity. To provide facility with on going assessment information necessary to develop a care plan to provide appropriate care and services. RAI information corresponds to the Minimum Data Set (MDS).	The DDD Assessment is a standardized assessment tool that measures the unique support needs of people with developmental disabilities for a variety of activities in various settings. The standardization processes incorporated into the assessment will: <ul style="list-style-type: none"> <li>• Promote consistency</li> <li>• Identify level of service and/or hours</li> <li>• Record service requests</li> </ul>

<b>Frequency completed</b>	<ul style="list-style-type: none"> <li>• Within 30 days of admission</li> <li>• Annually for health - medical, nursing, dental</li> <li>• Regular for other areas: “regular” is defined in WA state as no more than every 3 years as long as an annual update/review of each assessment is done</li> <li>• When significant change occurs for the person</li> <li>• Updated at time of transfer or discharge</li> </ul>	<ul style="list-style-type: none"> <li>• Within 14 days after admission</li> <li>• Reassessed following significant change</li> <li>• Annually for medical professionals</li> <li>• Quarterly reviews/updates using quarterly review assessment instrument not less frequent than once every three months with respect to those MDS items specified under state requirement.</li> <li>• Regular for other areas: “regular” is defined as no more than every 3 years as long as an annual update/review of each assessment is done.</li> <li>• Updated at time of transfer or discharge</li> </ul>	<ul style="list-style-type: none"> <li>• With 90 days of enrollment for services</li> <li>• Reassessed annually</li> <li>• Updated at times of significant change.</li> </ul> <p>Note: Clinical, professional and specialty assessments may be requested for planning purposes at any time</p>
<b>Quality Assurance of Assessment Contents</b>	RHC local QA procedures	PCC /MDS RN must certify assessment is completed and accurate. Every professional who participated also certifies the accuracy of that portion.	Sampling of CARES assessments are completed by DDD Office of Quality Control, Coordination and Compliance. Audits occur annually; Data is summarized and analyzed for needed corrective actions.

Assessors receive an inter-rater reliability evaluation each year to monitor and certify them for accurate administration of the Supports Intensity Scale.</p>
