**\*General dissolution statutes.** There are several statutes that relate to dissolution procedures for special purpose districts. **(1) Ch. 36.96 RCW pertains to the dissolution of "inactive" special purpose districts**, including every municipal and quasi-municipal corporation other than counties, cities, and towns. The statute specifically provides that such special purpose districts includes, but are not limited to, water-sewer districts, fire protection districts, port districts, public utility districts, county park and recreation service areas, flood control zone districts, diking districts, drainage improvement districts, and solid waste collection districts, but does not include industrial development districts created by port districts, local improvement districts, utility local improvement districts, and road improvement districts. **(2) Ch. 53.48 RCW pertains to the dissolution of port districts, but is also used for other types of districts**, including all municipal and quasi-municipal corporations having a governing body, other than cities, towns, counties, and townships, such as port districts, school districts, water-sewer districts, fire protection districts, and all other special districts of similar organization. It does not include local improvement districts, diking, drainage and irrigation districts, irrigation and reclamation districts, and public utility districts. **(3) Ch. 57.90 RCW contains a mechanism to disincorporate certain districts in counties with 210,000 population or more and that have been inactive for five years.** Ch 57.90 RCW only pertains water-sewer, park and recreation, metropolitan park, county rural library, cemetery, flood control, mosquito control, diking and drainage, irrigation or reclamation, weed, health, and fire protection districts, and any air pollution control authority and regional fire protection service authority.
