Implementation of 2008 Legislation

Independent Contractor Definition for Construction Contractors

- Policy and Procedures updated.
- Computerized auditing program updated to recognize new requirements.
- Website updated with links to independent contractor tests.
- Staff have been trained.
- Flyers were developed and printed.
- Information published in the Quarterly Business Update.

Additional Auditors

- Created an additional Auditor 4 for Underground Economy.
- Diverted 1.5 FTEs Tax Specialist from Collections and Audits to Underground Economy.



Implementation of 2009 Legislation

Retainage from public works contracts

- We currently have a manual process in place to handle the workload.
- We are working with our IT division to implement an electronic process.
- We processed 659 requests in May and 463 requests in June.

Failure to keep records

- Process is under development.
- This new penalty will apply to records for 4th quarter 2009 and forward.
- Requirements for system programming have been identified.
- Programming is scheduled to be completed by 1st quarter 2010.
- First audit subject to this penalty will be conducted in 2nd quarter 2010.

Economic Impacts

- Bankruptcy filings are increasing.
- Deferred Payment contracts are up 5% since 6/30/08.
- Deferred Payment contracts are being written for longer pay-back periods.
- Accounts Receivable increased about 3.5% between May and June 2009.
- For quarter end 3/31/09, over 97% of accounts were paid timely, but total dollars collected was 17% lower than quarter end 3/31/08.



Sharing Information

- We continue to exchange tips with Department of Labor and Industries as well as Department of Revenue. Cooperation is good between the agencies.
- We have e-training available for auditors so they can learn what is needed by each agency in an audit situation.
- Our Contracts unit was successful in updating the DSHS data sharing agreement for New Hire reporting to allow UI Tax to use the data for targeting purposes.
