Effect: A minor child or person with a disability may enter a facility segregated by gender where the gender of the child or person does not match the segregated facility when accompanied and supervised by a parent, guardian, or caretaker. The parent, guardian, or caretaker must be of the matching gender for which the facility is segregated.

6 (1) The right to be free from discrimination because of race, 7 creed, color, national origin, sex, honorably discharged veteran or 8 military status, sexual orientation, or the presence of any sensory, 9 mental, or physical disability or the use of a trained dog guide or 10 service animal by a person with a disability is recognized as and 11 declared to be a civil right. This right shall include, but not be 12 limited to:

13 (a) The right to obtain and hold employment without 14 discrimination;

(b) The right to the full enjoyment of any of the accommodations, advantages, facilities, or privileges of any place of public resort, accommodation, assemblage, or amusement;

(f) The right to engage in commerce free from any discriminatory 8 boycotts or blacklists. Discriminatory boycotts or blacklists for 9 purposes of this section shall be defined as the formation or 10 11 execution of any express or implied agreement, understanding, policy 12 or contractual arrangement for economic benefit between any persons which is not specifically authorized by the laws of the United States 13 and which is required or imposed, either directly or indirectly, 14 overtly or covertly, by a foreign government or foreign person in 15 order to restrict, condition, prohibit, or interfere with or in order 16 17 to exclude any person or persons from any business relationship on the basis of race, color, creed, religion, sex, honorably discharged 18 veteran or military status, sexual orientation, the presence of any 19 sensory, mental, or physical disability, or the use of a trained dog 20 guide or service animal by a person with a disability, or national 21 origin or lawful business relationship: PROVIDED HOWEVER, 22 That nothing herein contained shall prohibit the use of boycotts as 23 authorized by law pertaining to labor disputes and unfair labor 24 25 practices; and

26 (g) The right of a mother to breastfeed her child in any place of 27 public resort, accommodation, assemblage, or amusement.

б (4) Nothing in this chapter prohibits a public or private entity from limiting access to a private facility segregated by gender, such 7 as a bathroom, restroom, toilet, shower, locker room, or sauna, to a 8 person if the person is preoperative, nonoperative, or otherwise has 9 10 genitalia of a different gender from that for which the facility is segregated. Nothing in this chapter grants any right to a person to 11 access a private facility segregated by gender, such as a bathroom, 12 restroom, toilet, shower, locker room, or sauna, of a public or 13 private entity if the person is preoperative, nonoperative, or 14 otherwise has genitalia of a different gender from that for which the 15 16 facility is segregated.

(5) Nothing in this section prevents a minor child or a person 17 with a disability from entering a facility segregated by gender when 18 19 the child or person is a different gender from the gender for which the facility is segregated if: (a) A parent, guardian, supervisor, or 20 caretaker is escorting the minor child or the person with a 21 disability to or from the facility, (b) the child or person is under 22 the custody, control, supervision, or care of the parent, guardian, 23 supervisor, or caretaker, and (c) the gender of the parent, guardian, 24 25 supervisor, or caretaker is the same as the gender for which the facility is segregated. 26
