

Three Options to Resolve the Backlog of Park Development

- Significantly increase the portion of the capital budget invested in state parks.
- Stop acquiring new park land and devote capital resources to park development.
- Sell off park land that is not well positioned for the strategic direction of State Parks and use the proceeds for park development.
