shall not impair or otherwise affect the validity of the act as a whole or any other part thereof.

## DAIRY PRODUCTS.

An Acr relating to advertising of dairy products, prohibiting false advertising in the sale thereof, and providing penalties for violations thereof.

Be it enacted by the Legislature of the State of Washington:

Advertising breed of cattle.

Section 1. It shall be unlawful for any person, firm, corporation or association to use in any corporate or firm name of any association, or in any advertisement, trade mark, or brand, the name of any breed of dairy cattle, such as "Jersey", "Guernsey", "Ayrshire", "Holstein", or "Brown Swiss", unless the milk sold, advertised, offered or exposed for sale by such person, firm, corporation or association, shall be produced entirely from the breed cattle so named: *Provided*, That the owner of any herd of cows shall be entitled to the use of such term as "Jersey", "Guernsey", "Ayrshire", "Holstein", or "Brown Swiss" when each cow in said herd shall carry more than fifty per cent (50%) of the blood of the breed of cattle so named.

Each cow over 50 % as advertised.

Sec. 2. Any person, firm, corporation or association desiring to use the name of any breed of dairy

cattle in connection with any advertisement, trade mark, brand, or sale of any milk, shall make application to the state supervisor of dairy and livestock Permission of for permission to do so, and upon satisfactory assurance that the applicant is entitled to the use of such name, permission to do so shall be granted by the state supervisor of dairy and livestock in compliance with this act, and the rules and regulations pertaining thereto.

Sec. 3. Any person, firm, corporation or associa- Violation. tion violating any of the provisions of this act shall be guilty of a misdemeanor, and upon conviction, be fined not more than twenty-five dollars (\$25.00) for Penalty. the first offense, and not more than one hundred dollars (\$100.00) nor less than fifty dollars (\$50.00) for each subsequent offense.
