- (1) Fifty percent shall be placed in the forest development fund.
- (2) Fifty percent shall be paid to the county in which the land is located to be paid, distributed, and prorated to the various funds in the same manner as general taxes are paid and distributed during the year of payment.

HIGHWAYS-BONDS FOR PRIORITY PROJECTS.

An Acr relating to highways and roads; providing for the issuance, sale and retirement of motor vehicle revenue bonds to accelerate construction of priority projects; authorizing loan of funds in motor vehicle fund; amending section 2, chapter 121, Laws of 1951 and RCW 47.10.020, and section 2, chapter 154, Laws of 1953 and RCW 47.10.160; declaring an emergency.

Be it enacted by the Legislature of the State of Washington:

SECTION 1. Section 2, chapter 121, Laws of 1951 Amendment. and RCW 47.10.020 are each amended to read as follows:

To provide funds for accelerating construction of Bond issue these first priority projects, and to reimburse the motor vehicle fund for money expended for Agate Pass Bridge construction there shall be issued and sold limited obligation bonds of the state of Washington in the sum of sixty-six million seven hundred three thousand, six hundred and twenty-five dollars. The issuance, sale and retirement of said bonds shall be under the general supervision and control of the state finance committee.
