STOCK TRANSFERS TO SURVIVING SPOUSE-NONLIABILITY OF CORPORATIONS.

Be it enacted by the Legislature of the State of Washington:

SECTION 1. There is added to chapter 23.01 RCW New section. a new section to read as follows:

Neither a domestic or foreign corporation or its Business corregistrar or transfer agent shall be liable for trans-ferring or causing to be transferred on the books of surviving spouse-Nonthe corporation to or pursuant to the direction of the liability of surviving spouse of a deceased husband or wife any share or shares or other securities theretofore issued by the corporation to the deceased or surviving spouse or both of them if the corporation or its registrar or transfer agent shall be provided with the following:

(1) A copy of an agreement which shall have been entered into between the spouses pursuant to the provisions of section 2416 Code of 1881 and RCW 26.16.120 and certified by the auditor of the county in this state in whose office the same shall have been recorded;

(2) A certified copy of the death certificate of the deceased spouse;

(3) A release issued by the inheritance tax division of the tax commission of this state; and

(4) An affidavit of the surviving spouse that:

(a) The shares or other securities constituted community property of the spouses at date of death of the deceased spouse;

(b) No proceedings have been instituted or are contemplated to have admitted to probate a will of

SECTION 1. Section 15, chapter 261, Laws of 1945 as last amended by section 1, chapter 159, Laws of 1957, and RCW 41.24.150 are each amended to read as follows:

Volunteer firemen's relief and pensions. Disability payments. Whenever a fireman serving in any capacity as a member of a fire department subject to the provisions of this chapter becomes physically or mentally disabled, or sick, in consequence or as the result of the performance of his duties, so as to be wholly prevented from engaging in each and every duty as his regular occupation, business or profes-
