BOOTH GARDNER Governor

Booth Gardner is the 19th Governor of the state of Washington. Born in Tacoma on August 21, 1936, Governor Gardner has lived in the Pierce County area all his life.

Governor Gardner graduated from the University of Washington with a BA in business in 1958, and went on to receive a Masters Degree in business from Harvard

University in 1963.

From 1967–72, Governor Gardner was Director of the School of Business and Economics at the University of Puget Sound, and during this time was elected as a Washington State Senator representing the 26th district. During his tenure as Senator, he was chair person of the Education, Manufacturing and Development, and Commerce and Regulatory Agencies committees.

In 1972, Governor Gardner left Olympia to take over his family business as president of Laird Norton Co., a

national building materials and supply firm.

In 1980, Pierce County adopted the County Council form of government and elected Governor Gardner as their first County Executive in 1981. He was credited with turning a \$4.7 million county deficit into a \$4 mil-

lion dollar surplus by the end of his term.

In addition to his elected and private sector positions, Governor Gardner co-founded the Central Area Youth Association of Seattle, which still provides athletic, social adjustment and educational activities for minority and economically disadvantaged youths. He has also been a trustee or board member with the Central City Learning center of Tacoma; the Washington Commission for the Humanities; the Seattle Mental Health Institute; the Private Industries Council and the University of Puget Sound Board of Trustees.

Governor Gardner is also involved in youth sports activities, and in 1984 coached his girls' soccer team—

the Cozars—to the national championship game.

Governor Gardner and his wife, Jean, have two children, Doug and Gail.

JOHN A. CHERBERG, Lieutenant Governor

Democrat. Presently serving his eighth term as President of the Senate Chairman of Senate Rules Committee, member of State Finance Committee, Capitol Committee, Health Care Facilities Authority, Business License Center Board of Review, Washington State Patrol Memorial Foundation, Washington Higher Education Facilities Authority, Chairman of the Washington State Data Processing Authority and Joint Legislative Committee on International Trade, Tourism and Investment and Vice Chairman, Advisory Council on International Trade and Development. Formerly television executive, head football coach U of W and Seattle high school teacher and coach.



RALPH MUNRO, Secretary of State

Republican. The thirteenth Secretary of State of Washington, he is serving his second term and is a lifelong resident of Washington. Born and raised on Bainbridge Island, he now makes his home in Olympia with his wife, Karen, and son, George. A graduate of Western Washington University, he was Special Assistant to Governor Dan Evans and Washington's first volunteer coordinator. Munro was Director of Guardianship with the Foundation for the Handicapped, and is founder of several organizations for the disabled. Very active in environmental and historic preservation, he is member of many civic groups. Owner and operator of a tree farm in the Olympia area, he is an avid bagpiper.

ROBERT S. O'BRIEN, State Treasurer

Democrat. Born, raised and educated in the State of Washington. Elected to ten consecutive fouryear terms as a public fund treasurer. Elected Grant County Treasurer four times and elected State Treasurer six times. Chrm., State Finance Committee; Chrm., Washington Public Deposit Protection Commission; Chrm., State Investment Board 1981; Secretary, Washington Housing Finance Commission 1983-; Chrm., Public Employees' Retirement Board 1969-77; Chrm., Law Enforcement Officers' and Fire Fighters' Retirement Board 1971-77, past President Washington State Association of Elected County Officials, past President Washington County Treasurers' Association; past President Western State Treasurers'Conference, past President National Association of State Auditors, Comptrollers and Treasurers.





ROBERT V. GRAHAM, State Auditor

Democrat. Is a native Washingtonian and became the State's seventh auditor in 1965, and has been elected to a sixth term. Prior to his election he served in every administrative post in the Office of State Auditor. He is a Certified Internal Auditor, and active member of many professional organizations. He and his wife, LLoydine, have five grown children.

KEN EIKENBERRY, Attorney General



Republican. Serving his second term. Administers the Department of Natural Resources, the State's management agency for forest, agricultural, range, tidal, and shorelands. Chairman of Board of Natural Resources, Forest Practices Board, and Harbor Lines Commission. Formerly Chairman of the Board, Cowlitz County Commissioners. Worked as supervisor and engineer in the metals industry, and earlier employed as hard rock miner. MBA, University of Portland, B.S., Montana School of Mines. A washington resident for eighteen years.





RICHARD G. MARQUARDT, Insurance Commissioner

Republican. Raised in Western Washington, former Washington State Senator, and Director of the State Selective Service System as it wound down at the Viet Nam war, executive with a fuel oil company. As Insurance Commissioner Dick has been a consumer advocate, conducting educational forums and developing a special program to help senior citizens with insurance questions.

Lieutenant Governor President of the Senate

John Andrew Cherberg (Democrat) is serving his eighth term as President of the Senate and Chairman of the Senate Rules Committee. He was first elected Lieutenant Governor in 1956, and reelected in 1960, 1964, 1968, 1972, 1976, 1980, and 1984. Born in 1910 in Pensacola, Florida, he earned a life teaching diploma from the University of Washington in 1934. Formerly a teacher, he was head football coach at the University of Washington prior to his election. He and his wife, Betty, have three children.

Dairy Herd Improve. Assn., All-West Breeders Assn., other farm organizations. Elected Natl. Pres.—Holstein Friesian Assn. of America—1974, largest dairy cattle assn. in world. Past. Dir. and Chrm. of Snohomish School Bd. Elected at-large to Snohomish Cty. Council in 1980; elected to substantive post of Council Chrm. in 1982 and 83. He, his wife, Rosemary, and two sons, Don and Dan, still farm the Snohomish Valley dairy established by his grandfather in 1918. A third son, David, is a businessman in Chelan.



BARR, SCOTT

Democrat. Senator from the 49th District of Clark County, is serving his second term. Served as Representative from 1971 through 1980. Born in Lewistown, Montana in 1928. Graduate Portland State College and Oregon State College with Masters in Education and minor in Political Science. Past President Community Club, PTA, Vancouver Education Association. BENDER, RICK S., Majority Whip

CANTU, EMILIO



Democrat. HAYNER, JEANNETTE, Republican Leader

Republican. Senator from the 16th District comprising Walla Walla County, part of Franklin and Benton Counties. Republican. Senator from the 1st District of King and Snohomish Counties, serving his second term in the Senate. Served three terms in the House of Representatives from 1967 through 1972. Formerly an electronic research engineer, now a counselor and therapist in private practice. He and his wife, Donna, have three children.





KREIDLER, MIKE Democrat. Senator from the 22nd District located in Thurston County and including the State Capitol, is serving his first term in the Senate and has served four terms in the House of Representatives.
