BOOTH GARDNER Governor

Booth Gardner is the 19th Governor of the state of Washington. Born in Tacoma on August 21, 1936, Governor Gardner has lived in the Pierce County area all his life.

Governor Gardner graduated from the University of Washington with a B.A. in business in 1958, and went on to receive a Master's Degree in business from Harvard

University in 1963.

From 1967–72, Governor Gardner was Director of the School of Business and Economics at the University of Puget Sound, and during this time was elected as a Washington State Senator representing the 26th district. During his tenure as Senator, he was chair person of the Education, Manufacturing and Development, and Commerce and Regulatory Agencies committees.

In 1972, Governor Gardner left Olympia to take over his family business as president of Laird Norton Co., a

national building materials and supply firm.

In 1980, Pierce County adopted the County Council form of government and in 1981 elected Governor Gardner as the first County Executive. He was credited with turning a \$4.7 million county deficit into a \$4 million dol-

lar surplus by the end of his term.

In addition to his elected and private sector positions, Governor Gardner co-founded the Central Area Youth Association of Seattle, which still provides athletic, social adjustment and educational activities for minority and economically disadvantaged youths. He has also been a trustee or board member with the Central City Learning Center of Tacoma; the Washington Commission for the Humanities; the Seattle Mental Health Institute; the Private Industries Council and the University of Puget Sound Board of Trustees.

Governor Gardner is also involved in youth sports activities and in 1984 coached his girls' soccer team—the Cozars—to the national championship game.

Governor Gardner and his wife, Jean, have two chil-

dren, Doug and Gail.

ELECTED OFFICIALS

JOHN A. CHERBERG, Lieutenant Governor

Democrat. Presently serving his eighth term as President of the Senate. Chairman of Senate Rules Committee, member of State Finance Committee, Capitol Committee, Health Care Facilities Authority, Business License Center Board of Review, Washington State Patrol Memorial Foundation, Washington Higher Education Facilities Authority. Chairman of the Washington State Data Processing Authority and Legislative Committee on Economic Development. Formerly television executive, head football coach for University of Washington, and Seattle high school teacher and coach.



RALPH MUNRO, Secretary of State

Republican. The thirteenth Secretary of State of Washington, is serving his third term and is a lifelong resident of Washington. Born and raised on Bainbridge Island, he makes his home in Olympia with his wife. Karen, and son, George. A graduate of Western Washington University, was Special Assistant to Governor Dan Evans and Washington's first volunteer coordinator. Munro was Director of Guardianship with the Foundation for the Handicapped and is founder of several organizations for the disabled. Very active in environmental and historic preservation, he is a member of many civic groups. Owner and operator of a tree farm in the Olympia area, he is an avid bagpiper.

ROBERT S. O'BRIEN, State Treasurer

Democrat. Born, raised, educated in Washington State. Elected ten consecutive four-year terms as a public fund treasurer. Elected Grant County Treasurer four times, elected State Treasurer six times. Chair, State Finance Cmte; Chair, WA Public Deposit Protection Cmsn, Chair, State Investment Brd 1981; Secretary, WA Housing Finance Cmsn 1983-; Chair, Public Employees' Retirement Brd 1969-77; Chair, LEOFF Retirement Board 1971-77; past President WA State Assoc. of Elected County Officials; past President WA County Treasurers' Assoc.; past President Western State Treasurers' Conference; past President Ntl. Assoc. of State Auditors, Comptrollers and Treasurers.





ROBERT V. GRAHAM, State Auditor

Democrat. Is a native Washingtonian and became the state's seventh auditor in 1965 and has been elected to a sixth term. Prior to his election, he served in every administrative post in the Office of State Auditor. He is a Certified Internal Auditor and an active member of many professional organizations. He and his wife, LLoydine, have five grown children.

KEN EIKENBERRY, Attorney General


Republican. Serving his second term. Member, Corrections Standards Board, Criminal Justice Training Commission, Organized Crime Committee. Currently serving with the National Association of Attorneys General as Chairman of the Crime Victims and RICO subcommittees, and Vice Chairman of the Charitable Trusts and Solicitations Committee. Currently serving on the President's Child Safety Partnership and the Governor's Task Force on Child Support Enforcement. Former Special Agent of the F.B.J., Deputy Prosecutor for King County and three-term state legislator. Born, raised and educated in Washington State. DR. FRANK B. BROUILLET, Superintendent of Public Instruction

Non-partisan Office. Elected to Office of State Superintendent in 1972, is serving his fourth consecutive term. Former teacher, counselor, college instructor, holds B.A. and M.A. degrees in economics, B.Ed. and Ed.D. and Doctor of Humanities, honoris causa. Former member of the House of Representatives, served eight terms. President, Council of Chief State School Officers, 1984. Member, National Commission on Excellence in Teacher Education and National Committee on U.S./China Relations. A native of Puyallup where he resides with his wife, Marge'. They have two grown sons, Marc and Blair.



Republican. Serving his second term. Administers the Department of Natural Resources, the state's management agency for forest, agricultural, range, tidal and shore lands. Chairman of Board of Natural Resources, Forest Practices Board, and Harbor Lines Commission. Formerly Chairman of the Board, Cowlitz County Commissioners. Worked as supervisor and engineer in the metals industry, and earlier employed as hard rock miner. M.B.A., University of Portland; B.S., Montana School of Mines. A Washington resident for nineteen years.





RICHARD G. MARQUARDT, Insurance Commissioner

Republican. Raised in western Washington, Dick Marquardt was a fuel oil company executive, a State Senator and Director of the State Selective Service System before becoming Insurance Commissioner in 1977. As Commissioner, he has been a strong consumer advocate, initiating pro-consumer regulations and education programs, including a volunteer program to educate senior citizens about insurance; the program has been copied by many other states.

Lieutenant Governor President of the Senate

John Andrew Cherberg (Democrat) is serving his eighth term as President of the Senate and Chairman of the Senate Rules Committee. He was first elected Lieutenant Governor in 1956, and reelected in 1960, 1964, 1968, 1972, 1976, 1980, and 1984. Born in 1910 in Pensacola, Florida, he earned a life teaching diploma from the University of Washington in 1934. Formerly a teacher, he was head football coach at the University of Washington prior to his election. He and his wife, Betty, have three children.

Democrat. Senator from the 49th District of Clark County, is serving his second term. Served as Representative from 1971 through 1980. Born in Lewistown, Montana in 1928. Graduate Portland State College and Oregon State College with Masters in Education and minor in Political Science. Past President Community Club, PTA, Vancouver Education Association. Member: Kiwanis, Grange, American Legion and Salmon Creek Methodist Church. He is currently self-employed in agriculture. He and his wife, Patricia, have three children: Sue, Jim and Nancy.

BENDER, RICK S. Majority Whip

Democrat. He is serving his second term in the Senate representing the 44th District of South Snohomish and North King Counties, following five terms in the House of Representatives. Member of the Education, Financial Institutions, Transportation and Rules Committees. Born in Fairbanks, Alaska in 1949. Attended North Seattle Community College, University of Washington and the University of Puget Sound. Served in the U. S. Army Signal Corps, Vietnam Veteran. Part—owner of a construction firm. BENITZ, MAX E.

Republican. Senator from the 8th District of Benton County. Serving his fourth term in the Senate and served three sessions in the House of Representatives. Born in Wathena, Kansas. Past-president of the Washington State Farm Bureau Federation, former chairman of House and Senate Higher Education Committees, and former chairman of Senate Energy Committee. Republican. Senator from the 45th District of King County, is serving his fourth term in the Senate and has served four terms in the House of Representatives. Democrat. Senator from the 2nd District comprising part of Pierce and Thurston Counties. Has served in the Senate since 1972 and previously in the House since 1965. Born in 1932 in Tacoma. Graduate from University of Puget Sound with a B.A. degree and the University of Washington Law School. He is an attorney practicing in Tacoma. He and his wife, Darlene, have two children.

CANTU, EMILIO Republican Deputy Leader

Republican. Senator from the 41st District-Bellevue, Mercer Island, Issaquah, and NE Renton, is serving his first term in the Senate. Served two terms in the House of Representatives and was ranking Republican chairman of House Ways and Means Committee. Served on Bellevue School Board from 1973 to 1981. Democrat. Senator from the 37th District, King County. Served one session in House, serving sixteenth session in Senate. Born 1938 in Dallas, Texas. Member: Past President, Economic Development Executives of Washington; Pacific NW Industrial Development Council; Focus International; and Economic Development Partnership of Washington. GARRETT, AVERY

Democrat. Senator from the 11th District of King County, serving his first term in the Senate. Served nine terms in the House of Representatives. He and his wife, Edna May, have a son, three daughters, one grandson and one grand-daughter.





GASPARD, MARCUS S.

Democrat. Senator from the 25th District of Pierce County. He has served in the Senate since 1976 after serving two terms in the House of Representatives. He is currently the Chairman of Education, Vice—Chairman of Ways and Means and is a member of the Agriculture Committee. He was born in 1948 and reared in Puyallup, Washington. He is a graduate of the University of Oregon and is employed in the field of real estate and property management. HANSEN, FRANK "TUB"

Democrat. Senator from the 13th District comprised of Kittitas, most of Grant, part of Yakima, and Adams Counties, serving his third term in the Senate, served six years in the House of Representatives. Born in Olema, Washington. Retired cattle rancher. Past Chairman Agriculture Stabilization Conservation Service; Past Director, Washington State Cattlemen's Association. Member: Grange, Wheat Growers and Elks. He and his wife, Wanda, have two sons and two daughters.

HAYNER, JEANNETTE Republican Leader

Republican. Senator from the 16th District comprising Walla Walla County, part of Franklin and Benton Counties. Serving her third term in the Senate, served four years in the House of Representatives. Received B.A. and J.D. degrees from the University of Oregon. Active in a variety of civic activites. Currently serves on several state and regional citizen advisory boards, including the Organized Crime Advisory Board, and the Centennial Commission. Member of the Lutheran Church. Republican. Senator from the 28th District, comprising Lakewood, Tillicum, University Place, Fircrest and Steilacoom. Resident of the district 20 years. President/Owner of Gerrish Bearing & Industrial Supplies, Inc. for the past 30 years. Former Chairman of the Clover Park School District's Board of Directors. Formerly National President of North American Baptist General Conference. Presently Certified Professional Parliamentarian, American Institute of Parliamentarians. KISKADDON, BILL

Republican. Senator from the 1st District of King and Snohomish Counties, serving his second term in the Senate, Served three terms in the House of Representatives from 1967 through 1972. Born in California in 1929. Graduate of University of Washington with B.S. and M.S. in Electrical Engineering and Masters of Social Work degrees. Formerly an electronic research engineer, now a counselor and therapist in private practice. He and his wife, Donna, have three children.





KREIDLER, MIKE

Democrat. Senator from the 22nd District located in Thurston County and including the State Capitol, is serving his first term in the Senate and has served four terms in the House of Representatives. Born in 1943 in Tacoma. Graduate of Pacific University with a Bachelor and Doctor of Optometry degrees and U.C.L.A. with a Master of Public Health. He is an optometrist practicing with Olympia Group Health. He and his wife, Lela, have three children – Kelli, Michael and Lora.

LEE, ELEANOR

Republican. Senator from the 33rd District. Attended Washington State University and graduated from The Evergreen State College in Political Science. Business manager and director of a manufacturer's representative firm. Former State Land Planning Commissioner and League of Women Voters official; Past Chair of Fire District 2, Civil Service Board, Highline Citizens for Schools, and Civil Air Patrol Advisory Committee. Founder and co-chair Elected Washington Women. She and her husband, David, have three daughters and five grandchildren.





McCASLIN, BOB

Republican. Senator from the 4th Legislative District of Spokane County. Served in the U.S. Navy during WW II, graduate of WSU in 1950, post graduate work in 1951 and 1952 with a major in Sociology and Economics. Served in Production Management for 17 years with large aluminum fabricator and for the past 15 years has owned and managed a real estate firm in the Spokane Valley. Married, has two children, Janie and Bob, and with wife, Wanda, has been active in many service clubs and civic activities in the Spokane Valley.

McDERMOTT, JIM

Democrat. Senator from the 43rd District, King County, is serving his fourth term in the Senate and served one term in the House of Representatives. Age 50. Graduate, Wheaton College, B.A., and University of Illinois Medical School; is a child and adult psychiatrist. LCDR (MC) USNR, 1968–1970. Former chairman, Coalition for Open Government. He and his wife, Virginia, have two children.



McDONALD, DAN

Republican. First elected in 1978, represents Bellevue, Kirkland and Redmond area of King Co. He and his wife, Janie, and two sons, have lived in Bellevue for 17 years, since his return from tour as Naval Off. in Vietnam. He is a graduate in mech. engineering from the Univ. of Wash. and has a masters degree in economics. Presently employed with a consulting firm. He is active in the Municipal League, Bellevue Chamber of Commerce, American Public Works Assn. and Rotary. Appointed member of LEAP Committee. Member and past chairman of Econ. & Revenue Forecasting Council. Appointed member of WICHE.



Republican. Senator from the 10th District (Island County, parts of Snohomish and Skagit Counties). Served four years in the House and has served fourteen years in the Senate. Born in Marysville. Graduate Pacific Lutheran University. Retired Member: South Whidbey Kiwanis, Backcountry Horsemen of Washington, Grange, American Legislators Exchange Council, Farm Bureau, Natl. Assn. of Professional Educators, National Chairman of Honest Money for America, member of Government Operations Committee of NCSL. MOORE, RAY

Democrat. Senator from the 36th District, King County, is serving his third term in the Senate Born in Seattle, attended the University of Washington.
