ELECTED OFFICIALS



BOOTH GARDNER **Governor**

Booth Gardner is the 19th Governor of the state of Washington and was elected in 1988 to serve a second term. Born in Tacoma on August 21, 1936, Governor Gardner has lived in the Pierce County area all his life.

Governor Gardner graduated from the University of Washington with a B.A. in Business in 1958, and went on to receive a Master's Degree in Business from Harvard University in 1963.

From 1967-72, Governor Gardner was Director of the School of Business and Economics at the University of Puget Sound and, during this time, was elected as a Washington State Senator representing the 26th district. During his tenure as Senator, he was Chair of the Education, Manufacturing and Development, and Commerce and Regulatory Agencies Committees.

In 1972, Governor Gardner left Olympia to take over his family business as President of Laird Norton Co., a national building materials and supply firm.

In 1980, Pierce County adopted the County Council form of government and in 1981 elected Governor Gardner as the first County Executive. He was credited with turning a \$4.7 million county deficit into a \$4 million surplus by the end of his term.

In addition to his elected and private sector positions, Governor Gardner co-founded the Central Area Youth Association of Seattle, which still provides athletic, social adjustment and educational activities for minority and economically disadvantaged youths. He has also been a trustee or board member with the Central City Learning Center of Tacoma; the Washington Commission for the Humanities; the Seattle Mental Health Institute; the Private Industries Council and the University of Puget Sound Board of Trustees.

Governor Gardner is also involved in youth sports' activities and coached his girls' soccer team—the Cozars—to the national championship game three times in a row.

Governor Gardner and his wife, Jean, have two children, Doug and Gail.

ELECTED OFFICIALS

JOEL PRITCHARD, Lieutenant Governor

Republican. Serving first term as President of Senate and Chair of Senate Rules Committee. Born and raised in Washington; served 8 years in State House and 4 in State Senate (1958 to 1970). Elected to Congress from Washington's 1st Dist. in 1972; served in nation's capital until 1984, keeping a pledge to serve only 12 years. Has worked as TV commentator and been Dir. of Gov. Rel. for local law firm and Pres. of an envelope co. Attended Marietta Coll. (Ohio); served in Army Inf. in Pacific in WWII. Has 4 grown children and 1 grandchild. He and wife Damaris live in Seattle.



RALPH MUNRO, Secretary of State

Republican. First elected in 1980, serving third term as 13th Secretary of State of Washington. Also serves as Co-chair of Wash. Centennial Cmsn. Lifelong resident of Washington; born and raised on Bainbridge Is. Graduate of Western Wash. Univ.; was Special Asst. to Gov. Dan Evans and Washington's first volunteer coordinator. Served as Dir. of Guardianship Prog. for Foundation for the Handicapped; founded several organizations for the disabled. Active in elections' reform, voter outreach, historic preservation, environ. protection and interntl. trade dev. Munro, wife Karen and son George make their home in Olympia.

DANIEL K GRIMM, State Treasurer

Democrat. Serving his first term as State Treasurer. Served six terms (1977-1988) as a State Representative from Puyallup, including three terms as Chair of the House Ways & Means Committee. B.A., Columbia University. Lifelong resident of Puyallup, where he resides with his wife, Kathy, and their daughter, Whitney K.



ROBERT V. GRAHAM, State Auditor

Democrat. Is a native Washingtonian and became the state's seventh Auditor in 1965 and has been elected to a seventh term. Prior to his election, he served in every administrative post in the Office of State Auditor. He is a Certified Internal Auditor, a Professional Finance Officer and an active member of many professional organizations. He and his wife, Lloydine, have five grown children.

ELECTED OFFICIALS

KEN EIKENBERRY, Attorney General

Republican. Serving third term. Member of the Corrections Standards Board; Criminal Justice Training Commission; also an active member of National Association of Attorneys General, serving as Chair of the Criminal Law Committee and the Working Group on Model Patient Abuse Legislation. By Presidential appointment, he served on the President's Task Forces on Victims of Crime and Child Safety Partnership, and also serves on the Governor's Task Force on Child Support Enforcement. Former Special Agent of F.B.I., Deputy Prosecutor for King County and three-term state legislator. Born, raised and educated in Washington State. Graduate of WSU and UW. Ken and his wife, Beverly, reside in Olympia.



JUDITH A. BILLINGS, J.D.,

Superintendent of Public Instruction

Non-partisan Office. Elected, 1988; serving first term. Former teacher, state prog. admin. and Legis. Spec. for U.S. House of Rep. Ed. Subcmte. Holds B.A., Ed.; M.A., Commun. and J.D., cum laude. Former State Dir. of Chap. I Prog. for disadvantaged children and youth, 8 years. Legis. Chair, Ntl Assn of State Chap. I Prog. Member: Phi Delta Kappa, Wash. Assn for Supervision and Curric. Dev., and Interntl Reading Assn. Montana native; she and husband Donald live in Puyallup; have 4 grown children, Molly, Scott, Patty and Ron; 4 grandchildren.

BRIAN J. BOYLE,

Commissioner of Public Lands

Republican. Serving his third term. Administers the Department of Natural Resources, the state's management agency for forest, agricultural, range, tidal and shore lands. Chair of Board of Natural Resources, Forest Practices Board, and Harbor Lines Commission. Formerly Chair of the Board, Cowlitz County Commissioners. Worked as supervisor and engineer in the metals industry, and earlier employed as hard rock miner. M.B.A., University of Portland; B.S., Montana School of Mines. A Washington resident for over twenty years.



RICHARD G. MARQUARDT,

Insurance Commissioner

Republican. Raised in western Washington, Dick Marquardt was a fuel oil company executive, a State Senator and Director of the State Selective Service System before becoming Insurance Commissioner in 1977. As Commissioner, he has been a strong consumer advocate, initiating pro-consumer regulations and education programs, including a volunteer program to educate senior citizens about insurance; the program has been copied by many other states.

JOEL PRITCHARD

**Lieutenant Governor
President of the Senate**

Joel Pritchard (Republican) was elected as Washington's 14th Lieutenant Governor in 1988. He is only the second to be born in Washington, and brings 24 years of public service to his job as President of the State Senate. He served in the State Legislature from 1958 to 1970 and the U. S. House of Representatives from 1972 to 1984. In Congress, Joel was the ranking member on the Asian and Pacific Subcommittee of the Foreign Affairs Committee, and the Merchant Marine and Fisheries Committee. He also served as a U. S. Delegate to the General Assembly of the United Nations in 1983. Joel and his wife, Damaris, live in Seattle.

Republican. Senator from the 20th District; which includes all of Lewis and the southwest half of Thurston County. Served one term in the House of Representatives. A native of Lewis County, his work experience has been in the natural resource industry serving as the economic base for the District. A graduate of Centralia College and Pacific Lutheran University, Neil is Properties Manager for The Agnew Company, where he is actively involved in economic development. Majority Whip

Republican. Senator from the 42nd District of Whatcom County. Born 1952 in Yakima. Earned Masters Degree in Education from Central Washington University. Taught school for five years. Ann has served on the Board of Directors - WCLA Credit Union, State Board of Directors and past local president of Women in Timber and was a Governmental Affairs Representative for Washington Contract Loggers. Ann, her husband, Eric, and daughter, Cori, reside in Acme.

BAILEY, CLIFF

Republican. Senator from 39th District of Snohomish County, serving second term in Senate. Born in Snohomish County. Business and civic services range from presidencies State FFA, Snohomish Cty. Dairy Herd Improve. Assn., All-West Breeders Assn.; other farm organizations. Elected Natl. Pres.-Holstein Friesian Assn. of America-1974, largest dairy cattle assn. in world. Past Dir. and Chrm. of Snohomish School Bd. Elected at-large to Snohomish Cty. Council in 1980; elected to substantive post of Council Chrm. in 1982 and 83. He, his wife, Rosemary, and two sons, Don and Dan, still farm the Snohomish Valley dairy established by his grandfather in 1918. A third son, David, resides in Chelan.



BARR, SCOTT

Republican. Senator from the 7th District comprising Lincoln, Pend Oreille, Stevens, Ferry and parts of Okanogan and Spokane Counties. Serving second term in Senate; previously served three terms in House from 1977-1982. Born in 1916. Attended Whitman County schools. He and his wife, Dollie Mae, live on their cattle, grain and timber farm near Edwall in Lincoln County. Belongs to Grange, Farm Bureau, Cattlemen's Assn. Served as President of State Wheat Growers' Assn. and State Assn. of Conservation Districts. Involved in agri-related businesses and civic affairs.

BAUER, ALBERT**Democratic Floor Leader**

Democrat. Senator from the 49th District of Clark County, is serving his third term. Served as Representative from 1971 through 1980. Born in Lewistown, Montana in 1928. Graduate Portland State College and Oregon State College with Masters in Education and minor in Political Science. Past President Community Club, PTA, Vancouver Education Association. Member: Kiwanis, Grange, American Legion and Salmon Creek Methodist Church. He is currently self-employed in agriculture. He and his wife, Patricia, have three children: Sue, Jim and Nancy.

**BENDER, RICK S.****Democratic Whip**

Democrat. He is serving his second term in the Senate representing the 44th District of South Snohomish and North King Counties, following five terms in the House of Representatives. Member of the Education and Transportation Committees. Born in Fairbanks, Alaska in 1949. Attended North Seattle Community College, University of Washington and the University of Puget Sound. Republican. Senator from the 8th District of Benton County. Serving his fourth term in the Senate and served three sessions in the House of Representatives. Born in Wathena, Kansas. He is an engineering design manager for The Boeing Company, a U.S. Navy Veteran, and a Seattle Science Center Foundation Associate. Democrat. Senator from the 24th District comprising Clallam, Jefferson and part of Grays Harbor County. Attended Port Angeles Business College, Western Washington State College, University of Washington and Peninsula College. He and his wife, Thelma, have five children.

Vice President Pro Tempore

Republican. Senator from the 23rd District, Kitsap County, serving her third term in the Senate. Served two terms in the House of Representatives. Raised in Kitsap County. She and her husband, Bruce, have four grown children, and are active in church and christian organizations.

Democrat. Senator from the 19th District, comprising Pacific, Wahkiakum, and parts of Cowlitz and Grays Harbor Counties. Serving his second term in the Senate; previously served five terms in the House. Born in Glezen, Indiana. Received A.B. from Cornell College and M.A. from University of Northern Colorado. Member: Lower Columbia E.D.C., Cowlitz E.D.C., Sea Resources, AARP-NRTA and Longview Rotary. Retired educator. He and his wife, Donna, have five children and six grandchildren.

Democrat. Senator from the 37th District, King County. Served one session in House, serving eighteenth session in Senate. Born 1938 in Dallas, Texas. Graduate of University of Washington with B.A. in Business Administration. Member of Rose Bowl teams in 1960 and 1961. Community Development Manager, US West Communications. Member: Past President, Economic Development Executives of Washington; Past President, Pacific NW Industrial Development Council; Small Business Improvement Council; Economic Development Partnership of Washington; Bd member, Rainier Valley Enterprise Center and Central Area Motivation Program. He and his wife, Tina, an educator, have two daughters, Sonja and Yemi, and a granddaughter, Arica.



GASPARD, MARCUS S.

Democrat. Senator from the 25th District of Pierce County. He has served in the Senate since 1976 after serving two terms in the House of Representatives. He is currently the Chairman of State Economic Forecast Council, ranking Democrat on the Ways and Means Committee, member of the Education and Agriculture Committees and a member of the Legislative Budget Committee. He was born in 1948 and reared in the Puyallup Valley of Washington. He has a degree in Business Administration from the University of Oregon and is employed in the field of real estate and property management. Marc and his wife, Jo Anne, and their two young daughters, Morgan and Mackenzie, live in Sumner, Washington.

HANSEN, FRANK "TUB"

Democrat. Senator from the 13th District comprised of most of Grant, and parts of Kittitas, Yakima, and Adams Counties, serving his third term in the Senate, served six years in the House of Representatives. Born in Olema, Washington. Retired cattle rancher. Past Chairman Agriculture Stabilization Conservation Service; Past Director, Washington State Cattlemen's Association. Member: Grange, Wheat Growers and Elks. He and his wife, Wanda, have two sons and two daughters.



HAYNER, JEANNETTE Majority Leader

Republican. Senator from the 16th District comprising Walla Walla County, part of Franklin and Benton Counties. Serving her fourth term in the Senate, served four years in the House of Representatives. Received B.A. and J.D. degrees from the University of Oregon. Involved in a variety of civic activities. Currently serves on several state and regional citizen advisory boards, including the Organized Crime Advisory Board, and the Centennial Commission. Member of the Lutheran Church. She and her husband have three children.

JOHNSON, STANLEY C.
Majority Caucus Vice Chair

Republican. Senator from the 28th District, comprising Lakewood, Tillicum, University Place, Fircrest and Steilacoom. Resident of the district 22 years. President/Owner of Gerrish Bearing & Industrial Supplies, Inc. for the past 32 years. Former Chairman of the Clover Park School District's Board of Directors. Formerly National President of North American Baptist General Conference. Presently Certified Professional Parliamentarian, American Institute of Parliamentarians. He and his wife, Anita, have four children, Mark, Tim, Kris and Andy; and four grandchildren, Andrea, Cayla, Scott and Wesley.



KREIDLER, MIKE

Democrat. His district contains a portion of Thurston County including our State Capitol. He is currently serving his second term. Previously he was elected to the North Thurston School Board and four times to the House of Representatives. Born and raised in the Tacoma area. He holds degrees from Pacific University and U.C.L.A. He is a practicing optometrist with Olympia Group Health Cooperative of the Puget Sound Clinic. He and his wife, Lela, together with their three children, Kelli, Michael and Lora, reside in Olympia.

LEE, ELEANOR

Republican. Senator from the 33rd District. Attended Washington State University and graduated from The Evergreen State College in Political Science. Owner and business manager of a residential improvement firm. Former State Land Planning Commissioner and League of Women Voters official; Past Chair of Fire District 2, Civil Service Board, Highline Citizens for Schools, and Civil Air Patrol Advisory Committee. Founder and co-chair Elected Washington Women. She and her husband, David, have three daughters and five grandchildren.



MADSEN, KEN

Democrat. Senator Madsen represents the 2nd Legislative District which includes parts of Pierce and Thurston Counties. A former Green Beret and military advisor in Southeast Asia, with a Master's degree in business. Ken lives on a quiet farm in Roy. First elected in 1984 to the State House of Representatives. He has served in the State Senate since January of 1988. He is a grange, rotary and chamber member, and was appointed to the Governor's Alliance Against Drugs. Ken is recognized for his hard work and capable leadership.

SENATORS

MATSON, JIM

Republican. Senator from the 14th District, covering Yakima, Selah and part of Yakima County. Born in Yakima, where he attended Selah Schools, Yakima Valley College and Whitman College. A veteran of World War II, returned to Selah to live on his fruit ranch. Previously served 12 years in the Washington State Senate as a member of Transportation and Utilities, Agriculture, Labor, Ways and Means, and Rules Committees; holding positions of Whip, Vice-Chairman/Secretary, Chairman and Republican Leader. Presently Chairman of the Washington State Apple Commission, having served on the Board since 1983.

**McCASLIN, BOB**

Republican. Senator from the 4th Legislative District of Spokane County. Served in the U.S. Navy during WW II, graduate of WSU in 1950, post graduate work in 1951 and 1952 with a major in Sociology and Economics. Served in Production Management for 17 years with large aluminum fabricator and for the past 18 years has owned and managed a real estate firm in the Spokane Valley. Married, has two children, Janie and Bob, and with wife, Wanda, has been active in many service clubs and civic activities in the Spokane Valley.

McDONALD, DAN

Republican. First elected in 1978, represents Bellevue, Kirkland and Redmond area of King Co. He and his wife, Janie, and two sons, have lived in Bellevue for 17 years, since his return from tour as Naval Off. in Vietnam. He is a graduate in mech. engineering from the Univ. of Wash. and has a masters degree in economics. Presently employed with a consulting firm. He is active in the Municipal League, Bellevue Chamber of Commerce, American Public Works Assn. and Rotary. Appointed member of LEAP Committee. Member and past chairman of Econ. & Revenue Forecasting Council. Past Commissioner of WICHE.

**McMULLEN, PATRICK R.****Democratic Assistant Whip**

Democrat. Serving 40th District comprising western Skagit, southern Whatcom and San Juan Counties. Served five years in the House of Representatives, including Majority Leader and Chair of Trade and Economic Development Committee. Graduated from University of Washington with B.A. in Political Science, followed by a J.D. Degree in 1969. Served as Assistant Attorney General, twice elected Prosecuting Attorney for Skagit County. Now engaged in private practice, specializing in worker's compensation claims. Member of WSTLA.
