# CHRISTINE GREGOIRE Governor

Washington Gov. Christine Gregoire was elected the Evergreen State's 22nd governor on Nov. 2, 2004. She was Washington state attorney general for the 12 years prior, being the first woman elected to the position in state history.

As governor, Gregoire will work to:

- · Spur economic development and create jobs
- · Improve schools and colleges
- · Create broader access to health care
- Provide tax relief for small businesses
- · Help veterans

Raised in Auburn, Washington, Gregoire graduated from the University of Washington in 1969 with a teaching certificate and Bachelor of Arts degree in speech and sociology. In 1977, she received a Juris Doctorate degree and, in 1995, an honorary Doctor of Law degree from Gonzaga University.

Gregoire's record as attorney general reflected a commitment to ensuring that the laws of Washington work on behalf of all the people of our state. She worked tirelessly on children's issues and led a statewide program that resulted in a comprehensive reform of the state's juvenile system. She also worked to pass a tough new ethics law for state government and to find alternatives to litigation in resolving legal disputes.

Among other accomplishments as attorney general, Gregoire:

- Was lead negotiator in a groundbreaking settlement of state lawsuits against the tobacco industry.
- Was leader in the effort to protect privacy and combat identity theft.
- Worked to protect consumers and investors in the wake of the Enron scandal.
- Investigated and sued several drug companies for violating antitrust laws.

Prior to being elected attorney general, Gregoire served as director of the Washington Department of Ecology from 1988 to 1992 where she negotiated the breakthrough agreement to clean up the Hanford nuclear site. Gregoire and her husband, Michael, reside in Olympia. They have two daughters—Courtney, who attends law school, and Michelle, who is a sophomore in college.



#### BRAD OWEN Lt. Governor

Democrat. Brad Owen was elected as Washington State's 15th Lieutenant Governor in 1996, and was re-elected to his third term in 2004. He serves the state as president of the Senate, and is acting governor in the absence of the Governor. Owen was a small business owner and served his community as Shelton Finance Commissioner, followed by several terms as a state Senator and Representative. The Lieutenant Governor has dedicated his term of service to "helping kids grow up healthy in safe communities with opportunity", his office motto. Owen also actively supports strengthening the ties between Washington State's international community and state government. For the past several years he has worked toward fostering international trade and building stronger international connections. Owen also founded and is the president of a non-profit organization called Strategies for Youth. This innovative organization partners with his office to develop and deliver positive messages to youth, as well as to the community at large. Owen is married with six children and eleven grandchildren, and lives in Shelton.



#### SAM REED

#### Secretary of State

Republican. Sam Reed was elected as Washington's 14th Secretary of State in 2000 and re-elected for a second term in 2004. Raised in Wenatchee and a graduate of Lewis and Clark High School in Spokane, Secretary Reed received his Bachelors Degree in Social Studies and a Masters Degree in Political Science from Washington State University. Prior to his service as Secretary of State, Reed served five terms as Thurston County Auditor, receiving 10 national awards for innovations in the areas of election reform and record management. He served as the Assistant Secretary of State for six years and as Executive Director on Governor Evans' Constitutional Reform Commission and Urban Affairs Council. Since taking office, Reed has made substantial strides to bring Washington State into the 21st century. He launched the nation's first state government digital archives built from the ground up and helped to make Washington a more business-friendly state including, for the first time in state history, online corporate filing. Secretary Reed is credited with saving the State Library which is now placed in his office. Reed is nationally recognized for his expertise in elections. He fought to save Washington's beloved Blanket Primary. In 2004, he successfully advocated a new primary system similar to the Blanket Primary that allows people the freedom to vote for whomever they choose. Reed and his wife Margie, have a son David, a daughter Kristen, and a son-in-law Eric. They are the proud grandparents of Nathan and make their home in Olympia.



# MICHAEL J. MURPHY

#### State Treasurer

Democrat. Michael J. Murphy is the 21st Treasurer of the State of Washington. He was elected in 1996 and took office on Jan. 15, 1997. He was re-elected in 2000 and again in November 2004. Mike is a Seattle native and the eldest son of a family of 11 children. He graduated from Seattle University in 1969 with a B.A. in history. After a tour of duty in the military, Mike was hired by the Office of the State Treasurer in 1972. In his first 15 years at the state treasurer's office, Mike held jobs including administrator of the Public Deposit Protection Commission and internal auditor. While working full-time and attending college at night, Mike earned his M.B.A. from Pacific Lutheran University. Mike was appointed treasurer of Thurston County, the state's eighth largest county, in spring 1987. He won election to the position in fall 1987 and was re-elected in 1990 and 1994. As State Treasurer, Mike is responsible for investments of more than \$7.6 billion in the treasury portfolio, including \$4.3 billion in the Local Government Investment Pool. The State Treasurer is chair of the State Finance Committee, which oversees management of the state's outstanding debt. The State Treasurer is one of 10 voting members of the State Investment Board, which manages more than \$57 billion in investments. Mike is vice president of the Western State Treasurers Association. Mike is married to Teri Smith Murphy, who retired in 2001 after 30 years as a teacher in the Olympia School District. Mike and Teri live in Olympia.



#### BRIAN SONNTAG State Auditor

Democrat. Now in his fourth term, Brian Sonntag has served the citizens of Washington as State Auditor since 1993. He is committed to open and accountable government. He supports independent, comprehensive performance audits of state government and strengthening the state's open public records and open public meetings laws to protect the rights of citizens to know what their government is doing. Brian is a Certified Government Financial Manager and a member of the Performance Audit Task Force of the National State Auditor's Association. He also serves on the Board of the Washington Coalition for Open Government and is a member of the Rainier Institute, a public policy research organization devoted to developing practical solutions to difficult issues facing Washington State. He is a member of the facing Washington State. He is a member of the state Productivity Board and co-chairs Public Service Recognition Week, an annual event showcasing the achievements of state employees. Brian is the state's eighth elected State Auditor. He has a long career in public service. He was elected Pierce County Clerk at age 26 and later served as Pierce County Auditor, an office his father once held. His civic involvement has included United Way, Boys and Girls Club, YMCA, March of Dimes and coaching youth baseball and basketball. Brian and his wife, Jann, live in Tacoma. Brian has three sons and one grandson.



#### ROB McKENNA Attorney General

Republican. Serving his first term. Rob began his legal career at Perkins Coie in Seattle, specializing in business and regulatory law. In 1995, he was elected to the King County Council and ran unop-posed in 1999 and 2003. He chaired the Regional Transit, Budget and Transportation Committees and served on the Law, Justice and Human Services Committee. He chaired the Washington State Transportation Improvement Board and the Eastside Transportation Partnership; served on the Sound Transit Board; was a board member of the Economic Development Council of Seattle and King County; and co-founded the Eastside Human Services Forum. Rob is an Eagle Scout; past president of the Bellevue Schools Foundation; Board Member of the Bellevue Community College Foundation; Fundraising Chair for the Eastside Domestic Violence Program; Executive Board Member of the Boy Scouts of America. Chief Seattle Council; and he co-chaired the City of Hope Walk for Hope to Cure Breast Cancer. His honors include: Advance Bellevue 10th Anniversary Legacy Award; Washington Law and Politics "25 Smartest People in Washington"; the Puget Sound Business Journal's "40 Under 40" award; and the Municipal League's Doug Mason Memorial Award. Rob earned dual bachelors degrees with distinction in economics and international studies from the University of Washington and his law degree from the University of Chicago. He resides in Bellevue with his wife Marilyn, and their four children.



# TERESA "TERRY" BERGESON, Ph.D. Superintendent of Public Instruction

Nonpartisan. For more than 35 years, Terry Bergeson has worked to ensure public school students achieve an education that truly prepares them for life beyond the classroom. Born and raised in Massachusetts, Bergeson holds a B.A. in English, a master's degree in counseling and guidance and a Ph.D. in education. She began her career as a teacher and junior high school guidance counselor, working in Massachusetts, Alaska, and Washington. As an advocate for education and educators, Dr. Bergeson became active in the Washington Education Association; she was elected vice president in 1981, then president in 1985. She was hired in 1989 as executive director of the Central Kitsap School District, where she supervised nine schools and several special programs. In 1993, Dr. Bergeson was appointed executive director of the Washington State Commission on Student Learning. As executive director, Dr. Bergeson was charged with developing statewide standards for students, as well as a series of tests students must pass prior to graduation. She served as executive director until 1996, when she was first elected as state superintendent of public instruction. She was re-elected in 2000 and 2004.



#### DOUG SUTHERLAND Commissioner of Public Lands

Republican. Serving his second term as Commissioner of Public Lands, Doug Sutherland administers the Department of Natural Resources, the state's management agency for forest, agricultural, range, tidal and shore lands. As Commissioner, Doug will work to balance the important goals of providing funding for schools, habitat protection and opportunities for recreation. He serves as chair of the Board of Natural Resources and the Forest Practices Board. Elected in November 2000, Doug previously served two terms as Pierce County Executive where he was co-chair of the Tri-County ESA Task Force. Doug began his political career as a member of the Tacoma City Council, then as Tacoma's mayor from 1982-1990. As mayor, Doug was instrumental in beginning the Superfund cleanup of Commencement Bay and improving Tacoma's air quality.



#### MIKE KREIDLER Insurance Commissioner

Democrat. Native-son Mike Kreidler has served the people of Washington in elected offices and appointed posts at local, state and national levels for more than 30 years. Beginning his career as a school board member, he then served 16 years in the state legislature - both houses - and was later elected to Congress. President Clinton appointed him Regional Director of the Department of Health and Human Services. He also served gubernatorial appointments representing Washington on the Northwest Power Planning Council. Reelected Insurance Commissioner in 2004, Mike continues a strong commitment to consumer protection as his second term unfolds, advocating for health insurance reform and a strong regulatory presence in the state's insurance markets. A doctor of optometry, he practiced at Group Health Cooperative of Puget Sound for 20 years. He also holds a master's degree in public health and was a founding director of what is now Venture Bank. Mike retired as a Lieutenant Colonel from the Army Reserves with 20 years of service in 2003. He and wife Lela have three children and are proud grandparents. They reside in Lacev.

# BRAD OWEN Lieutenant Governor President of the Senate

#### BRAD OWEN Lt. Governor

Born in Tacoma, Washington on May 23, 1950, Lieutenant Governor Owen graduated from Frankfurt American High School in 1968. Upon returning to the U.S. after graduation, he moved back to his birth state of Washington and then later settled in Shelton. During the next 22 years, Owen was a small business owner and became a prominent member of his community.

Brad Owen was elected as Washington state's 15th lieutenant governor in 1996, and in 2005 is commencing his third term as lieutenant governor. Lieutenant Governor Owen serves the state as president of the Senate, and is the acting governor in the absence of the governor. Prior to his election as lieutenant governor, Owen served as Shelton finance commissioner from 1976-1979, as a member of the Washington State House of Representatives from 1976-1982, and in the Washington State Senate from 1983-1996.

Lieutenant Governor Owen has dedicated his term of service to provide leadership in the field of public health and safety, with an emphasis on substance abuse and prevention. He is the co-chair of the new Washington State Mentoring Partnership, as well as the chair of the Legislative Committee on Economic Development and International Relations. He has conducted many foreign trade and goodwill missions and promotes stronger ties among Washington State's economic and international communities. Additionally, as president of a non-profit organization called Strategies for Youth (SFY), he develops and delivers positive messages about substance abuse and bullying awareness to youth, as well as to the community at large. In 2002, he received an Honorary Doctorate of Letters (Humanities) from Walla Walla College for his years of public service and work with kids and communities.

Lieutenant Governor Owen is an avid outdoorsman, hunter, and fisherman, and enjoys playing a variety of musical instruments including the guitar, drums, and sax. Owen and his wife, Linda, live in Shelton. They have six children: Shanie, Dana, Sherri, Mark, Adam, and Royce, and eleven grandchildren: Elizabeth, Casey, Amanda, Savannah, Joshua, CammiAnn, Seth, Sophia, Naomi, Luke, and Jayden.



#### BENSON, BRAD

Republican. Brad is serving his first term as Senator representing the 6th District. He previously served four terms in the House of Representatives. A former small business owner, he worked in the banking industry for seven years, including positions as a branch manager, trust officer and assistant vice president at Seafirst National Bank. He served as a Captain in the Air Force from 1982 to 1988 and is currently a Major in the Air National Guard, 141st Air Refueling Wing, Fairchild Air Force Base. Benson earned a Bachelor of Science degree from the California State University and a master's degree from the University of Southern California. He is actively involved in several community groups, including serving as a board member for the Inland Northwest Technology Education Center (INTEC). He is also active in Spokane's Hoopfest Tournament and serves on several committees with Northview Bible Church. He and his wife Jill have four children: Ashley, Patrick, Grahm and Hannah, and one grandchild, Dane.



BENTON, DON Republican. Represents the 17th District, eastern Clark County. A self-employed business owner, Don lives in Vancouver with his wife, Mary, and four children. His company, The Benton Group, conducts sales, marketing, training and consulting for television, radio and cable companies worldwide. Don holds a B.S. degree in management and communication and is an advertising and marketing expert. He is a Life Member of the Vancouver Moose Lodge #1774, Past President of the Jaycees and a member the Financial Literacy Public-Private Partnership. Don is also an Assistant Scoutmaster and Awards Chairman for his son's Cub Scout pack.



**BERKEY, JEAN Democrat.** Senator for the 38th District. Jean is in her fifth year serving the citizens of the 38th District, first as representative and now as senator, which includes Everett and Marysville. Jean has long been active in political and community activities in Snohomish County – serving as board member for a number of organizations includ-ing the Everett Senior Center, the Everett Medic One Foundation, United Way and the Everett Community College Board of Trustees. She has a bachelor's degree in business administration from the University of Washington. Jean is a strong advocate for education, government accountability, and affordable health care, and serves as the vice-chair for the both the Financial Institutions, Insurance & Consumer Protection Committee and the Government Operations & Elections Committee, and a member of the Early Education, K-12 and Higher Education Committee. Jean and her husband, Don, make their home in South Everett.



#### BRANDLAND, DALE E. Republican Caucus Vice Chair

Republican. Sen. Dale Brandland is serving his first term as a state senator representing the 42nd District, which includes Bellingham, Blaine, Ferndale, Lynden and Point Roberts, Dale served as Whatcom County Sheriff for 11 years and also as a Bellingham Police Officer. He is a former president of the Washington Association of Sheriffs and Police Chiefs, the United Way of Whatcom County, and the Washington State Sheriff's Association. #### CARRELL, MIKE

Republican. Appointed in 2004 and reelected in 2005 to the Senate after serving five terms in the House of Representatives. Represents the 28th District, which includes Lakewood, DuPont, Fircrest, University Place, Steilacoom, Tillicum, West Tacoma and Anderson, Ketron, Day and McNeil islands. Serves on the Judiciary Committee; Early Learning, K-12 and Higher Education Committee; and Human Services and Corrections Committee. A community leader and state legislator, Sen. Carrell is a life-long Tacoma-area resident and retired educator who taught science at Franklin Pierce High School and Pierce College for over 30 years. Also serves the community through civic, church and professional organizations. Received his B.A. in Education from Pacific Lutheran University. Married to Charlotte, they have three sons and four grandchildren.



DECCIO, ALEX Republican. Represents the 14th District, covering parts of Yakima County. Serving his sixth term as a state Senator since 1981. Serves as the ranking member on the Senate Health and Long-Term Care Committee and as a member of the Labor, Commerce and Research and Development Committee. Previous public service includes the House of Representatives from 1975-1981; Yakima County Commissioner from 1989-1993. Active in Yakima civic affairs. Member of several community organizations and member of the Yakima Rotary Club. Sen. Deccio and his wife, Lucille, have seven children and 19 grandchildren and 3 great-grandchildren.



#### DELVIN, JEROME

Republican. Jerome is serving his first term as Senator in the 8th District. He previously served five terms in the House of Representatives in the 8th District, which includes Kennewick, Richland, West Richland, Benton City and Prosser in Benton County. Former military policeman and officer in the Hanford Patrol; Richland Police Officer since 1979; 20 years as trained bomb technician, eight years as Drug Abuse Resistance Education (D.A.Ř.E.) officer. Holds two associate degrees from Columbia Basin College. An avid backpacker, downhill skier and mountain climber, Jerome was part of the 2002 American expedition that climbed Manaslu, the world's 8th highest peak. A lifelong resident of Benton County, he is 48 and lives with wife Josie in Richland.



#### DOUMIT, MARK LAWTON

Democrat. Appointed to the Senate in 2003, re-elected in 2004. Served three terms in the House of Representatives. Represents the 19th District which includes Pacific and Wahkiakum counties, and parts of Grays Harbor and Cowlitz counties. Commercial fisherman and owner of 210-acre commercial tree farm. Wahkiakum County Commissioner two terms (eight years). 
### ERICKSEN, DOUG Republican Floor Leader

### How a Bill Becomes a Law

 A bill may be introduced in either the Senate or House of Representatives, but the procedure by which a bill becomes a law is much the same, wherever the bill originates.

The bill is introduced in the Senate or the House by a member, or members, of that body. After the bill is filed with the Secretary of the Senate or Chief Clerk of the House, it is given a number and, it is read the first time by title only in open session and referred to a standing committee.

- The committee studies the bill and often holds public hearings on it. The committee will then meet to consider the information it has gathered. It may approve the bill with or without amendments, draft a new bill on the same subject incorporating the desired changes, or take no action.
- 3. The committee is now ready to report back to the Senate or the House. If the majority is in favor of the bill as introduced or with certain amendments, the chair recommends the bill for passage. The committee report is read in open session of the Senate or the House, and the bill is then referred to the Rules Committee.
- 4. After the bill has been recommended for passage by the standing committee to which it was originally referred, the Rules Committee can either place it on the second reading calendar for debate before the entire body, or take no action.
- 5. When the bill appears on the calendar for second reading, it is subject to amendment. It is then returned to the Rules Committee where it must receive a favorable vote before being placed on the third reading calendar for final passage. This referral to Rules is often bypassed by vote of the Senate or the House and the bill placed on final passage immediately following its second reading. Depending upon the degree of controversy, debate may last a few minutes to several hours or even several days.
- After passing in the Senate or the House, the bill will go through an almost identical procedure in the other body.
  - If the bill is passed by the other body, but is amended, the originating body must concur in the amendments. If the change in the bill is not accepted, it may be returned for reconsideration of the amendments. If the amendments are not rescinded, a conference committee may be requested on the differences.
- 7. If the conference committee cannot agree, a conference committee may be appointed with power to rewrite the amendment or even write an entirely new bill. When the conferees reach agreement, they report to their respective houses. Their report is either accepted or rejected without any changes.
- If the report is accepted by both houses, the bill is signed by the President of the Senate and the Speaker of the House in open sessions of each body, and then is sent for the Governor's signature.
- 9. Within five days, if the Legislature is still is session, or 20 days after its adjournment, the Governor may sign the bill or veto all or any section of it. The Legislature can override the veto by a two-thirds vote of both houses. If the Governor fails to act on the bill, it becomes law without a signature.

## **Visitors Tour Information**

The State Capitol Tour Program provides educational tours to school groups, constituent visitors and guests, community organizations and the visiting public. The Tour Office will coordinate with legislator's office arrangements for visiting constituents. When school groups are scheduled to tour the capitol during session, the legislator's office will reserve a time for the legislator to speak to the group from their district.

Requests from constituents often come directly to the Tour Office which then informs the legislators from the district. Many times the request comes first to the legislator who will then call the office with the name of the group and a contact phone number.

Guided public tours of the Washington State Legislative Building are offered seven days a week between the hours of 10:00 a.m. and 3:00 p.m. Tours are free and begin every hour on the hour and last 60 minutes. Groups can meet their tour guide at the foot of the rotunda steps on the north side of the building, just inside the main entrance. The Legislative Building is closed on Thanksgiving, Christmas, and New Year's Day.



## State Capitol Parking Information


There are six parking locations available to visitors at the Capitol:

- Visitor Information Center Parking. Located at the Visitor Information Center at 14th and Capitol Way. There is a \$.50 per hour charge. The phone number is (360) 586-3460.
- 2. North and South Diagonal Parking. Located along the North and South Diagonal roads on the Capitol Campus. There is a \$.50 per hour charge. South Diagonal parking is not available for public parking during legislative session.
- 3. **General Administration Parking Garage** (upper level) off of 11th Avenue. There is a \$.50 per hour charge.
- Natural Resources P1 Parking Lot off Washington Street is metered parking.
- 5. The Satellite Visitor Parking Lot at Jefferson Street and 16th Avenue (access at Jefferson). Parking is metered. The Legislative Shuttle will operate continually every weekday from 7:30 a.m. to 5:45 p.m. throughout the session. This shuttle service is free. Wheelchair accessible.



6. Deschutes Parkway along Capitol Lake (see map next page). Intercity Transit serves Deschutes Parkway weekdays every 30 minutes. Buses operate between the Westside and the downtown Transit Center where passengers can transfer to the Capitol Campus and other destinations. For route and schedule information, call (360) 786-1881 or visit www.intercitytransit.com. The fare is \$.75 for a single ride and \$1.50 for an all-day pass.

## State Capitol Parking Information



To Deschutes Parkway from I-5 Southbound: Take exit 103 and proceed on 2nd Avenue; turn left onto the Custer Way overpass; turn right on Boston, proceed downhill to Deschutes Parkway; turn right (north) onto the Parkway and proceed to the designated parking area along Capitol Lake.

**To Deschutes Parkway from I-5 Northbound:** Take exit 103 and proceed north on Deschutes Parkway through the stop sign to the designated parking area along Capitol Lake.

**Tour and School Buses:** Buses may unload and reload passengers on the Capitol Campus at the Winged Victory statue (at the junction of the North and South Diagonals). Buses should then park in the bus parking area at the Satellite Parking Lot.
