### JAY INSLEE Governor

Jay Inslee is a fifth-generation Washingtonian who grew up in the Seattle area. His father, Frank, was a high school teacher and coach. His mother worked as a sales clerk at Sears & Roebuck. Jay worked his way through college and graduated from the University of Washington with a degree in economics before earning his law degree at Willamette University. He and his wife, Trudi, then moved to Selah where Jay worked as a prosecutor and they raised their three sons.

Jay first became involved in public service in 1985 when he and Trudi helped lead the effort to build a new public high school in Selah. Motivated to fight against proposed funding cuts for rural schools, Jay went on to represent the 14th Legislative District in the state House of Representatives. He continued serving communities in the Yakima Valley when he was elected to Congress in 1992. The Inslees later moved back to the Puget Sound area where Jay was elected to Congress in 1998, serving until 2012.

During his time in Congress, Jay became known as a forward-thinking leader, especially on issues of clean energy and the environment. He co-wrote a book, "Apollo's Fire: Igniting America's Clean-Energy Economy," about the job-creating potential of the clean tech industry. As governor, Jay's top priority is growing Washington's innovative industries such as clean energy, IT and life sciences and strengthening existing industries such as aerospace, agriculture, maritime and military.

To grow these industries, Jay knows we must strengthen our schools so we can better equip our children to compete for these good-paying jobs. And we must bring a new culture of efficiency and performance to state government, to more efficiently serve the people and businesses throughout Washington State.

Jay and Trudi are proud grandparents to three grandchildren. Besides writing and illustrating books for his grandchildren and sketching scenes from around Washington, Jay is an avid cyclist and charter member of Hoopaholics.

**BRAD OWEN**  
**Lt. Governor**

**Democrat.** Brad Owen was elected as Washington State's 15th lieutenant governor in 1996, and was re-elected to his fifth term in 2012. He serves the state as president of the Senate, and is acting governor in the absence of the governor. Owen was a small business owner and served his community as a finance commissioner in Shelton, followed by 20 years of combined service as a state Senator and Representative. The lieutenant governor has dedicated his term of service to "helping kids grow up healthy in safe communities with opportunity," his office motto. Owen also actively supports strengthening the ties between Washington state's international community and state government. For the past several years he has worked toward fostering international trade and building stronger international connections. Owen is married with 6 children, 20 grandchildren and one great-grandchild, and lives in Shelton.



**KIM WYMAN**  
**Secretary of State**

**Republican.** Washington's 15th Secretary of State, Kim Wyman, is currently serving her first term. Elected in 2012, she is the second female Secretary of State in Washington history and the only woman currently holding statewide executive office.

Prior to being sworn into this office, Kim served as the Thurston County Elections Director and was elected Thurston County Auditor in 2001. Kim actively participates in multiple state and national workgroups, which has helped make Washington State a national leader.

Secretary Wyman leads one of the most diverse offices in state government. She promotes civility and civic engagement and is committed to connecting people with their government. Kim enjoys mentoring students and participates in leadership development organizations. She is an advocate for our military service members, veterans, and their families.

Kim is a graduate of California State University, Long Beach and holds a Master's Degree in Public Administration from Troy State University. She is a Rodel Fellow, member of the Lacey Rotary Club, serves on the boards of the Washington State Historical Society, TVW and Jennifer Dunn Leadership Institute (board chairman), and takes part in numerous civic activities.

Kim and her husband John reside in Thurston County with their two children.

### **JIM MCINTIRE** **State Treasurer**

**Democrat.** James L. McIntire was elected as Washington's 22nd State Treasurer in 2008 and reelected in 2012. Upon taking office in 2009, the failure of a small bank sparked concerns about the security of state and local public deposits. McIntire initiated reforms that preserved secure access to banking services for local and state governments. Though 19 banks holding public deposits have failed since 2009, none of the public money they held was lost.

In 2011, McIntire prepared the State's first ever debt affordability study to provide a comprehensive tool for managing the state's debt. McIntire has also re-engineered the way the Treasurer's Office issues bonds. These changes infused greater competition and market pressure in the process, allowing the Office to capture \$1.3 billion in savings through refinancing outstanding debt and lower than expected interest rates on new issues.

McIntire was elected chair of the State Investment Board in September, 2011. He also chairs the State Finance Committee and the Public Deposit Protection Commission. He is Co-Chair of the Democratic State Treasurers and the immediate past president of the Western State Treasurer's Association.



### **TROY KELLEY** **State Auditor**

**Democrat.** Prior to his election as State Auditor in 2012, Troy Kelley served three terms in the Washington House of Representatives, where he chaired the Joint Legislative Audit and Review Committee.

Kelley is committed to independence, respect and integrity in his agency's interactions with state and local governments to help them work better, cost less and deliver higher value. For him, the bottom line is better government.

For nearly 30 years, Kelley focused on the business of moving families into homes. Early in his career, Kelley served in the criminal section of the federal prosecutor's office (Western District of New York). Later, he worked as an attorney for the Securities and Exchange Commission in Washington, D.C., leading teams focused on regulatory audits.

Kelley holds a B.A. from the University of California at Berkeley, and a J.D. and an M.B.A. from the State University of New York at Buffalo; and is a member of the Washington State Bar. A 20-year Army Judge Advocate General (JAG) officer, Kelley serves as a lieutenant colonel in the National Guard.

He lives with his wife, Diane, and their two sons in Tacoma, where Kelley enjoys coaching the boys' sports teams.

### **BOB FERGUSON** **Attorney General**

**Democrat.** Bob Ferguson is Washington's 18th Attorney General. As the state's chief legal officer, he is committed to protecting the people of Washington against powerful interests that don't play by the rules. Bob is focused on standing up for consumers and defending taxpayers, protecting seniors, keeping our communities safe, protecting our environment and advocating for our veterans and military families. His office provides legal services to more than 230 state agencies, boards and commissions. During his first two years in office, Bob has stopped deceptive business practices and returned millions of dollars to consumers, kept sexually violent predators off our streets, taken action on environmental cleanup and improved access to veteran benefits.

Bob is a fourth-generation Washingtonian, a graduate of the University of Washington and New York University law school. Bob began his legal career in Spokane as a law clerk for Chief Judge Wm. Fremming Nielsen of the Eastern District of Washington. Bob and his wife, Colleen, are the proud parents of 6-year-old twins, Jack and Katie. He hopes they are future Huskies.



### **RANDY DORN** **Superintendent of Public Instruction**

**Non-partisan.** A lifelong resident of Washington state, Randy Dorn has been an elementary and middle school teacher, a principal and a legislator. For nine years he was executive director of Public School Employees of Washington, the second largest educational employee's organization in Washington state.

In 2008, Dorn was elected Superintendent of Public Instruction. In his 3+ years as state superintendent, he has replaced the existing state assessment system with a shorter system, argued successfully against cuts to education funding, expanded early learning opportunities for all students and championed an updated teacher and principal evaluation system. He also established partnerships with major businesses, including Microsoft and Boeing, to help students gain real world skills they can apply to the job market or the classroom.

Dorn and his wife, Kaye, live in Eatonville and have three grown sons.

### **PETER GOLDMARK** **Commissioner of Public Lands**

**Democrat.** Lifelong Washington resident Peter Goldmark was elected to his second term in 2012 as Commissioner of Public Lands. Goldmark led the Department of Natural Resources (DNR) to raise more than \$276 million in Fiscal Year 2012 to fund the construction of public schools, colleges, universities, as well as county and state services.

With Puget Sound a priority, Goldmark helped create the Puget SoundCorps, improve aquatic leases, and strengthen the agency's ability to remove derelict vessels from our waterways. By development of innovative forest biomass industry and increasing the use of wind and solar power on state lands, the Commissioner has moved fostered renewable energy.

Goldmark chairs the state Board of Natural Resources, which sets policy for 3 million acres of publicly owned land. DNR also manages approximately 2.6 million acres of aquatic lands, which include tidelands, navigable lakes and rivers.

Goldmark oversees a department that protects 12.7 million acres from wildfires. He also chairs the state Forest Practices Board, which sets regulations concerning private timber harvests, forest road building, and other forest operations.

A rancher from Eastern Washington, Goldmark is a published scientist and holds a PhD in molecular biology from the University of California at Berkeley. He has held positions as the Director of the Department of Agriculture, Washington State University Regent, local school board member, and served as a volunteer firefighter for more than 30 years.

Goldmark and his wife, Wendy, split their time between their ranch in Okanogan and home in Olympia.



### **MIKE KREIDLER** **Insurance Commissioner**

**Democrat.** Mike Kreidler is Washington's eighth insurance commissioner, first elected in 2000 and re-elected to his fourth term in 2012. His term ends 2016. Commissioner Kreidler has earned a reputation as a staunch advocate for consumer advocacy and as a fair and balanced regulator.

Commissioner Kreidler served 16 years in the state Legislature, first as a Representative and then Senator. He later was elected to Congress.

A doctor of optometry, he practiced at Group Health Cooperative in Olympia for 20 years. He holds a master's degree in public health. Mike retired from the Army Reserves as a lieutenant colonel after 20 years of service. He and his wife, Lela, have three children and are proud grandparents.

He is the most-tenured insurance commissioner in the country, providing leadership that spans from health care reform to climate change.

The Office of the Insurance Commissioner oversees the insurance industry in Washington state. Its budget is financed by premium assessments charged to insurers.

### OWEN, BRAD Lieutenant Governor President of the Senate

Born and raised in Tacoma, Bradley Scott “Brad” Owen was elected Washington’s 15th lieutenant governor in 1996 and re-elected in 2000, 2004, 2008 and to his fifth term in 2012. His 39 years in public office includes service as a finance commissioner for the City of Shelton, and more than 20 years of combined service as a state Senator and Representative. He is now the longest-serving elected official in Washington state government as well as “the dean” of active lieutenant governors in the nation. The office motto “helping kids grow up healthy in safe communities with opportunity” summarizes the lieutenant governor’s leadership role in economic development, international relations and trade development, and inspiring youth to reach their full potential. As lieutenant governor he has conducted numerous foreign trade and goodwill missions to countries in Asia, Europe and South America. He holds leadership positions on numerous other boards and committees, both in the government and non-profit sectors. Among his many honors is the bestowment of a Spanish order of knighthood by the King of Spain in 2007. In 2002 he received an honorary doctorate in humanities from Walla Walla College. In 2014 he was awarded the Excellence in Mentoring Award for public leadership by the National Mentoring Partnership. He is a Rotary International Paul Harris Fellow. Lt. Governor Owen is an avid outdoorsman. He and Linda live in Shelton. They have six children, 20 grandchildren and one great-grandchild.

**ANGEL, JAN**  
**Majority Caucus Vice Chair**

**Republican, Majority Coalition Caucus.** Jan Angel is in her fourth term representing the 26th District, which includes portions of Pierce and Kitsap counties. She is a former Kitsap County commissioner, serving eight years. Jan owned a business for nine years with approximately 54 employees in Pierce and Kitsap counties, and was a Realtor in Kitsap County for seven years. She has served on numerous national, state and local boards, including the Washington State Association of Counties and is past president of the Western Washington District. **BAILEY, BARBARA**

Michael is a former diplomat and business consultant, having served as an economic affairs officer with the U.S. State Department in Iraq. **BECKER, RANDI**

She is the Chair of the Senate Health Care Committee and also serves on the Ways & Means; and Higher Education Committees. ### **BENTON, DON**

**Republican.** Don is Clark County's senior legislator, serving his fifth term as 17th District senator. Don is the Chairman of the Senate Financial Institutions and Insurance Committee, which deals with issues concerning banks, credit, lending, insurance companies, financial markets and multi-family housing. In 2013 Don was selected as the Director of Environmental Services for Clark County. He is also an advertising and marketing expert and the founder of The Benton Group. Don graduated cum laude from Portland's Concordia University with a bachelor's degree in management and communication and is the co-author of two books on marketing and success techniques. Don resides in Vancouver with wife Mary and four children.



### **BILLIG, ANDY**

#### **Deputy Minority Leader**

**Democrat.** This is Andy's first term representing Spokane's 3rd District in the Senate, after serving a term in the House. He serves in Democratic Caucus leadership as deputy leader. An active member of the community, he serves on the board of Spokane Neighborhood Action Partners and Thrive by Five Washington. Previously, he has served as a Big Brother, volunteer youth sports coach, and board member of the YMCA of the Inland Northwest. Andy is part-owner and former general manager/president of the Spokane Indians Baseball Club. He graduated cum laude from Georgetown University with a degree in Government.



### **BRAUN, JOHN**

#### **Majority Caucus Deputy Leader**

**Republican, Majority Coalition Caucus.** John is in his first term as 20th District senator, representing parts of Lewis, Cowlitz, Thurston and Clark counties. He is the Senate majority deputy leader, serving as vice-chair of three of his four committees. A Navy veteran and Naval Reserve commander, John is president of family-owned Braun Northwest, which specializes in building emergency-response vehicles. He has an engineering degree from the University of Washington and master's degrees in business and engineering from the University of Michigan. He has been recognized as Legislator of the Year by the Washington Farm Bureau and named a Guardian of Small Business by the National Federation of Independent Business. John and his family reside in Lewis County.



### **BROWN, SHARON**

#### **Vice President Pro Tempore**

**Republican, Majority Coalition Caucus.** Sen. Brown is the Chair of the Senate Trade and Economic Development Committee, which deals with issues regarding international trade, economic development incentives, tourism, and technical assistance for business. She is also one of the Legislature's leading voices on energy issues, including hydropower and nuclear energy. Brown served 22 years as a business attorney before being elected to the Kennewick City Council in 2009. In 2010, she was elected Mayor Pro Tem of the City of Kennewick, where she focused on increasing job growth in the city. An active member of the Tri-Cities community, Brown was appointed to the WA State Senate by the Benton County Commission and assumed office on February 4, 2013. She was elected to serve a full term in November of 2014. Brown is married and has five children.

### CARLYLE, REUVEN

**Democrat.** Represents the 36th District, which includes Seattle's northwest neighborhoods (Queen Anne, Magnolia, Belltown, South Lake Union, Greenwood, Ballard, Crown Hill, North Beach and Blue Ridge) including the iconic Space Needle. A serial entrepreneur in Seattle's wireless and software sectors, Reuven works professionally to bring advanced technology solutions to global markets. Reuven earned a BA from the University of Massachusetts and a MPA from Harvard University. He and his wife, Dr. Wendy Carlyle, have four children.



### CHASE, MARALYN

**Democrat.** Maralyn vigorously represented the democratic values of 32nd Legislative District citizens and their families in the House for nearly a decade before winning election to the Senate in 2010 where she continues to champion those values today. Maralyn earned her BA and MA in Political Science at the UW and was honored as Distinguished Alumni of 2008. She serves on the boards of the Shoreline Chamber of Commerce and the Shoreline Solar Project. Maralyn fights for working families, students, seniors and vulnerable citizens. #### **Democratic Assistant Floor Leader**

**Democrat.** Born and raised in the 49th District, Annette brings over 30 years of public and private sector knowledge to Olympia. This includes having worked as staff for two U.S. senators, five years at the Vancouver Columbian, and her current position in administration at a non-profit health organization. Annette has long been involved in her community on affordable healthcare issues and advocated for small businesses, seniors and veterans. Annette lives in Vancouver with her husband and daughter.



### CONWAY, STEVE

**Democrat.** Senator Conway was elected to the Senate in 2011 for the 29th District, having served as a State Representative since 1993. 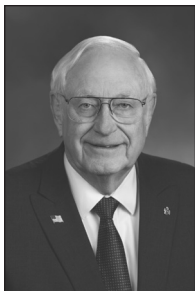

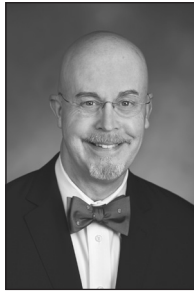

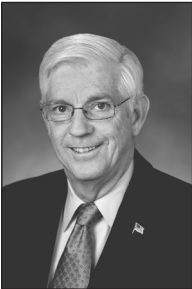
### **BUYS, VINCENT**

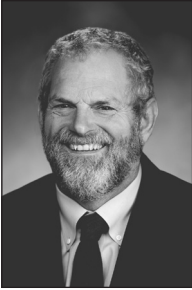

### FARRELL, JESSYN

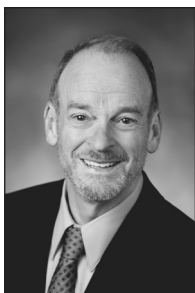
#### Deputy Majority Whip

### GRIFFEY, DAN

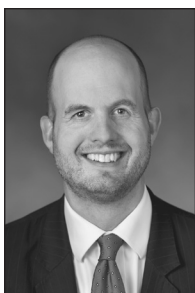
#### Assistant Republican Whip

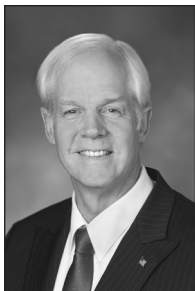
### HANSEN, DREW

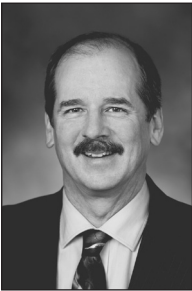

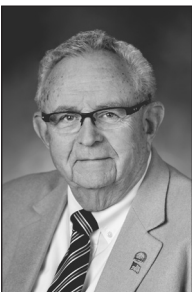
### HURST, CHRISTOPHER

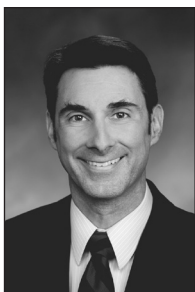
#### Deputy Speaker Pro Tempore

## How a Bill Becomes a Law

---

1. A bill may be introduced in either the Senate or House of Representatives, but the procedure by which a bill becomes a law is much the same, wherever the bill originates.  
The bill is introduced in the Senate or the House by a member, or members, of that body. After the bill is filed with the Secretary of the Senate or Chief Clerk of the House, it is given a number and, it is read the first time by title only in open session and referred to a standing committee.
2. The committee studies the bill and often holds public hearings on it. The committee will then meet to consider the information it has gathered. It may approve the bill with or without amendments, draft a new bill on the same subject incorporating the desired changes, or take no action.
3. The committee is now ready to report back to the Senate or the House. If the majority is in favor of the bill as introduced or with certain amendments, the chair recommends the bill for passage. The committee report is read in open session of the Senate or the House, and the bill is then referred to the Rules Committee.
4. After the bill has been recommended for passage by the standing committee to which it was originally referred, the Rules Committee can either place it on the second reading calendar for debate before the entire body, or take no action.
5. When the bill appears on the calendar for second reading, it is subject to amendment. It is then returned to the Rules Committee where it must receive a favorable vote before being placed on the third reading calendar for final passage. This referral to Rules is often bypassed by vote of the Senate or the House and the bill placed on final passage immediately following its second reading. Depending upon the degree of controversy, debate may last a few minutes to several hours or even several days.
6. After passing in the Senate or the House, the bill will go through an almost identical procedure in the other body.  
If the bill is passed by the other body, but is amended, the originating body must concur on the amendments. If the change in the bill is not accepted, it may be returned for reconsideration of the amendments. If the amendments are not rescinded, a conference committee may be requested on the differences.
7. If the conference committee cannot agree, a conference committee may be appointed with power to rewrite the amendment or even write an entirely new bill. When the conferees reach agreement, they report to their respective houses. Their report is either accepted or rejected without any changes.
8. If the report is accepted by both houses, the bill is signed by the President of the Senate and the Speaker of the House in open sessions of each body, and then is sent for the Governor's signature.
9. Within five days, if the Legislature is still in session, or 20 days after its adjournment, the Governor may sign the bill or veto all or any section of it. The Legislature can override the veto by a two-thirds vote of both houses. If the Governor fails to act on the bill, it becomes law without a signature.

There are nine parking locations available for visitors to the Capitol:

- 1. Visitor Information Center Parking:** Parking is available at the Visitor Information Center at 14th Avenue and Capitol Way. The charge is \$1.50 per hour. For visitor parking information at other locations on the Capitol Campus grounds, please contact the state government Campus Parking Office at (360) 725-0030.
- 2. North and South Diagonal Parking:** Located along the North and South Diagonal streets on the Capitol Campus. There is a \$1.50 per hour charge.
- 3. General Administration Building:** , located at 11th Avenue and Columbia Street. There are 35 visitor parking stalls on the west side (facing Capitol Lake) of the building. There is a \$1.50 per hour charge.
- 4. Natural Resources P1 Parking Lot:** off Washington Street is metered parking.
- 5. Professional Arts Building:** 11th Ave. and Washington St. The 48-stall lot includes a meter that accepts payment with either a debit or credit card. The cost is \$1.50 per hour. Free Dash shuttle service is also offered at this lot.
- 6. Capitol Campus Visitor Parking at Maple Park and Jefferson Street:** Parking is \$1.50 an hour.
- 7. Capitol Campus Visitor Parking at Farmers Market:** at the north end of Capitol Way (available January through March only). Parking is \$1.50 an hour. Intercity Transit's free Dash shuttle serves this lot every 12-15 minutes on weekdays, taking passengers between the Capitol Campus and downtown Olympia.
- 8. Deschutes Parkway:** Intercity Transit serves Deschutes Parkway weekdays every 15 minutes. Other bus routes operate throughout the region and serve the Olympia Transit Center where passengers can transfer to Routes 12, 13, and 68 for service to the Capitol Campus. For route and schedule information, call (360) 786-1881 or visit [www.intercitytransit.com](http://www.intercitytransit.com). The fare is \$1 for a single ride and \$2 for an all-day pass. State employees working in Thurston County ride all Intercity Transit services free with a STAR Pass. Intercity Transit also operates a free Dash Shuttle along Capital Way between the Capitol campus and downtown Olympia. Service is every 12 minutes.

**To Deschutes Parkway from I-5 Southbound:** Take exit 103 and proceed on 2nd Avenue; turn left onto the Custer Way overpass; turn right on Boston, proceed downhill to Deschutes Parkway; turn right (north) onto the Parkway and proceed to the designated parking area along Capitol Lake.

**To Deschutes Parkway from I-5 Northbound:** Take exit 103 and proceed north on Deschutes Parkway through the stop sign to the designated parking area along Capitol Lake.

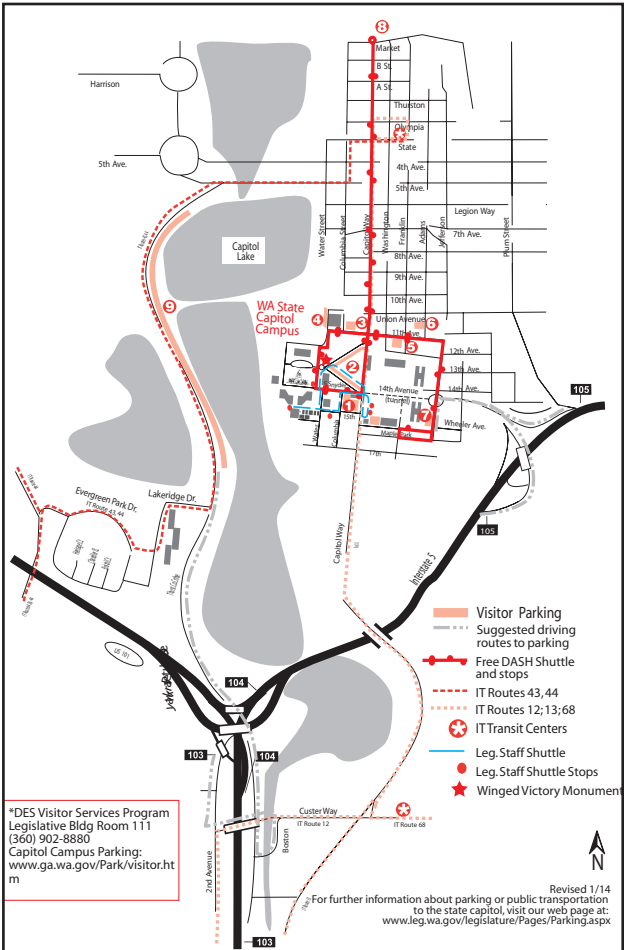
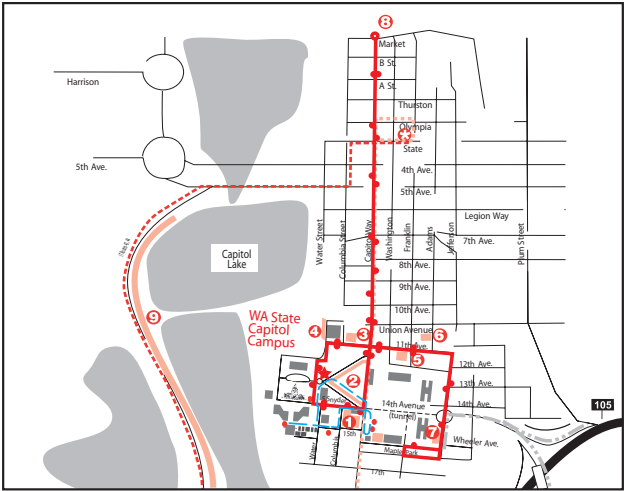

## Visitors Tour Information

---

The Department of Enterprise Services State Capitol Visitor Services Program provides general public and specialized educational tours to school groups, constituent visitors and guests, community organizations and the visiting public. The Tour Office will coordinate with the legislator's office when scheduling visiting constituent groups. When school groups are scheduled to tour the capitol during session, the Tour Office will notify legislative offices of any visiting groups from their district and reserve a time for the legislator to meet with them.

Tour requests from constituents usually come directly to the Tour Office. However, many times the request comes first to the legislator, who will then call the Tour Office with the name of the group and a contact phone number.

Free guided public tours of the Washington State Legislative Building are offered seven days a week between the hours of 10:00 a.m. – 3:00 p.m. Monday – Friday, and 11:00 a.m. – 3:00 p.m. on weekends and holidays. Tours begin every hour on the hour and are one hour in length. Public tours begin in the main entrance foyer, located just inside the main entrance doors of the Legislative Building. The Legislative Building is closed on Thanksgiving, the day after Thanksgiving, Christmas, and New Year's Day.

Free public tours of the Governor's Residence are available most Wednesdays by reservation. Morning and afternoon tours are available, but tour dates and times can vary from week to week. Maximum group size is limited to 20 and each tour lasts one hour. Photo ID is required.

Visitors are welcome to take a self-guided tour of the Legislative Building and the campus grounds. Complimentary building brochures and information about mobile tours are available at the Tour Information Desk, located in the main entrance foyer of the Legislative Building and at the Visitor Services Office located on the first floor of the Legislative Building in Room 111.

The Washington State Capitol Tour Office accepts reservations for group tours year round.
