Project Title: Emergency Management Center at Camp Murray

Project Goal:

Understand emergency management responsibilities and response including implementation of recently funded items.

Project Description:

The facility at Camp Murray serves as the state Emergency Operations Center and Washington State Emergency Management Division headquarters. By centralizing response actions in an Emergency Operations Center, the state can maximize the coordination of resources during an emergency and with homeland security initiatives. The facility serves as the central location for state responses. The state has provided funding for the implementation of several emergency response mechanisms to improve the state's preparation for and ability to respond to potential emergencies, and to enhance homeland security initiatives.

Project Title: K-12 Updates

Project Goal:

This project will update the committee on the results of the WASL taken by 10th graders in the spring, and on Washington Learns preliminary K-12 recommendations.

Project Description:

Passing the 10th grade Washington Assessment of Student Learning (WASL) or an alternative is a requirement for graduation from a public high school beginning with the class of 2008. This spring, that class has its first opportunity to take the WASL as 10th graders. The 2006 Legislature passed legislation providing for alternatives to the WASL under certain circumstances, and the 2006 supplemental operating budget provided \$28.6 million to help students who have been unsuccessful at passing one or more sections of the 10th grade WASL. The budget also provided funding to make the spring results available earlier to students so that those that failed and would like to receive assistance during the summer can do so. This project will review the preliminary state-wide results of the WASL.

Project Title: Washington Learns

Project Goal:

Review the recommendations of Washington Learns, a comprehensive study of early learning, K-12, and higher education.

Project Description:

In 2005, E2SSB 5441 established a steering committee to study and make recommendations on early learning, K-12 finance, and higher education. This effort is Washington Learns. An interim report is due in June 2006 and the final report and recommendations are due November 15, 2006. This project will monitor the progress of Washington Learns and review the preliminary recommendations, particularly those related to financing early learning, K-12, and higher education programs.

Project Title: Health Costs

Project Goal:

This project will provide information on the drivers of state-financed health costs and state efforts related to health costs and benefits.

Project Description:

Roughly one-third of the operating budget is related to health costs and health benefits. This includes medical assistance (through Medicaid and other DSHS programs) to Washington residents who meet certain criteria), and providing or funding health benefits for state employees (including higher education) and K-12 employees. This project will provide information on the drivers of state-financed health costs and state efforts related to health costs and benefits.

Project Title: IT Projects

Project Goal:

This project will review the implementation of HMRS, OMNI, and SACWIS, and review the PCHEES higher ed system.

Project Description:

There are a number of significant IT projects underway or near completion. In recent years, there have been a number of project implementation issues on important IT projects, including HRMS and OMNI. This project will review the status of:

(1) the Human Resources Management System (HRMS), which replaces the current mainframe based payroll system, supports requirements of the Personnel System Reform Act of 2002, and supports other human resource and health benefits administration;

(2) the Offender Management Network System (OMNI), which will replace the Department of Corrections' current offender tracking system;

(3) the State Automated Child Welfare Information System (SACWIS), which replaces the current system used by Children's Administration in the Department of Social and Health Services; and

(4) the Medicaid Management Information System (MMIS), which is a federally certified health care claims processing system.

In addition, this project will review the Office of Financial Management's student data information system called the Public Centralized Higher Education Enrollment System (PCHEES), how it currently is used, and potential broader uses for this system.

Project Title: Energy Initiatives Funded in 2006

Project Goal:

This project will review the implementation of energy related initiatives funded in the 2006 budget.

Project Description:

In 2006, the Legislature enacted E2SHB 2939, referred to as the Energy Freedom Program. \$23 million was provided by the operating budget for this program. This project will provide an update on the implementation of projects that are in process, particularly the project to increase green power generation in Grays Harbor County and bio-energy projects.

Project Title: State audit process

Project Goal:

This project will review the state audit process and implementation of I-900

Project Description:

The state auditor conducts financial audits of state agencies and local governments. Legislation and Initiative 900, both passed in 2005, give the auditor authorization to conduct performance audits of state agencies and local governments. Approximately \$18 million per year is earmarked for performance audits. This project will review the State Auditor's traditional audit process and how the Auditor intends to implement performance audits under I-900. The project also will review the Joint Legislative Audit and Review Committee's plan to receive state performance audits on behalf of the Legislature.

Project Title: Update on Collective Bargaining

Project Goal:

This project will provide an update on funding requests related to the collective bargaining process for the 2007-09 biennium.

Project Description:

The Personnel System Reform Act of 2002 authorized collective bargaining for certain state employees. The Governor's Labor Relations Office bargains with representatives of state employees under the provisions of the Personnel System Reform Act of 2002. The bargaining process typically takes place in the summer and early fall of even-numbered years. State law requires that for consideration by the Governor in her budget proposal, agreements must be reached by October 1st and that the Legislature either approves or rejects funding requests for the agreements included in the Governor's budget proposal. This project will provide an update on the collective bargaining process for funding requests in the 2007-09 biennium.

Project Goal:

Project Title: Implementation of the Energy Freedom Program

Project Goal:

Monitor the Department of Agriculture's implementation of the Energy Freedom Program.

Project Description:

Sections 191 and 192 of the 2006 Supplemental Capital Budget (ESSB 6384) provide \$17 million in funding to the Department of Agriculture for implementation of the Energy Freedom Program. This program provides funding for renewable energy projects including the development of biofuel oilseed crushers, supporting infrastructure, and facilities for five political subdivisions. In addition, the Department of Agriculture is authorized to award financial assistance to political subdivisions, federally recognized tribes, or state institutions of higher education on a competitive basis for projects that convert farm products or waste into electricity or fuel. This work session topic will update the Committee on implementation of the program.

Project Title: Trust Land Asset Management Strategies

Project Goal:

Discuss the Department of Natural Resources' trust land asset management strategies.

Project Description:

The Department of Natural Resources (DNR) manages a diverse portfolio of trust lands to include forest lands, agricultural lands, and commercial real estate. In the 2006 legislative session, the DNR requested additional capital budget appropriation authority for the Land Bank program to acquire properties that provide increased income or benefit to the trust beneficiaries or that could be more efficiently managed by the DNR. The Legislature has directed the University of Washington to examine the economic, recreational, and environmental trends influencing the forest products industry and secondary manufacturing sectors in Washington and the State Investment Board has been directed to study the performance of the DNR's commercial properties portfolio. This work session topic will discuss DNR's trust land asset allocation strategy, return on investment from current properties, and income goals. In addition, a progress update on the two studies will be provided to the Committee.

Project Title: Level of Service Standard for Local and Regional Park Facilities

Project Goal:

Monitor the development of a statewide recreation level of service standard for local and regional active recreation facilities by the Interagency Committee for Outdoor Recreation.

Project Description:

Section 228 of the 2006 Supplemental Capital Budget (ESSB 6384) directs the Interagency Committee for Outdoor Recreation (IAC) to develop recommendations for a statewide approach to a level of service standard for local and regional park facilities, including indicators which measure progress in achieving level of service objectives. The IAC is directed to report on level of service standards including individual participation measures, service area analysis using geographic information system tools and techniques, and recommendations to incorporate level of service reporting into its grant programs. This work session topic will provide an update to the Committee on the IAC's progress in this effort.

Project Title: Higher Education Capital Project Prioritization

Project Goal:

Section 908 of the 2005-07 Capital Budget (ESSB 6094) provides additional guidance to the Higher Education Coordinating Board and the four-year institutions in developing and submitting a single prioritized project list of capital projects to the Legislature for the 2007-09 biennium. This project will monitor the work of the HECB and the Council of Presidents to refine the methodology for determining the ranking of project requests. In addition, this project will monitor and review the work of the State Board for Community and Technical Colleges in the development of a prioritized project list for the state's two-year system.

Project Title: Decision Making Processes Used by States for Institutional Closures

Project Goal:

Review other states' decision making processes and implementation of institutional closures.

Project Description:

State institutions serve a critical role in the delivery of services to Washington citizens. Maintaining the capital needs of state institutions requires both long-term planning and financing. However, the state lacks an independent review process and an effective method of decision making for state institutions with excess capacity or with alternative service delivery models. Capital Budget staff in coordination with Senate Fiscal staff will research and report on decision making and implementation processes used in other states and by the federal government for the closure of institutions.

Project Title: Technical Review of Local Community Projects

Project Goal:

Identify local community projects funded by the Legislature but not included in existing grant, loan, or technical assistance programs and analyze whether the projects meet the programs' criteria.

Project Description:

Section 229 of the 2006 Supplemental Capital Budget (ESSB 6384) directs the Joint Legislative Audit and Review Committee (JLARC) to conduct an inventory of all state public infrastructure programs and funds. It is the intent of the Legislature to use the inventory information to identify or develop a comprehensive funding structure to support the integration, consolidation, and standardization of processes, procedures, and infrastructure programs. This project will augment the work of JLARC by identifying local community projects funded by the Legislature but not included in existing grant, loan, or technical assistance programs and analyzing whether the projects meet the programs' criteria. This information will be used to inform the Committee about potential gaps between the state's infrastructure programs and assist with potential changes to the programs.

Project Title: Best Practices for Managing the Capital Budget Process

Project Goal:

Collaborate with the Office of Financial Management on the identification and implementation of best practices in Washington's capital budget processes.

Project Description:

Section 224 of the 2006 Supplemental Budget (ESSB 6384) expands on the work of the 63-20 financing study conducted by the State Treasurer in 2005. This project involves working with OFM to identify: (1) best practices for managing capital project costs including long-term forecasting information for facility preservation, major facility or system replacement, and new capacity to result in more effective investment decisions for major public facilities and infrastructure; (2) best practices in the state's capital budgeting process and public works contracting procedures; (3) appropriate uses of alternative capital project financing; and (4) management of risk and reduction of potential claims and litigation associated with state construction projects. OFM is required to report to the Legislature by September 1, 2007.

Project Title: Services for Children with Sensory Disabilities

Project Goal:

Committee will develop recommendations regarding services for children with sensory disabilities.

Project Description:

The Committee will review and discuss information regarding: (1) Outreach activities (including collaboration with school districts, educational service districts, and community partners); (2) Current technology available to assist hard of hearing and profoundly deaf;

(3) The incidence and severity of deafness in the general population and among the Washington School for the Deaf (WSD) applicants and current students; and (4) The incidence and type of co-occurring disabilities within the student populations of the WDS and Washington School for the Blind (WSB).

Staff will conduct a literature review of studies examining service delivery models for educational services to students with sensory disabilities.

Project Goal:

The 2005-07 operating budget created a flexible family support pilot program for families caring for family members with developmental disabilities. Funding is provided for support services, including respite care, training, counseling, assistive technologies, transition services, and assistance with extraordinary expenses. The Committee will receive a report from the DSHS regarding recommendations for integrating state-funded family support programs into a single program in order to improve families' access to and understanding of program services.

ESSB 6635 (2006) directs the DOH and the DSHS to recommend an efficient means for collecting, compilation, and publishing adoption statistical data. Recommendations from the DOH are due October 1, 2006. ESSB 6635 (2006) also directs the DSHS to consult with adoption stakeholders and develop recommendations relating to: (1) Reducing barriers to adoption of children our of foster care; and (2) Accreditation standards for adoption-related service providers. Recommendations from the DSHS are due January 1, 2007.

The task force is directed to study and make recommendations regarding the growing incidence of autism and ways to improve the delivery and coordination of autism services in Washington. The task force presented an interim report in February 2005. The final report and recommendations are due December 1, 2006.

ESSB 6741 (2006) expanded the membership and extended the duration of the task force to determine the most appropriate and effective administrative structure for delivery of social and health services to the children and families of the state. The task force is directed to "study how best to ensure that an administrative structure has defined lines of responsibility for delivering services to children and families in need and the best means for the public to hold government accountable for delivery of those services." The Committee will receive the final recommendations of the task force by December 1, 2006.

Project Title: Braam Settlement Agreement Implementation

Project Goal:

Committee will receive progress reports on the implementation of the improvement plan developed pursuant to the Braam settlement agreement.

Project Description:

The Braam Oversight Panel was created in 2004 to oversee a settlement agreement regarding Washington State's foster care system. The settlement agreement was reached after a six-year period of litigation. The independent panel has responsibility, in collaboration with Washington's Department of Social and Health Services, and substantial input from plaintiffs, to develop outcomes, benchmarks and action steps as well as professional standards for the six areas identified in the settlement agreement. The Panel issues two types of reports: Implementation Plans and Progress Reports. The Panel issues progress reports every six months, reporting on the Department's progress and including specific findings on the Department's compliance with the provisions of the agreement. These reports inform the parties and the public whether conditions for Washington's youth in foster care are improving according to the agreement and within identified timeframes. The first report on progress was due February 2006; the second is due June 2006.

Project Title: Services to Adolescents

Project Goal:

Committee will receive information from the Department of Social and Health Services regarding screening and responding to referrals of child abuse and neglect involving adolescents.

Project Description:

The Legislature passed ESB 5538 (2005) requiring the Department of Social and Health Services (DHSH) to: (1) Develop staff training curriculum on screening and responding to referrals of child abuse neglect involving adolescents; (2) Conduct quarterly reviews of a sampling of screening decisions involving adolescents and use the results to improve practice and training; and (3) Report to the Legislature and Governor in August 1, 2006 and August 1, 2007. The Committee will review the staff training curriculum and the results of the quarterly reviews of screening decisions.

Project Title: Gambling Policy

Project Goal:

Examine current gambling policy and make recommendations on the future of gambling policy setting.

Project Description:

During the 2006 session the Legislature considered, but did not adopt, Substitute Senate Concurrent Resolution 8417 that would have created a Joint Select Committee on the Future of Gambling Policy Setting.

During the 2006 interim, in lieu of the Joint Select Committee, the House Commerce & Labor Committee and the Senate Labor, Commerce, Research & Development Committee will hold up to 3 joint hearings and work sessions to examine gambling policy, including the current and potential future nature and scope of legalized gambling in the state (how these forms of gambling have developed and changed over time and what are the current trends), the current and potential future tax structures relating to gambling activities in the state, the nature of problem gambling and efforts to address it in this state, and the manner in which policies on gambling have been and are established in this state.

The committees will solicit information and recommendations from the relevant state and federal agencies, tribal representatives, and private and non-profit sector stakeholders.

Project Title: Agricultural Labor

Project Goal:

Examine the supply and the demand for agricultural labor in Washington, and related issues.

Project Description:

There are approximately 31,000 seasonal agricultural workers in Washington. In 2006, however, there are concerns that the supply of agricultural labor in Washington will be insufficient to meet the demand for such labor. To address these concerns, the Employment Security Department has expanded its efforts to increase the number of growers who list jobs with WorkSource and the number of workers who apply, as well as to better match the skills of workers with the available jobs. Some growers are seeking approval through the federal H-2A visa program to bring up to 1,000 workers from Mexico to Washington.

During the 2006 interim the House Commerce & Labor Committee will participate in a possible work session to examine agricultural labor and related issues. The Committee will: (1) Examine the supply and the demand for agricultural labor in Washington; (2) learn about various elements of the agricultural labor market, including hiring workers directing, engaging farm labor contractors, and participating in the federal H-2A visa program; and (3) gather information on proposed changes to federal immigration laws and their impact on the agricultural labor market in Washington.

Project Title: Workplace Safety

Project Goal:

During the 2005 interim members of the House Commerce & Labor Committee participated in ride alongs with inspectors from the Department of Labor and Industries' Division of Occupational Safety and Health Services (formerly the WISHA Services Division).

During the 2006 interim the House Commerce & Labor Committee will follow up on issues raised during these ride alongs. The Committee will also hold a work session in which the Department of Labor and Industries will make a presentation on the following: (1) The Department's compliance and consultation activities; (2) the Department's inspection, citation, and penalty processes; (3) existing Strategic Partnership Programs and Voluntary Protection Programs; (4) related federal and state law; and (5) evolving procedures. The presentation will also include information about the underground economy's effect on workplace safety.

Project Goal:

Review proposed changes to the state law governing the licensing of real estate brokers and salespersons.

Project Description:

In December 2003 the Department of Licensing's Real Estate Program appointed a task force to study possible revisions to the law governing the licensing of real estate brokers and salespersons. Since then, the task force has been working on creating a revised draft of the law.

During the 2006 interim the House Commerce & Labor Committee will hold a work session discussing the results of the task force's work and the feedback from stakeholders on the revised draft. The Committee will consider possible legislation for the 2007 session.

During the 2006 interim the House Commerce & Labor Committee will continue to monitor various workers' compensation issues, receive related reports from the Department of Labor and Industries, and consider possible legislation for 2007. Activity will include:

(1) Monitor the status of audits of the state fund and receive any available updates. (SHB 1856, enacted in 2005, requires the Department of Labor and Industries to prepare financial statements on the state fund, accident fund, medical aid fund, and pension reserve fund. Beginning in 2006, the State Auditor's Office must conduct audits of the state fund and issue a report within six months of the end of the fiscal year. The State Auditor's Office also conducts performance audits.)

(2) Monitor implementation of SHB 2537, enacted in 2006, which requires the Department, by January 1, 2007, to develop and begin a pilot program in which employers assist workers in completing an application for benefits.

(3) Review of recent caselaw, such as the Gallo decision and the Roller decision.

(4) Review of Department decisions and any court cases on hour banks.

(5) Review of the Department's processes for making medical coverage decisions and review of the Department's involvement in the implementation of E2SHB 2575, enacted in 2006, which established the Health Technology Assessment Program.

(6) Report on implementation of SHB 1691, enacted in 2004, which authorized advanced registered nurse practitioners to examine, diagnose, and treat injured workers, and SB 6356, also enacted in 2004, which authorized physician assistants to assist workers who are filing claims for simple industrial injuries in applying for compensation. These reports are due to the House Commerce & Labor Committee by December 1, 2006.

(7) Report on benefit adjustment when retroactive social security benefit overpayments are issued by the Social Security Administration. The report is due to the House Commerce & Labor Committee by December 1, 2006 under RCW 51.32.220.

(8) Report on uses of workers' compensation funds.

Project Title: Apprenticeship and Pre-Apprenticeship Opportunities

Project Goal:

Receive reports from the Washington State Apprenticeship and Training Council and the Office of the Superintendent of Public Instruction. Monitor implementation of pre-apprenticeship pilot projects.

Project Description:

2SHB 2789, enacted in 2006, relates to apprenticeship opportunities for high school students. Under the bill, up to ten school districts will be awarded incentive grants for the 2006-07 school year for personnel to negotiate and implement direct-entry agreements with local apprenticeship programs. The incentive grants for must be awarded for the 2006-07 school year and a related report is due to the House Commerce & Labor Committee in December 2006. The bill also establishes up to four pilot projects to increase student enrollment in pre-apprenticeship programs.

2SHB 2789 also requires the Office of the Superintendent of Public Instruction to convene a workgroup to identify barriers and opportunities for further expansion of pre-apprenticeship. A second report on work done by the workgroup is due to the House Commerce & Labor Committee in December 2006.

During the 2006 interim the House Commerce & Labor Committee will monitor implementation of the direct-entry programs and pre-apprenticeship pilot projects, and will review the results of both reports.

Project Title: Task Force on Sale and Distribution of Beer and Wine

Project Goal:

Receive a report from the task force reviewing the currently regulatory system controlling the sale and distribution of beer and wine.

Project Description:

2SSB 6823 was enacted in 2006 in response to Costco Wholesale Corp v. Hoen, et al (2005), in which the United States District Court for the Western District of Washington struck down the Washington law allowing in-state, but not out-of-state, wineries and breweries to distribute their products directly to retailers. The bill allows wineries and breweries in Washington and other states to distribute wine and beer of their own production to Washington retailers until June 30, 2008. The bill also requires the Liquor Control Board to convene a task force to review the current regulatory system controlling the sale and distribution of beer and wine, and make recommendations about any proposed changes to the system by December 15, 2006.

During the 2006 interim the House Commerce & Labor Committee will monitor the task force proceedings and receive the task force report on the sale and distribution of beer and wine.

Project Title: Inmate Educational Programs & Inmate Mentally III Programs

Project Goal:

To review: 1) educational programs currently offered to inmates and 2) Washington's Dangerous Mentally III Program.

Project Description:

Inmate Education:

Prior to the passage of 2E2SHB 2010 (Chapter 10 of the laws of 1995), the Department of Corrections (DOC) contracted with nine community colleges to provide educational services for offenders at 15 correctional facilities. Instruction was offered in adult basic education, life skills training, and vocational education. Funding for offender education programs was provided primarily by state legislative appropriation and was administered by the department. Some federal funds were also used for specific education programs.

After the passage of 2E2SHB 2010, the department was required to prioritize resources for education in the following order: (1) basic academic skills through high school or GED and vocational training; (2) additional work and education programs based on assessment and placement criteria; (3) other work and education programs not related to assessment and placement criteria. Inmates with skills below 8th grade basic skills level were required to be placed in a combined work and education program. Currently, inmates are placed in appropriate programs based on placement criteria: release date; custody level, education and work skills assessment; economic circumstances, and prior performance. In addition, inmates are required to pay on a sliding scale, based on ability to pay, for the following: (1) AA or BA programs when placed by DOC and (2) second and subsequent vocational programs associated with work programs. Inmates must pay full costs or tuition for the following: post-secondary academic degree programs when not placed in the program by DOC; second and subsequent vocational programs when not associated with work programs.

The Committee, working in conjunction with the DOC and local community colleges, will review educational programs currently offered to inmates and the possibility of expanding upon having more community colleges provide educational services to prison incarcerated inmates.

Dangerous Mentally III Program:

In 2004, E2SSB 6358 was enacted relating to dangerous mentally ill offenders. The act required mental health providers, chemical dependency treatment providers, and the DOC to share records and reports with each other regarding offenders who are under supervision by the DOC and are subject to courtordered treatment. Among other requirements, the act also required the DOC and the Department of Social and Health Services (DSHS) to develop a training plan for information sharing on offenders under supervision who are subject to mental health or chemical dependency treatment orders.

The DOC and the DSHS will be invited to provide an update on the Dangerous Mentally III Offender program and to offer suggestions on how the program can be improved.

Juvenile Offender to Adult Felon:

The report will focus on a juvenile's crime, criminal history, and age, and how each of these factors affect the chance that a juvenile will re-offend as a young adult. The Task Force will be invited to provide an overview of its findings and recommendations.

Project Title: Washington Learns

Project Goal:

Consider and discuss preliminary recommendations on K-12 finance and governance from Washington Learns.

Project Description:

Legislation enacted in 2005 created a comprehensive education finance and governance review chaired by the Governor called Washington Learns. Washington Learns operates with a steering committee and three advisory committees, one each for early learning, K-12, and higher education. National consultants have been engaged to conduct a review of education finance at all three levels. Preliminary reports from the K-12 consultants should be available by mid-June, with preliminary recommendations of the K-12 advisory committee due to the steering committee in July. Policy and fiscal recommendations from the overall Washington Learns effort will be before the 2007 Legislature for consideration. The House Education Committee has not yet had an opportunity to interact with the consultants or the non-legislative members of the K-12 advisory committee. This meeting will provide an in-depth orientation to the research, methods, findings, and preliminary recommendations from the review as well as discussion among members of the Education Committee and the advisory committee.

Project Title: Alternative Assessments

Project Goal:

Review and provide input on the Superintendent of Public Instruction's proposed guidelines, protocols, and scoring criteria for alternative assessments to the WASL. Review the State Board of Education's approval decision for implementation of the collection of evidence alternative method.

Project Description:

Legislation enacted in 2006 (ESSB 6475) authorized the Superintendent of Public Instruction to develop and implement several alternative assessments that eligible students may use for high school graduation purposes instead of the Washington Assessment of Student Learning. The legislation directed SPI to make an in-depth report to the Education Committees of the Legislature by September 2006 on the guidelines, protocols, and scoring criteria for the alternatives; field tests of the alternatives being conducted in the spring and summer of 2006; and an updated estimate of the number of students likely to pursue one of the alternatives. One of the alternatives is a collection of work samples submitted by students as evidence that they meet state standards (collection of evidence). The legislation stipulated that the collection can only be implemented after approval by the State Board of Education. This decision is expected by December 1, 2006. In September, members of the Education Committee will have an opportunity to review the information prepared by the SPI for submittal to the State Board; in December, the Committee will receive a briefing on the State Board's decision and an additional status update from SPI.

Project Title: WASL Remediation

Project Goal:

Examine preliminary information about schools districts' use of supplemental funding for WASL remediation from the Promoting Academic Success Program.

Project Description:

The 2006 supplemental budget provided \$27.9 million for the Promoting Academic Success Program to provide remedial extended learning opportunities for students not successful on the high school WASL. The budget also directed the Washington State Institute for Public Policy to perform a quantitative analysis of the effectiveness of the remedial programs. Although outcomes information will not be available until the Institute's final report in December 2007, a December 2006 interim report should provide information about the remedial strategies school districts are using and the number of participating students, as well as the research methods proposed to examine program effectiveness. The OSPI will also provide preliminary information on school districts' use of special instructional modules developed by OSPI for WASL remediation.

Project Title: Standards, Instruction, Curriculum, and Assessment of Mathematics

Project Goal:

Examine current issues regarding the state of mathematics standards, instruction, curriculum, and assessment in Washington.

Project Description:

Although 70 to 80 percent of students are meeting state standards on the WASL in reading, and 58 to 65 percent in writing, student scores in mathematics continue to lag. In particular, fewer than half of 10th grade students met the standard in 2005. Students who take the WASL in 2006 will be required to pass all three sections before they graduate from high school. The 2006 supplemental budget provided funding for a variety of mathematics initiatives. However, questions remain about the state of mathematics standards, instruction, curriculum, and assessment in Washington. Do Washington's standards focus on the most essential skills and knowledge? How can mathematics instruction be improved? What are current issues and controversies about mathematics curriculum? How does the mathematics WASL compare to other mathematics assessments? During the 2006 Interim, the Education Committee will gather and examine information about each of these aspects of mathematics and convene a work session to hear expert testimony on these issues.

Project Title: Partnerships to Address the Achievement Gap

Project Goal:

Examine the research literature and best practices for parent and community involvement with schools to address the achievement gap for students.

Project Description:

Much of the research literature on closing the achievement gap focuses on strategies that are successful in improving the achievement of all students; other research literature focuses on the unique social and cultural needs of certain groups of students. The 2006 supplemental budget provided \$500,000 for SPI to award five grants to parent, community, and school district partnerships to meet the unique needs of different groups of students in closing the achievement gap. Committee staff will prepare a review of the literature on strategies to address the achievement gap and summarize policies proposed or used by other states (including Washington) in an attempt to close the gap. During the 2007 Legislative Session, partnership grant recipients will be invited to make presentations on their strategies.

Project Title: Instruction, Assessment, and Educational Opportunities for English Language Learners

Project Goal:

Examine the research literature, best practices, and strategies used by other states to improve instruction, assessment, and other educational opportunities for English Language Learners

Project Description:

Although Washington students are showing overall gains in academic achievement, the WASL scores of English Language Learners or ELL students significantly lag their peers. Fewer than half of 4th grade ELL students passed the Reading WASL and only one-fourth passed Mathematics. Test scores decline dramatically for older students, many of whom are recent arrivals to this country or to the education system. Fewer than 30 percent of 10th grade ELL students passed Reading and only 12 percent passed Mathematics. Successful approaches for educating ELL students vary depending on a number of factors: the number of students needing extra services, the number of different languages spoken, age and educational background of students. The 2006 Legislature directed the Superintendent of Public Instruction to examine the feasibility of offering the mathematics WASL in languages other than English. The Education Committee will examine best practices in delivering instruction, assessment, and other educational opportunities for ELL students, particularly for older students.

Project Title: Accountability and Goals for Improving Student Achievement

Project Goal:

Examine the current status of state and federal goals and accountability mechanisms for improving student achievement and identify options for alternatives for Washington.

The federal No Child Left Behind Act of 2001 established expectations for states to set goals for improving student achievement and required certain actions to be taken to hold schools and school districts accountable for reaching their goals, as long as these actions are authorized under state law. The Washington Legislature created the Academic Achievement and Accountability Commission in 1999 to develop a state accountability system. Various accountability schemes have been proposed, but not enacted. In 2005, the A+ Commission was eliminated and its duties assigned to a newly reconstituted State Board of Education which begins its work in 2006. As the new State Board considers its charge and duties, the Education Committee will also re-examine the current status of goals and accountability mechanisms and plan to meet with the members of the State Board early in the 2007 legislative session for a discussion of these issues.

Project Title: Wrongful Conviction Compensation

Project Goal:

Develop an appropriate mechanism for providing compensation for persons who are wrongfully convicted and incarcerated.

Project Description:

HB 3254 and SB 6692, introduced last session, would have created compensation statutes for persons wrongfully convicted and incarcerated. Congress and numerous states have enacted wrongful conviction compensation statutes. The statutes vary widely in terms of eligibility, procedural requirements, monetary limits, and statute of limitations. The Innocence Project, a nonprofit legal clinic that represents defendants whose postconviction DNA evidence can be used to overturn their convictions, has drafted a model compensation statute. The Committee will examine wrongful conviction compensation statutes from other states and determine whether and to what extent such a statute is needed in Washington. The Committee will have one public hearing/work session to discuss the issue and potential draft legislation creating a wrongful conviction compensation statute for Washington.

Project Goal:

Examine certain issues relating to the exercise of the power of eminent domain and consider possible legislation for the 2007 session.

Project Description:

The Committee will examine certain issues relating to the taking of private property through the exercise of the power of eminent domain. The use of eminent domain to take private property has recently been the subject of intense interest in the Legislatures of most states. Several bills relating to eminent domain were introduced and considered in the Washington Legislature last session. Much of this recent interest was generated by a U.S. Supreme Court case that upheld the condemnation of private property in Connecticut for uses that arguably would not be permissible in Washington State. None of the eminent domain legislation introduced in Washington last session passed.

The Committee will examine three issues relating to eminent domain that have emerged as areas of concern in this state. The first issue relates to notice requirements when property is going to be condemned. A recent Washington Supreme Court decision upheld the use of Internet postings as adequate notice. The Committee will consider requiring enhanced and uniform standards for giving notice to property owners when a condemning authority is planning to exercise the power of eminent domain. The second issue relates to property that has been condemned for a public use, but is either never actually put to that use or is put to that use only for a short time. The Committee will consider providing some rights for the prior owner regarding possible reacquisition of the condemned property in such circumstances. The third issue relates to the justification a condemning authority must show before using the power of eminent domain. The Committee will consider requiring condemning authorities to demonstrate that a proposed condemnation is necessary and that any reasonable alternatives to the condemnation have been considered.

The Committee will conduct a public hearing/work session in December to consider these issues as well as any proposed legislation that results from the Committee's work during the interim.

Project Title: Federal Process for Certification of Election Systems

Voting systems, voting devices, and vote tallying systems must be certified and approved by the Secretary of State before they can be used or sold in the state. One of the stipulations for certification in this state was that the equipment be used in another state. Legislation passed in 2006 removed this requirement, and made it mandatory that any equipment used in Washington state must be tested and certified by the U.S. Election Assistance Commission. Under the federal certification process, vendors of voting equipment must submit hardware, firmware, and software to an Independent Testing Authority (ITA) for evaluation against the updated voting system standards required by the Help America Vote Act.

In the public hearing on the bill, concerns were raised regarding security issues related to ITA evaluations. The work session will provide the members with detailed information on the standards and testing process.

Identify and discuss any challenges discovered by the Secretary of State's Office and others in identifying and tracking ex-felons for voter registration purposes. Project Title: Open Public Records Act

Project Goal:

Review of the open public records act and discussion of exemptions from disclosure and privacy

Project Description:

Exemptions:

In 1972, voters approved Initiative 276. Among other things, the initiative required a positive duty for a public agency to disclose public records unless they fall within specific exemptions. At the time the initiative was passed, there were 10 exemptions from disclosure. Currently, there are several hundred exemptions. Many are contained in a specific chapter of statute, but many more are spread throughout the statute. Each year, the State Government Operations and Accountability Committee considers many new exemptions.

Privacy:

In 2005, legislation passed that recodified the exemptions in chapter 42.17 RCW into a new chapter of statute, 42.56 RCW. In 2006, legislation was introduced that cross-referenced all exemptions contained in other statutes into 42.56 RCW. That legislation also stipulated that exemptions not contained or cross-referenced in 42.56 RCW are not exemptions.

Also in 2006, the Committee considered HB 2750 and HB 2831. HB 2750 prohibited county auditors from publicly disclosing or otherwise allowing public access to federal social security numbers (SSN), unless the individual to whom the SSN is assigned gives his or her express written consent to disclose the number or unless disclosure is requested by a federal, state, or local agency. A fee of \$1 per document would have been charged by the auditors for each recorded document to assist with the costs associated with the bill. The fiscal impact of the bill was indeterminate, but Snohomish County alone estimated that it would cost approximately \$1.3 million to create such a system, which included over 66,000 staff hours to review affected records. It was estimated that the \$1 per document surcharge would have raised approximately \$250,000 in revenue annually.

HB 2831 prohibited the use of any list obtained from any state or local government agency for commercial purposes, or for any type of solicitation, by or on behalf of nonprofit or charitable organizations. The prohibition would apply whether or not the list was obtained as a result of a public records request and whether the request was made directly by the person himself or herself or by another person. Any person who knowingly violated the prohibition, or who induced another to do so, would be guilty of a gross misdemeanor.

The Committee will look at the need to reduce the numbers of exemptions as well as the need to address privacy issues and identity theft associated with disclosure of public documents.

Project Title: Smart Buy

Project Goal:

Review the progress of the Smart Buy Program

Project Description:

The Smart Buy Program was instituted in 2005 to identify ways to achieve the best value for purchases and to take advantage of savings opportunities. The program establishes new state contracts for purchased goods and services. Team leaders from various state agencies establish appropriate award considerations, including quality, service and price. Vendors are then asked to submit contract proposals in these categories. Established contracts will be monitored to track use, measure savings and to determine where other contracts might be developed. Currently, seven contract categories have been established. They include: office equipment; information technology; office supplies; fuel; leasing; legal data services; and PC hardware. The Committee will be briefed on identified savings and use of the contracts by state agencies.

Project Title: Washington Management Service

Project Goal:

Review of Washington Management Service including an update on the numbers of employees in the program and the definition of "manager" under the program.

Project Description:

The Washington Management Service (WMS) was established in 1993 as a separate personnel system for management positions within the executive branch of state government. Its statutory purpose is to develop and maintain a professional managerial workforce and to provide agencies with increased flexibility for their management positions in the areas of hiring and setting compensation.

The WMS applies to classified management positions in the state's civil service system. According to the Joint Legislative Audit and Review Committee (JLARC) Report 02-2, as of July 2001, there were approximately 5,000 employees in the WMS, which was just less than 9 percent of the total Merit System 1 workforce of approximately 57,000. WMS managers are prohibited from belonging to a collective bargaining unit.

There have been on-going discussions among stakeholders and legislators regarding the rate of growth of the WMS relative to non-WMS positions and the WMS definition of manager.

This meeting will provide the members with an update of the numbers of employees in the WMS and its growth rate over the past several years.

Project Title: Review of election measures passed in 2006 session

Project Goal:

Evaluate the effectiveness of the changes made to election laws

Project Description:

During the 2006 legislative session, several bills were enacted making changes to elections laws. These provisions include: 1) requiring that in-person disability access voting be available 20 days before an election and end on the day of the election; 2) requiring county auditors to establish an advisory committee to improve election accessibility; 3) requiring county auditors to contact a voter by telephone and by certified mail for a missing or mismatched signature on an absentee or provisional ballot if the ballot is received within three business days of the final meeting of the canvassing board; 4) removing the option for an elector to transfer his or her voter registration within 15 days of an election; and 5) challenging voter registrations.

County auditors and the Secretary of State will report on the implementation of the new laws and will discuss any problems associated with implementation.

Project Title: Providing election materials in languages other than English

Project Goal:

Determine the bilingual voting assistance capabilities that counties can offer in the event that bilingual assistance provisions of the federal Voting Rights Act are not renewed.

Project Description:

During the 2006 Legislative Session, the Committee considered HB 2594, Bilingual Voting Assistance. Section 203 of the Voting Rights Act requires a state or political subdivision to provide registration or voting notices, forms, instructions, assistance, or other materials relating to the electoral process, including ballots, in the language of an applicable minority group as well as in English. This law applies if more than 10,000 or over 5 percent of the total voting age citizens in a county are members of a single minority language group and are limited in English proficiency. In Washington, four counties are required to provide voting materials in additional languages: Adams, Franklin, and Yakima counties must provide materials in Spanish, and King County must provide materials in Chinese. The provisions of section 203 expire in 2007.

The original bill required that county auditors must provide bilingual voting materials for any language group in the county in which more than 3.75 percent of the voting age citizens belong to a single language minority community and have limited English abilities; or more than 7,500 voting-age citizens belong to a single language community and have limited English abilities and the illiteracy rate of the citizens in the language group is higher than the national illiteracy rate. However, testimony indicated that it would be impossible to determine these numbers because the census does not gather information relating to language minorities based on voting ages.

The substitute bill established a task force to identify ways to increase voter participation by single language minority groups. The bill passed the House, but did not pass the Senate.

A work group of up to six members will convene a meeting with county auditors, election officials from the Office of the Secretary of State and stakeholders to discuss how to implement the requirements of section 203 of the Voting Rights Act within the state; identify ways to increase voter participation by single-language minority groups who do not speak or understand English adequately enough to participate in the electoral process; and to recommend parameters for providing languages other than English on voting and election materials.

Project Title: Genetically Engineered Organisms (GEOs)

While the agricultural use of genetically engineered organisms (GEOs) has attracted significant attention, there are other sectors where GEOs are being used such as medical genetic engineering, pharmaceutical development and production, energy and industrial biotechnology.

The Committee will hold a work session to consider the impact of GEOs, what issues related to GEOs are under state control and what a state policy would look like. The Committee will look at the role GEOs may play in optimizing through breeding and genetic modification production of biomass as an energy crop. Other GEO related issues may include plant research, GEO setbacks from other crops, consumer safety, public health and environmental quality. Project Title: National Energy Policy Act of 2005

Project Goal:

Review provisions of the federal Energy Policy Act of 2005 and recommend potential legislation to address issues important to Washington.

Project Description:

The federal Energy Policy Act of 2005 (Act) represents the first comprehensive national energy legislation in 13 years. The full impact of the Act upon the states is not yet fully understood. It is anticipated that state policy-makers may either help implement or respond to changes brought on by the passage of this major piece of legislation.

The Committee will consider the following provisions of the Energy Policy Act of 2005: National Interest Electric Transmission Corridors; Reliability Standards; Repeal of the Public Utility Holding Company Act (PUHCA) of 1935; Public Utility Regulatory Policies Act (PURPA); Siting of Liquefied Natural Gas Terminals; Energy Efficiency; and Renewable Energy.

The Committee will review key provisions and make recommendations for further state actions to implement the Energy Policy Act.

Project Title: Renewable Energy Standardized Definition

Project Goal:

Develop a standard definition of renewable energy and develop legislation to ensure state law refers to this definition.

Project Description:

Currently, in the Revised Code of Washington, a common definition does not exist for renewable energy. During the 2006 session, a number of energy-related bills sought to provide a definition of renewable energy that could be used as a standard.

The Committee will examine current definitions used in Washington state law and develop a standard definition for use throughout the Revised Code of Washington.

Project Title: Integrated Resource Planning

Project Goal:

Review electric utility efforts to develop Integrated Resource Plans or Resource Plans.

Project Description:

During the 2006 session the legislature passed and the governor signed into law HB 1010. HB 1010 specifies how certain utilities with more than 25,000 customers and not full requirements customers of the Bonneville Power Administration must integrate into demand forecasts and resource evaluations descriptions of the mix of resources and efficiency measures that will meet current and future needs at the lowest reasonable cost to the utility and ratepayers. Also, HB 1010 requires all other utilities to submit a Resource Plan to the Department of Community, Trade and Economic Development.

The Committee will continue discussions with interested parties, stakeholders, and agency representatives on this issue. Committee work may include briefings from the Department of Community, Trade, and Economic Development, the Washington Utilities and Transportation Commission, and the Northwest Power Planning Council. The Committee will consider how information generated by energy forecast reporting requirements in HB 1010 may inform the development of a Renewable Portfolio Standard.

Project Title: Oil and Gas Exploration and Development

Project Goal:

Study issues related to oil and gas exploration and development.

Project Description:

Recent high prices and increased demand for oil and natural gas have renewed interest in natural gas exploration in Washington. Parts of the state show promise for reserves of natural gas. Also, recent auctions of oil and gas exploration rights on state trust lands suggests that drilling activities may increase. Current state law and administrative code lacks a comprehensive regulatory approach to oil and gas exploration, development and compliance. This could place Washington at a disadvantage in ensuring environmental protection and realizing appropriate economic benefits from this activity.

The Committee will evaluate oil and gas program funding and adequacy, oil and gas exploration, the potential of coal bed methane extraction and other relevant issues. The study will include recommendations to improve the regulatory, technical, environmental, and financial framework of the oil and gas industry in the Washington. The study will examine related existing state code and infrastructure needs that will support this sector.

Project Title: Interconnection Standardization

Project Goal:

Monitor progress implementing interconnection standards for generating facilities under 25 kilowatts and developing standards for generating facilities in the 26 kilowatts to 100 kilowatts range.

Project Description:

In early 2006, the Utilities and Transportation Commission finalized its process to adopt rules for how customer-owned generation facilities under 25 kW may connect to electric delivery systems. The Committee will monitor and discuss UTC efforts to develop interconnection standards for generating facilities in the 26kW to 100 kW range.

The Committee will continue discussions with interested parties and stakeholders on this issue. Committee work may include briefings from the Department of Labor and Industries and the Department of Community, Trade, and Economic Development.

Utilities will be asked to report on how the existing interconnection standard is being used, how many projects are occurring per year, and to briefly assess the successes and challenges of implementing current interconnection standards.

Project Title: Interoperability

Project Goal:

Examine the challenges of transitioning from current agency-based public safety radio systems to a standards-based, frequency-independent, multiple subsystems technology architecture.

Project Description:

During the 2006 session, the Committee considered HB 3095, which required a statewide public safety communications system to be built by June 30, 2012. This system must have a number of features such as a centrally managed system of system architectures that may be able to facilitate the sharing of assets between state and local governments and the ability for non-state agencies to be able to interconnect their radio systems with the state's radio over internet protocol-based interoperability system.

The Committee will continue discussions with interested parties and stakeholders on interoperability issues, including how to plan for the transition of the current agency-based public safety radio systems to a standards-based, frequency-independent, multiple subsystems technology architecture.

Project Title: Telecommunication Infrastructure Development in Rural Areas

Project Goal:

Examine potential tax incentives to encourage the building of telecommunication infrastructure in rural areas.

Project Description:

During the 2006 session, the TEC Committee considered HB 2631, which created a tax exemption for equipment or infrastructure used in the sale of telecommunications or internet services. Tax incentives found like HB 2631 may encourage the construction of advanced telecommunications into rural areas.

The TEC Committee will continue to explore various tax incentives in order to encourage the build-out of telecommunications infrastructure in rural areas.

Project Goal:

Develop guiding principles to protect individual personal information when state government adopts new technologies.

Project Description:

The electronic age poses numerous challenges to the citizens of Washington state, such as how to secure one's personal information, how to conduct business safely over the Internet, and how to remain safe from cyber-criminals. During the 2006 session, the TEC Committee considered bills related to electronic privacy. The Committee also held a work session in 2005 on the use of Radio Frequency Identification (RFID).

The Committee will continue to explore issues related to electronic privacy. This committee will develop an "Electronic Bill of Rights," which would outline general principles that a citizen can expect government to adhere to when adopting a new technology with respect to protecting an individual's personal information. These principles will be used to develop legislation for the 2007 legislative session.

Project Title: Internet and Consumer Protection

Project Goal:

Examine enforcement of the Computer Spyware Act and determine whether additional legislation is needed.

Project Description:

In 2005, the Legislature passed the Computer Spyware Act, as well as an anti-phishing law. In January of 2006, the Washington Attorney General filed his first lawsuit under the state's new computer spyware law. The lawsuit and a similar suit brought by Microsoft were the result of parallel investigations by experts at Microsoft and the Attorney General's High-Tech Fraud Unit.

The Committee will continue discussions with interested parties and stakeholders on these issues, and related issues, including identity theft, emerging technologies, e-commerce, etc. Committee work may include briefings from industry groups and the Attorney General's Office. The Committee will monitor the outcome of the state's first lawsuit under the Computer Spyware Act and determine whether further legislation is needed.

Project Title: Communications and Emerging Technologies

Project Goal:

Examine the current status of communications and emerging technologies and develop appropriate legislative response.

Project Description:

During the 2005 session, the Committee reviewed HB 2161, which proposed a legislative task force to study telecommunications and information technology. There are a number of current issues related to the classification, taxation, and regulation of emerging telecommunications technologies, including Voice over Internet Protocol (VoIP) and broadband. The FCC, federal courts, and the states have been involved in proceedings related to the regulatory status of emerging technologies. Some states have also begun to explore related issues and/or to enact legislation directed at restricting or prohibiting local governments from offering broadband services.

The Committee will examine the current status of these issues and the role of the state. The Committee may consider issues related to: taxation of telecommunications, cable, and internet services; sales taxes as related to online commerce; taxes on radio and television advertising; taxes on satellite services; use of public rights of way; the impact of these taxes on the revenue needs of local governments; and the impact of changing technologies and universal service policies.

The Committee will also monitor developments at the federal level, including potential revisions to the 1996 Telecom Act. The Committee will monitor federal activities related to the Telecommunication Act of 1996 and whether it will be updated.

The Committee will monitor efforts by the E911 Committee to develop emergency communications via VoIP.

Committee work will include briefings from representatives of the telecommunications and information industries, consumer groups, local government, the Washington Utilities and Transportation Commission, and the Department of Information Services.

Project Title: Interstate Electrical Transmission Siting Compact

Project Goal:

Monitor regional, multi-state efforts to develop model legislation that would create an interstate compact with jurisdiction over national interest electric transmission corridors.

During the 2006 session, the Committee considered HB 2401, which called for the creation of a task force to negotiation the terms of an interstate compact to assert jurisdiction over national interest electric transmission corridors satisfactory to provisions of the federal Energy Act Policy Act of 2005. HB 2401 instructed the task force to ensure the compact reflects as close as possible the Washington State Energy Facilities Siting Evaluation Council model and its procedures to ensure appropriate adjudicative proceedings and mitigation of environmental impacts.

The Committee will monitor activities to develop model compact legislation through processes established by the Pacific Northwest Economic Region (PNWER).
