Getting Your Driver License



Two Pathways to Getting Your Driver License

The Intermediate Driver License Path for 16-17 Year Olds (Enacted in 2001)

The Unrestricted License Path for 18+ Year Olds

Intermediate License Requirements

Be at least 15 years old and get an instruction permit.

Complete at least 50 hours of driving practice (including 10 hours at night) with an experienced driver.

Pass a Traffic Safety Education (TSE) course.

Have your Instruction Permit for at least 6 months.

No alcohol or drug offenses while holding the Instruction Permit.

Pass the knowledge (written) test and driving skills test at any driver training and testing location. *HB* 1635

Get your license at a driver licensing office or online.



Rules for 16-17 Year Old Drivers



Passenger Restrictions for Non-Family

- First 6 months: No passengers under 20 years old, except for immediate family members.
- Next 6 months: No more than 3 passengers under 20 years old who aren't immediate family members.

Night Driving Restrictions for the First 12 Months

• No driving between 1 a.m. and 5 a.m. for the first 12 months unless you're with a licensed driver 25 years.

No Use of Wireless Devices

Restrictions Expire After the Driver Turns 18 Years Old

18 And Over License Requirements





Pass the knowledge (written) test at a driver training and testing location.



Apply for an instruction permit if you plan to practice driving.

Instruction permit not required to test.



Pass the driving test at a driver training and testing location.



No restrictions and no education requirements.



Prior to 2002

OSPI set curriculum standards and annually approved all programs. DOL also licensed private schools and instructors.

2002

Legislature moved private driver training school oversight from OSPI to DOL (ESHB 2560).

2011

Legislature enacted ESHB 1635. This allows both knowledge and skills exams to be conducted by the training school itself (public school or private program).


Today

DOL continues to provide testing at 11 licensing offices and contracts with 330 schools.

Education Trends



Private Driver Training Schools Educate Most Young Drivers Enrolled in Traffic Safety Education



2013 Calendar Year



A Driver Training School submits an application and pays a \$500 fee to DOL.

All instructors must have 100 hours of training (40 hours classroom, 40 behind-the-wheel, 20 BTW supervised instruction) and pass both a knowledge and skills test.

DOL inspects the school, approves the curriculum, and issues the license.

Required Curriculum Topics





Curriculum Requirements



DOL adopted the Washington Risk Prevention Student Curriculum (WRPC) based on national standards.

Private driver training school curriculum must align with these requirements.
DOL approves and audits for compliance.



Education Program Requirements



A total of 30 hours of classroom instruction (max 2 hours per day).

National standard is 45 hours.

A minimum of 6 hours of practice driving (max 1 hour per day).

National standard is 10 hours.

At least 1 hour observing another driver behind the wheel.

Important Instructional Standards





Students in a classroom session must be on the same lesson. Open enrollment or self-paced instruction is not permitted.



Classroom and behind the wheel instruction in a course must be contiguous.



Classroom and behind the wheel instruction is complementary and integrated.
