PURPOSE

The principle objective of this project is to improve the utility and minimize the cost of state-level transportation plans, and to clarify responsibility for their preparation.

Transportation Budget

The legislature has directed the Joint Transportation Committee (JTC) to "Evaluate the preparation of state-level transportation plans. The evaluation must include a review of federal planning requirements, the Washington Transportation Plan and statewide modal plan requirements, and transportation plan requirements for regional and local entities. The evaluation must make recommendations concerning the appropriate responsibilities for preparation of plans, methods to develop plans more efficiently, and the utility of statewide planning documents. (ESSB 6381,Section 204, (7)(210)

 Transportation Commission separately
- Highlighted need to clarify relationships among the Washington
 Transportation Plan, WSDOT's multi-modal and mode plans, corridor plans,
 and Regional Transportation Planning Organizations (RTPOs) and
 Metropolitan Planning Organizations (MPOs)

- What legislation should be considered to modify requirements and assign responsibility?
- What are the financial impacts of proposed modifications?

Task 6. Review other state planning efforts

• Identify and analyze states that have a similar organizational structure, effective transportation planning, and are successful in receiving federal support

Task 7. Review federal initiatives

- Requirements for data driven and outcome planning
- Relationship of planning to investment decisions

Task 8. Recommend state-level plans

- Essential plans: schedule, vertical integration, links to investment decisions and performance reporting, and legislative review
- Desirable plans: schedule
- Planning that should no longer be required or plans that should be consolidated

Task 9. Responsibility

- Agencies that should be responsible for the essential & desirable plans
- Coordination requirements
- Plan review

Task 10. Draft legislation

Draft bill for consideration

Task 11. Financial impact

- Operating and capital costs impact over 16-year plan period
- Budget allocation or re-allocation
