2:09- Terry Bergeson, Superintendent of Public Instruction- Introduction of amendment on revising hour requirements from 1,155 to 1,080 hours for instructional program of basic education program in grades 7–12. Motion adopted.

- 2:27- Bette Hyde, Bremerton School District- Proposal of amendment to change proposed definition of middle school from grades 7–8 to grades 6–8. Motion deferred.
- 2:34- Bette Hyde- Proposal of amendment to include students in institutions and residential programs in definition of basic education. Motion adopted.
- 2:37- Representative Skip Priest, 30th Legislative District- Proposal of amendment to make Learning Improvement Days (allocations for professional development) available to classified staff serving in an instructional capacity. Motion adopted.

- 4:20- Terry Bergeson- Proposal of amendment to increase custodial and maintenance funding ratio for districts. Motion adopted.
- 4:33- Terry Bergeson- Proposal of amendment to increase allocations to high school by 0.5 FTE guidance counselors, amended by Representative Fred Jarrett, 41st Legislative District, to add 0.5 FTE guidance counselors to the existing line item of 1.0 FTE in the proposed model. Amendment adopted. Motion as amended rejected, subsequently re-tallied and adopted.
- 4:49- Terry Bergeson- Proposal of amendment to maintain Learning Assistant Program (LAP) and English Language Learners (ELL) as categorical programs in the proposed report of recommendations. Motion deferred.
- 4:54- Representative Skip Priest- Proposal of amendment to include early learning programs in the definition of basic education and allocate funds to districts to either run or contract programs. Motion adopted.
