

The data presented on the following slides is from the National Center for Disease Control(CDC), Washington State Department of Health (DOH), and the Division of Developmental Disabilities(DDD).

- Methodology: The data is extracted from the DOH website and merged with the DDD data.
- The CDC codes for cause of death are listed on the CDC website.
- The major categories and sub-categories are provided by the DOH.
- The merging of the DOH data along with the ICD 10 codes from the CDC allows an in depth analysis of the causes of death.





#### Percentage of Deaths by Residence Type - Based on Client Demographics






#### Percentage of Deaths by Residence Type - Based on Client Demographics
