## Lodging Tax VISION for Culture

Last year, SB 6638 made a mid-course correction to create a thoughtful plan to restructure *existing resources* to set culture on a stable path.

It reorganizes current funding for arts and heritage and allocates only a third of future available lodging tax revenues for arts and heritage.

SB6638 utilizes no new tax revenues and no tax increases.
