The question was asked of the cabinet agencies, statewide elected officials and institutions of higher education whether they knew of any contracts in FY02, FY03 or FY04 in which all or part of the work was being performed outside the United States. The information from agencies, offices and institutions that reported work performed outside the United States is below. Most agencies, offices and institutions do not keep detailed records that would indicate the contractor's place of operations (as compared to their "point of contact"), the contractor's subcontractors and their place of operations, or the location of the individuals performing the work. The reporting for this data call was handled by searching records and contract manager/project manager knowledge to provide as much information as possible. There may, or may not, be additional work being performed outside the United States which is not reflected in the records that were examined.
