I had sent an email encouraging you to propose a cola and catch-up cola that would keep more retirees off of MEDICAID, supply enough money so plan 1 retirees don't have to decide wether they should buy food or prescriptions to stay alive. On Medicaid all their medicines are paid for, rent is paid, all by the Washington State Dept. of Health. If you had stood behind the colas for the last few years they would be off of Medicaid and be relying on their retirement we were promised when we retired. The average payments for retirees are \$22,000 a year. That is at or below poverty levels. Last I heard people drawing unemployment are drawing any where from \$31000 to \$62000 a year to sit on their butts. The can buy food and also be covered by the Washington Health care system. Retirees are at the bottom of the barrel. Isn't it about time for a catch-up cola?

Just this past year the federal government determined that the cost of living was 5.4%. Past years it was at 3% for the last 11-12 years.

We are now about 30-35% in cola raises, which means our spending is down that 30-35%.

A 5.4% plus 20% catch-up would be a tremendous help.
