## **WORK SESSION:**

**David Pringle, Staff**: Review of the Pension Funding Council's tasks and work process. The pension funding contribution rates recommendation from the Select Committee on Pension Policy was forwarded to the Pension Funding Council on July 23. In even numbered years the Council shall adopt or make changes to the contribution rates for the state retirement systems no later than July 31.

**Matt Smith, State Actuary**: Review of proposed contribution rates by the State Actuary. Review of the results of the latest actuarial evaluation as of June 30, 2011. Review the performance of state retirement plans. Review of the two rate contribution options before the Council today.
