Agriculture Workplan Summary - Interim 2003

Project: Development of a Livestock Nutrient Management Program that Achieves

Compliance with new Federal Clean Water Act Rules and State Water Quality Laws

Completion Date: December 1, 2003 Staff: Bob Lee

Description: Federal rules were adopted by the Environmental Protection Agency on February 12, 2003, which

expanded the requirements that concentrated livestock feeding operations must meet to protect surface waters under the federal Clean Water Act. In addition to protecting surface waters, the State of Washington's water quality laws also require the protection of ground waters. Currently, large beef feedlots operations, and all dairy farms under the 1998 Dairy Nutrient Management Act, have specific regulatory requirements that assure compliance with water quality laws. Specific requirements of the new federal rules are established for large, medium and small concentrated animal feeding operations. Legislation was enacted in 2003 establishing a broad-based work group to develop specific legislation for a state administered program, including funding, for all segments of the livestock industry including beef cattle and poultry that meet the requirements of federal rules and state laws. This recommended legislation and funding is to be submitted to the 2004 session.

Project: Examining Protections Available to Seed Producers to Reduce the Risk of Non-

payment to Producers Who Sell or Consign Crops to Seed Processing Companies

Description: Currently, seed processing companies are required to be licensed and bonded by the state. This

program is intended to provide a degree of assurance that the seed processing company has sufficient financial assets to reduce the likelihood and seriousness of losses to farmers should the company fail financially. A recent bankruptcy of a large seed processing company has resulted in significant losses to seed producers. There are various mechanisms which provide an increased possibility that producers who convey title when delivering seed to processors will be paid in the event that the processor goes bankrupt. An overall examination of processor lien law, seed bailment contract law, secured transaction law under the recent changes to Article 9 of the Uniform Commercial Code, and the federal requirements of direct notice to buyers of agricultural products will be comprehensively analyzed and integrated in terms of filing requirements and protections available. Suggestions have been made that creating an indemnity fund may provide a mechanism to cushion the losses to farmers that result when non-payment occurs due to a seed processor bankruptcy. In addition to an examination of indemnity fund establishment, alternative protections afforded in other states and for other types of agricultural products that address nonpayment to agricultural seed producers and assess seed company fiscal stability will be identified and

evaluated.

Description: Recently, the Secretary of the federal Homeland Security Department responded to concerns about

food safety and bioterrorism by endorsing a nationwide identification plan for commercial livestock. In addition, the Food Safety and Inspection Service of the USDA recently issued a notice that any poultry or livestock exhibiting central nervous system disorders associated with West Nile Virus at slaughter must be condemned. The recent discovery of bovine spongiform encephalophy (BSE or Mad Cow Disease) in Alberta, Canada has added to questions related to trace-ability of diseases

that affect both livestock and humans.

The country of origin labeling requirements contained in the 2002 federal farm bill are being phased in. Guidelines were promulgated in 2002 and regulations are to be adopted by USDA by September 30, 2004. These labeling requirements are to apply to retail sales beginning September 30, 2004, and also apply to livestock meat products.

The Washington State Department of Agriculture regulates the movement, testing and safety of animals and animal products coming into or being sold within the state and administers a livestock identification program to track changes in ownership. Committee staff will evaluate legislative policy issues relating to the effectiveness of current mechanisms to identify, trace and respond to food safety, security, and animal disease concerns. The network of organizations and entities that provide animal disease surveillance and early identification of food safety concerns will be explored. The Department's inspection and search warrant authorities will be assessed. Mechanisms and technologies, such as radio frequency tags and microchips, that enable prompt trace-back to food and animal sources will be identified and evaluated. Meetings required by SSB 5891 will be monitored, agency contingency plans will be reviewed and reports will be provided to the committee.
