<b>REFERENCES:</b>	SB 6312 (2012), SB 5127		

**DESCRIPTION:** In the fall of 2011, the Department of Ecology (DOE) announced that insufficient water was available for construction of homes in some rural sub-basins of the Skagit River. During the 2012 session, the Legislature considered SB 6312 to address the water supply needs in the sub-basins that were closed or will be closed in the near future to new home construction.

Though that legislation did not reach agreement, \$2.2 million was appropriated in the capital budget to provide both near-term and long-term solutions to the area's water supply needs. The budget proviso directs that funds are to be used to develop mitigation options and alternative water sources and tools. Additionally, a portion of the funds are to be used to develop a rural domestic demonstration project that meets the mitigation requirements of the basin rule.

During the 2012 interim, the committee will monitor how the DOE plans to utilize the funds and evaluate the degree that solutions will be provided to the affected region. In addition, the committee plans to receive an update during the committee assembly in December.

**DESCRIPTION:** The Legislative Council on River Governance (LCRG) consists of legislators appointed from each of the four northwest states including Washington, Idaho, Oregon and Montana. At the annual summer meeting, this group receives an update on and discusses a number of water issues that are related to the Columbia River watershed or are otherwise of common interest to the northwest states. Meeting preparations, including arranging speakers to address topics of interest to members, are coordinated by the Council of State Governments. The location of the annual meeting rotates and this year it is tentatively planned for August in Boise, Idaho.

**DESCRIPTION:** National and state reports regarding graduation and dropout rates show conflicting characterizations about the rate trends in Washington State.

Committee staff will review, compare, and contrast various reports and efforts to improve graduation rates and decrease dropout rates in Washington and other states and summarize the information for members. Staff will draft legislation as directed.

**DESCRIPTION:** In recent years the Legislature has created a number of task forces, working groups, councils, and committees with legislators as members:

<u>Quality Education Council (QEC).</u> The QEC was created in statute in 2009 to recommend and inform the ongoing implementation by the Legislature of an evolving program of basic education and funding for it; and develop goals and priorities for a 10-year period for the educational system. It is comprised of eight legislators and five educational agency representatives (Office of the Governor, Office of the Superintendent of Public Instruction, State Board of Education, Professional Educator Standards Board, & Department of Early Learning.) The QEC is required to annually report to the Legislature and the Governor.

<u>Joint Select Committee on Education Accountability.</u> The committee was created in statute in 2010 to examine accountability models in other states and identify options for a complete system of education accountability but is not to convene prior to May 1, 2012. It is comprised of eight legislators. The Committee must report to the Legislature and the Governor by September 1, 2012 and 2013.

<u>Educational Opportunity Gap Oversight and Accountability Committee (EOGOAC).</u> The EOGOAC was created to recommend policies and strategies to close the achievement gap. It is comprised of the chairs and ranking members of the Education Committees or their designees plus one additional legislator from the House and Senate, and other appointed members.

<u>Joint Select Committee on Article IX Litigation.</u> The joint select committee was created in 2012 to facilitate communication between the Court and the Legislature on the McCleary case since the Court retained jurisdiction of the case. It is comprised of eight legislators.

<u>Joint Task Force on Education Funding.</u> The task force was created in 2012 and is comprised of eight legislators, and three others appointed by the Governor. It is to develop a proposal for a reliable and dependable funding mechanism to support basic education programs and report by December 2012.

<u>The Early Learning Advisory Council.</u> The counsel was created in 2007 to advise the Department of Early Learning on statewide early learning community needs and progress and is comprised of four legislators; and representatives from Thrive by Five Washington, the Office of the Superintendent of Public Instruction, the State Board for Community and Technical Colleges, the Washington Federation of Independent Schools, a tribal appointment, and 14 Governor appointees.

<u>The Financial Education Public-Private Partnership.</u> The partnership was created in 2009 and is tasked with determining the best methods of equipping students with the knowledge and skills they need to make decisions regarding their personal finances. The membership includes four legislators, four representatives from the private for-profit and nonprofit financial services sector, four teachers appointed by Office of the Superintendent of Public Instruction with one each representative from the elementary, middle, secondary, and postsecondary education sectors, a representative from the Department of Financial Institutions, and two representatives from OSPI.

<u>The Interstate Compact on Education Opportunity for Military Children State Council.</u> The council was created in 2009 to coordinate the state's participation in, and compliance with, the Interstate Compact. The membership includes one member from each legislative branch of government.

The following efforts are in addition to the legislative working groups created with legislative reporting requirements on specific education issues by the end of the year:

<u>The School Employee Compensation Working Group.</u> The group is to begin the process of developing an enhanced salary allocation model for school employees. An initial report is due by June 2012, which must include recommendations for whether additional work is necessary.

<u>The Working Group on Preventing Bullying, Intimidations, and Harassment.</u> The working group must submit reports with prevention recommendations by December 1, 2013, and December 1, 2015.

<u>The Career and Technical State Strategic Plan Working Group.</u> The group must develop a strategic plan for career and technical education by December 1, 2012.

<u>WaKIDS Workgroup</u>. The workgroup must provide recommendations on the implementation of WaKIDS and annually report by December 1 beginning in 2012.

Committee staff will provide research and support to the legislators serving on the legislative groups, provide summary information of meetings, and draft legislation as requested.

**REFERENCES:** RCW 43.440.280

**DESCRIPTION:** In 2007 the Legislature created the STARS program, requiring that the Washington Economic Development Commission (WEDC), The Higher Education Coordinating (HEC) Board, and research institutions develop a plan for recruitment of ten significant entrepreneurial researchers over ten years to lead innovation research teams. The HEC Board was to implement the plan. The goal was to strengthen research and commercialization capacity in areas identified as useful to strategic clusters and innovative firms in the state. A total of six STAR researchers have been hired. Over 30 entrepreneurs in residence have been engaged under the program.

In the 2012 session, the HEC Board was abolished. At the end of this year, the WEDC is to assess and report on the STARS program and recommend modifications of its authorizing statute. Staff will work with interested members and the WEDC, identified strategic clusters and innovative firms, and research institutions to review the STARS statute and assess options for modifications based on the program's five years of operation and developments in the field of innovation and commercialization. Legislation will be drafted as appropriate.

**DESCRIPTION:** Manufacturing matters to the state's economy for a number of reasons:

- Manufacturing jobs tend to be high-productivity, high value-added jobs with good pay and benefits.
- Manufacturing has the highest multiplier effect of all sectors of the economy, thus, growth in manufacturing creates jobs and investment in non-manufacturing sectors.
- Manufacturing is the major source of commercial innovation. Manufacturers employ the majority of scientists and engineers and 68 percent of business research and development spending takes place in manufacturing firms.
- When domestic demand is low and depressing the economy, globally competitive manufactured goods can grow the economy through export sales.

The Legislature has, at various times, promoted programs that encourage in-state manufacturing and assistance to manufacturers. Committee staff will examine state programs and policies that impact manufacturing. Policy options that can strengthen the competitiveness of Washington as a location for manufacturing will be developed. Legislation will be drafted as appropriate.

**DESCRIPTION:** The Washington State Export Initiative, whose goal is to increase exports by 30 percent in five years, began in 2010 as a response to the National Export Initiative to double exports in the same time frame. In the 2011 legislative session, the state enacted various measurers directed to meet this objective through trade promotion, training, and direct assistance to small and medium sized businesses (SMEs). The Community Economic Revitalization Board (CERB) received \$3 million in state funding which the board awarded in the form of grants to various organizations to develop trade specific services for Washington State SMEs.

Due to budgetary restraints, there is increased interest in collaborating with private sector organizations to provide greater trade assistance to SMEs. Staff will (1) work with state agencies and trade organizations to identify the organizations and programs involved in the state's international trade efforts; (2) research best practices for government trade assistance services; and (3) provide a report to the Economic Development, Trade & Innovation committee regarding the findings of this research. Legislation will be drafted as appropriate.

**DESCRIPTION:** In 2001, the Legislature started requiring each retail electric utility in the state to disclose its actual or imputed annual fuel mix used to generate electricity. Among other things, the disclosure must include the percentage attributable to each of the following generation sources: coal, hydroelectric, natural gas, nuclear, or other. The Department of Commerce (Commerce) administers the fuel mix reporting program.

During the 2011-12 legislative biennium, five bills were heard that would have amended the fuel mix reporting law: SHB 1712, SHB 2783, SSB 5431, SSB 5510, and SB 5809. Four of the bills concerned the reporting of null power, which is renewable electricity from which renewable energy credits have been separated. The remaining bill concerned the reporting of coal power that is generated from a plant that is transitioning to non-coal fuel. During the discussion of these bills, questions arose about the original purpose of the fuel mix reports and how the reports are currently used.

Senate committee staff will prepare a report on the fuel mix reporting program, which will examine the following: the legislative history of the law, previous evaluations of the program by Commerce, and how the collected fuel mix data is used by other agencies and entities.

**DESCRIPTION:** In 2006, the Washington Utilities and Transportation Commission (WUTC) adopted rules for interconnecting small electric generating projects to electrical systems owned by investor-owned utilities (IOUs). During the summer of 2011, the WUTC developed policy recommendations for promoting distributed generation in IOU service territories, including a recommendation that the WUTC initiate a rulemaking to consider changes to the interconnection rules. That rulemaking is now underway (WUTC Docket: UE-122133) and is focusing on reviewing rules to lower interconnection costs and accelerate the development of distributed generation systems, without unduly shifting costs between ratepayers or classes. Stakeholders have submitted comments on the proposed rules and the WUTC will hold workshops during the legislative interim to review and discuss the comments. The WUTC plans on issuing the final rules in December 2012. Senate committee staff will attend the workshops, monitor the progress of the rulemaking, and assist in the preparation of any draft legislation as directed.

**DESCRIPTION:** The Legislature has regularly considered and taken action regarding forest health and fire issues in recent years. For example, in 2007 SSB 6141 designated the Department of Natural Resources as the state lead in developing a comprehensive forest health program for the state and created a tiered advisory and regulatory system to address forest health issues. More recently, in November 2011 the Commissioner of Public Lands initiated a forest health hazard warning and convened a technical committee to provide recommendations on this threat and potential responses. Also, the 2012 supplemental operating budget initiated a study on mechanisms for reducing the amount of and variation in the state's fire suppression costs, including an examination of the state's fire suppression staffing costs and Oregon's fire suppression insurance program. Senate committee staff will monitor these and other relevant forest fire and health related activities and provide information, support, and drafting services to members as requested.

**DESCRIPTION:** A number of activities relating to marine waters issues will be ongoing during the 2012 interim. These include implementation of both 2SSB 6263 which modifies the framework for marine spatial planning as well as an associated 2012 operating budget proviso that provides an appropriation of \$2.1 million for marine management planning. Activities under an interagency, public-private partnership established in December 2011 and known as the Washington Shellfish Initiative will continue, including work by the Ocean Acidification Blue Ribbon Panel. Additionally, the ongoing local shoreline master program update process will continue according to the statutory schedule. Senate committee staff will monitor these activities and other emerging marine waters issues and provide information, support, and drafting services to members as requested.

**DESCRIPTION:** The State Environmental Policy Act (SEPA) was adopted in 1971, establishing a framework for an environmental review and evaluation process to assist with decision-making for proposals. SEPA applies to decisions by every state and local agency, including state agencies, counties, cities, ports, and special purpose districts. SEPA is intended to ensure that environmental values are considered during decision-making by state and local agencies. Proposed 2011 legislation sought to update and streamline the SEPA process.

Staff will work with interested members and stakeholders to address outstanding concerns such as notification requirements; subjects for statutory categorical exemptions; and possible and appropriate changes for use of non-project environmental reviews. Staff will prepare and draft legislation as directed.

**DESCRIPTION:** During the past decade, the Legislature has considered several bills regarding manufacturers' stewardship of products. The bills have addressed issues of financing stewardship programs, collecting, recycling, and appropriately disposing of unwanted drugs, carpet, rechargeable batteries, mercury-containing lights, paint, and electronic products.

Staff will review other states' product stewardship programs and regulations; national, international, and private sector models; and strategies for uniform templates; as well as work with stakeholders. Staff will prepare and draft legislation as directed.

**DESCRIPTION:** The federal Clean Water Act (CWA) establishes the National Pollutant Discharge Elimination System permit system to regulate wastewater discharges from point sources to surface waters, including, but not limited to, storm water discharges from municipalities operating municipal separate storm sewer systems that meet specified criteria. The Department of Ecology (DOE) administers permits, including municipal storm water general permits, under the CWA. On January 17, 2007, DOE reissued the phase I municipal storm water general permit and issued two phase II municipal storm water permits, one for Western Washington and one for Eastern Washington, all with an effective date of February 16, 2007. As a result of 2011 legislation, by July 31, 2012, DOE must extend the phase II permits for a term of one year and without modification. Additionally, DOE must issue updated phase II permits, which become effective on August 1, 2013. Staff will review the proposed municipal storm water general permits and draft legislation as directed.

**DESCRIPTION:** Residential foreclosures continue to impact residents of Washington State. This interim, staff will monitor the implementation of ESHB 2614 (relating to short sales, the Foreclosure Fairness Act, and foreclosure remedies) by attending various meetings including, but not limited to; the Washington State Housing Commission monthly Commissioner meetings and the quarterly Affordable Housing Advisory Board meetings and any related trainings.

SSB 6070, addressing the recording of all Deed of Trusts, was introduced but did not pass into law during the 2012 regular session. Staff will engage in member directed research on the issue of recording Deed of Trusts, including Mortgage Electronic Registration System (MERS). Staff will attend and staff meetings as directed by members, as well as attend other related meetings and trainings.

Other related issues include; monitoring the Attorney General's National Mortgage Settlement; continuing to monitor foreclosure statutes and litigation in other jurisdictions; and other work as directed. Possible legislation as directed by members.

**DESCRIPTION:** A tax-deferred exchange is a method by which a property owner trades one or more relinquished properties for one or more like-kind replacement properties. The Internal Revenue Code 26 U.S.C 1031 requires the use of an exchange facilitator or qualified intermediary to hold proceeds from the sale of the original property until those funds are applied to the purchase of the replacement property in order to receive a tax deferral on the exchange. During the 2012 legislative session, SSB 6295 passed which modifies certain exchange facilitator requirements and enacts additional penalties. The bill also contains a provision requiring the development of a stakeholder taskforce to identify effective regulatory procedures for the exchange facilitator industry and to provide specific recommendations to the Legislature by December 1, 2012. Staff will attend and help facilitate the stakeholder taskforce meetings over the interim.

**DESCRIPTION:** Several manufacturers produce GPS tracking devices for the use of private individuals. They can be placed on vehicles with or without the owner's or driver's knowledge. While the U.S. Supreme Court has ruled that placement and use of these tracking devices by law enforcement constitutes a search, use by private individuals was not addressed. Staff will survey the other state's laws to determine whether and how these devices are regulated and whether the issue has been addressed by the courts. Legislation will be drafted as requested.

**DESCRIPTION:** Currently, restrictions and requirements regarding intercepting, recording, or divulging private communication; intercepting private communication; intercepted communication in evidence; and violating the right to privacy do not apply to police, fire, emergency medical service, emergency communication center, and poison center personnel if the sound recordings correspond to video images recorded by video cameras mounted in law enforcement vehicles. A sound recording device that makes a recording must be operated simultaneously with the video camera when the operating system has been activated for an event.

Senate Bill 6066 (2012) provided that law enforcement officers may make sound recordings that correspond to video images recorded by video cameras actually worn by law enforcement officers (in uniform) in addition to those mounted in law enforcement vehicles. A question arose regarding a provision in the current statute that "no sound or video recording may be duplicated and made available to the public by a law enforcement agency until final disposition of any criminal or civil litigation which arises from the event or events which were recorded." It was unclear as to the extent to which this provision could prevent discovery (through the Public Disclosure Act or pretrial discovery) and possible use by an alleged victim of improper law enforcement action. In addition, clarification was sought regarding a recorded person's right to privacy in these situations.

Staff will survey the laws of other states and the federal law, as well as court decisions regarding the discovery and right to privacy issues. Legislation will be drafted as requested.

Approximately half of the states have child access prevention laws that hold adult firearms owners responsible when a child gains access to improperly stored weapons. Washington does not have a specific provision, but reckless endangerment charges have been successfully used in some circumstances. Staff will survey the specific child access prevention laws of other states and also research how the states without such laws address the issue. Legislation will be drafted as requested.

**DESCRIPTION:** Cell phones register their location with the network several times a minute and this function cannot be turned off while the phone is getting a wireless signal. Some cell phone companies store customers' location data for a period of time. For example, according to the U.S. Department of Justice, Sprint keeps location tracking records for 18-24 months, and AT&T holds onto them "since July 2008," suggesting they may be stored indefinitely. Yet none of the major cell phone providers disclose to their customers the length of time they keep their customers' cell tracking data. Some Washington law enforcement agencies have gained access to cell phone records for individuals without warrants. Some believe that requiring law enforcement to obtain a warrant before gaining access to cell phone records should be required, especially since the U.S. Supreme Court ruling in *United States v. Jones*, where a majority of the Supreme Court recently concluded that the government conducts a search under the Fourth Amendment when it attaches a GPS device to a car and tracks its movements. Staff will determine what current practice is in Washington and survey the applicable laws in other states and at the federal level. Legislation will be drafted as requested.

For many drivers, the cost of being an independent contractor is not offset by adequate remuneration. Some view this as a misclassification of workers as independent contractors. Others view these drivers as independent contractors by choice - drivers who prefer the flexibility and independence that such work allows them. Other jurisdictions have attempted to address this disparity through legal challenges. Staff will research the unique elements which comprise this dilemma, related case law, and information about how other states have addressed such issues to provide background for legislators interested in addressing this issue.

**DESCRIPTION:** Qualified employers may self-insure for industrial insurance purposes. Self-insured employers typically contract with third party administrators (TPAs) to administer the employer's workers compensation system. The Ombudsman for Self-Insured Workers has repeatedly found that the failure of TPAs to timely pay authorized medical bills is a source of frustration for injured self-insured workers, as unpaid medical bills are sent to collection agencies. Legislation to address this issue was opposed by self-insured employers, who want to be sure they are paying only for authorized care, are concerned that medical providers may be billing the worker directly, and believe enforcement of current L&I policies would correct the problem. The committee will work with stakeholders to develop a solution to the issue of non-timely payment of medical bills by TPAs.

**DESCRIPTION:** <u>Privatization</u>. Privatization of the distribution and sale of liquor statewide is still in the implementation phase. Staff will provide an update on progress to date, as well as those aspects of privatization yet to be implemented or requiring legislative follow up.

<u>In-state manufacturers (distilleries, wineries, breweries).</u> Craft distillers of spirits have increased from zero to approximately forty in Washington State in the last four years. Some have compared craft distilleries' potential economic impact to that of the very successful Washington State wine industry. Staff will provide legislators with legal analysis around licensing issues relating to craft distillers.

<u>Farmer's Markets - Legal definition of farmers market for purpose of sales or sampling of certain</u> <u>alcoholic beverages.</u> Under current state law Washington wineries may offer wine samples and sell wine at certain farmers markets. Likewise, domestic breweries and microbreweries are permitted to sell their products at certain farmers markets. Not all farmers markets in Washington State meet the legal definition of a qualifying farmers market for the purpose of selling beer or wine. Although this issue is raised annually and the Liquor Control Board has suggested clarifying language, it remains unresolved. Staff will provide legislators with statutory and agency background and prepare legislative proposals as requested.

Meetings will be held with individual stakeholders and all stakeholders will be invited to participate in group meetings in Olympia. The study will be supported by a staff workgroup comprised of staff from the JTC and House and Senate Transportation Committees. Additionally, although language directing DOT to submit a report on moving the Aviation Division headquarters from Arlington to Olympia was vetoed, a study and report on this issue are being conducted and will be completed prior to the next legislative session. Committee staff will participate in both the staff workgroup evaluating the search and rescue program and the review of the location of the Aviation Division headquarters, monitor these studies, and assist with draft legislation as appropriate.

**DESCRIPTION:** The REAL ID Act of 2005 (Act) prohibits Federal agencies from accepting a driver's license or personal identification card issued by a U.S. State for any official purpose unless the license or card has been issued by a state that meets the requirements set forth in the Act. The Act also authorizes the Secretary of Homeland Security to grant states extensions of time to meet the requirements of the Act if the state provides adequate justification for noncompliance. On January 29, 2008, the Department of Homeland Security (DHS) promulgated a final rule implementing the requirements of the Act. The rule specifies what provisions must be in place in order for a state to be considered in "full compliance" with the Act and sets a deadline. DHS has extended the full compliance date a number of times since the Act passed. The current deadline is January 15, 2013. During some recent Congressional hearings, DHS indicated that it will not extend the full compliance date again. Washington is currently not in full compliance with the Act. Staff will also attend meetings and briefings by affected state agencies on REAL ID Act compliance. Staff will prepare any legislation requested by members to address compliance with the Act.
