LIMITATION OF ACTIONS TO SET ASIDE OR CANCEL TAX DEEDS.

An Act to provide a limitation for the bringing of actions to set aside or cancel tax deeds, or for the recovery of lands sold for delinquent taxes.

Be it enacted by the Legislature of the State of Washington:

Actions must be brought within three years. SECTION 1. Actions to set aside or cancel the deed of any county treasurer issued after and upon the sale of lands for general, state, county or municipal taxes, or for the recovery of lands sold for delinquent taxes, must be brought within three years from and after the date of the issuance of such treasurer's deed: *Provided*, This act shall not apply to actions not otherwise barred on deeds heretofore issued if the same be commenced within one year after the passage of this act.
