**Project Title: Forestry's Role in the Environment, Jobs, and Biomass Energy**

**Project Goal:**

**Explore forestry and its role on the environment, jobs, and biomass energy.**

**Project Description:**

Many issues that have been recently before various committees, and will again be before these committees in coming sessions, have a close nexus with the forest products industry in the state. Issues involving forestry are as diverse as endangered species management, climate change, economic stimulus, and biomass energy. Each of these issues are closely linked when viewed under the lens of forest practices.

The Agriculture & Natural Resources and the Technology, Energy & Communications Committees will jointly conduct a work session that invites representatives from the environmental community, federal and state government, labor, and the private sector to discuss these issues and the role the state can take, in light of changes at the federal level, to take a leadership role in addressing these critical issues.

**Project Title: Wildfire Response and Prevention**

**Project Goal:**

**Investigate the state's investments in preventing wildfires and the methods used to fight wildfires.**

**Project Description:**

State forest fire management policy is primarily implemented by the Department of Natural Resources (DNR). Two significant services provided by the DNR are wildfire prevention efforts and the actual fighting of forest fires.

The Committee will investigate both aspects of the DNR's wildfire program to learn more about both the prevention and fighting of wildfires. This process will include an investigation into how the DNR maximizes its own state resource and how it chooses and utilizes the services provided by private contract firefighting crews. The Committee will also consider any recommendations brought forward regarding potential legislation that offers suggestions for making the fire prevention and fighting efforts at the DNR more effective and efficient, including ideas on how to more efficiently collect property assessments levied to cover fire prevention and response costs.

**Project Title:** State Management of Natural Resources

**Project Goal:**

**Identify efficiencies, redundancies, and potential administrative streamlining measures in how the state manages its natural resources.**

**Project Description:**

The state's natural resources are managed by a number of state agencies. Each agency has a set jurisdiction, management structure, and list of duties and responsibilities. In most instances the natural resource agencies operate independently from one another; however, there are other times when the jurisdictions and authorities of the agencies overlap and close coordination among the various agencies is required.

The Committee will investigate the current natural resources management structure with the goal of identifying efficiencies, redundancies, and potential administrative streamlining measures. This investigation will include the management and governance structures of the various agencies, areas where agency jurisdictions and authorities overlap, and programs within each natural resource agency that may be managed more efficiently and effectively by other agencies or under a different model.

As part of this process, the Committee will monitor the processes required in: (1) section 907 of the state operating budget involving a governor's advisory body for consolidation opportunities with natural resource agencies and (2) HB 2157 regarding increasing efficiencies in grant programs and assessing coordination in watershed and salmonid management. The Committee may invite the participants to present their results to the Committee.

**Project Title:** Water Resource Policy Considerations

**Project Goal:**

**Explore options and consider recommendations on important water policy issues, and start preparing legislation for the 2010 Legislature.**

**Project Description:**

Several water policy issues have emerged over the past few years that require thoughtful discussions and creative brainstorming in order to resolve. Issues revolving around exempt wells, stock watering, instream flows, rain harvesting, relinquishment, storm water, and water transfers have all surfaced as potential issues for the 2010 Legislature.

The Committee will explore options and consider recommendations from various stakeholders on pressing water policy issues. The Committee will brainstorm on how to resolve these issues, and ultimately draft legislation for the 2010 Legislature that addresses the concerns of the Committee members and the public.

**Project Title: Reclaimed Water and Water Rights Impairment**

**Project Goal:**

**Monitor and verify that reclaimed water use rulemaking is consistent with Legislative intent and that the impairment recommendations are received in a fair and equitable manner.**

**Project Description:**

Reclaimed water is an effluent derived from a wastewater treatment system that has been treated in order to be suitable for a beneficial use or a controlled use that otherwise would not occur. The Department of Ecology (DOE) and the Department of Health (DOH) must adopt rules addressing all aspects of reclaimed water use by December 31, 2010. Rulemaking has begun and the DOE plans to continue with further rulemaking. Several task forces established by the DOE and the DOH have reviewed the current reclaimed water regulations and have suggested ways to make development of reclaimed water facilities easier and more efficient.

The Committee will monitor the Reclaimed Water Committee and Reclaimed Water and Water Rights Advisory Committee to ensure that legislative intent is maintained and the DOE delivers a valid and substantial recommendation to the Legislature by November 30, 2009, on the impairment requirements and the standards for reclaimed water, as well as the positions of the stakeholders on those issues.

**Project Title: Energy Savings Performance Contracting**

**Project Goal:**

**Research the current and potential uses of Energy Savings Performance Contracting and potential methods that the state may implement to assist entities in using the program.**

Energy Savings Performance Contracting is used by state and local governments to increase the energy efficiency of buildings. Building improvements are financed and loans repaid through energy savings realized from the improvements. The Committee's research will address entities that use the program and those that do not, the barriers to using the program, and ways to overcome the barriers. The Committee will hear from the Department of General Administration, the Office of the Superintendent of Public Instruction, other state agencies, and Energy Savings Contractors to understand Energy Savings Performance Contracting and the barriers, and ways to overcome the barriers to Energy Savings Performance Contracting.

**Project Goal:**

**Project Description:**

Funds were appropriated in the state capital budget for implementation of Engrossed Substitute House Bill 2289 (2009) and Engrossed Second Substitute Senate Bill 5649 (2009) that create and revise programs providing for energy efficiency, renewable energy, and innovative energy technologies in government, non-profit, and private business facilities. In addition, a significant amount of federal American Recovery and Reinvestment Act funds are designated through the state of Washington and through national competitive processes for implementation of the energy programs and technologies. The Committee will monitor, review, and evaluate the use of the energy funds for consideration of current and future distribution of state funds and implementation of statutes.

### **Project Title: Joint Legislative Task Force on School Construction Funding**

#### **Project Goal:**

**Provide staff support and research for the Joint Legislative Task Force on School Construction Funding.**

#### **Project Description:**

The 2009-11 Capital Budget authorizes the Joint Legislative Task Force on School Construction Funding (task force) to continue the work of the 2007-09 task force but with revised membership. The 2009-11 task force consists of six members, and is mandated to explore the following: (1) the state funding assistance ratio used in the school construction assistance grant program formula; (2) methods to accommodate specialized program space or unique building circumstances (such as all-day kindergarten and science labs); and (3) ways to account for regional cost differences in the school construction assistance grant program formula. The Office of the Superintendent of Public Instruction will update the task force on the tracking system to increase accuracy in predicting the timing of school district claims for reimbursement for school construction assistance grants. A task force report is due to the Legislature by January 1, 2010. The task force must conduct its work without incurring travel, per diem, or other costs.

### **Project Title:** Higher Education Scoring System

#### **Project Goal:**

**Participate in revisions to the scoring system for the four year higher education institutions and participate in facilitation of the scoring teams.**

#### **Project Description:**

By statute, the Office of Financial Management (OFM) must submit a scored categorical project list for the four year higher education institutions for consideration of funding in the capital budget. The projects are scored within categories by teams assembled by the OFM. Legislative staff may participate by facilitating the scoring teams.

Up to \$3 million is for school facility repairs and renovations necessary for health and safety. The remaining amount is for energy operational cost savings and safety and health infrastructure improvements to school facilities. Office of Program Research Capital Budget Committee staff will monitor and analyze the use of the funds and the ability of schools to access the Energy Savings Performance Contracting program.

**Project Title:** Gambling Policy

**Project Goal:**

Review recent issues and consider possible legislation for the 2010 session.

**Project Description:**

For many years, the Committee has dealt with the issue of city and county authority with respect to house-banked card rooms. There have also been discussions about other aspects of the state's gambling policies.

During the 2009 interim, the Committee will receive an update on card room and other recent gambling legislation and consider potential legislation for the 2010 session. The Committee will also review the state's gambling policies and receive an update on issues before the Gambling Commission.

**Project Title:** Agricultural Labor

**Project Goal:**

Monitor key issues related to agricultural labor in Washington.

**Project Description:**

During the 2009 interim, the Committee will hold two work sessions to examine issues related to agricultural labor in Washington. The Committee will monitor the supply of seasonal and immigrant workers in the agricultural community. The Committee will also review proposed changes to federal immigration laws (e.g., the federal Agricultural Job Opportunities, Benefits and Security (AgJOBS) Act), the state Farm Labor Contractor Act, and the state human trafficking disclosure statement requirement, as well as the impact of these changes on the agricultural labor market in Washington. Parties invited to participate in work sessions will include representatives of farm workers, agricultural employers, the Department of Agriculture, and the Employment Security Department.

**Project Title:** Human Trafficking Disclosure Statement

**Project Goal:**

**Review outstanding issues and develop legislation for the 2010 session.**

**Project Description:**

During the 2009 session, E2SSB 5850 relating to protecting workers from human trafficking violations was enacted. The act requires that disclosure statements be provided by employers of foreign workers and international labor recruitment agencies to foreign workers referred to or hired by a Washington employer. Foreign workers are persons who are not U.S. citizens and who come to the state based on an offer of employment, but not persons who hold H-1B visas. A section classifying a violation of the disclosure statement requirement as a violation of the Consumer Protection Act was vetoed.

During the 2009 interim, the Committee will review outstanding issues with the Senate Labor, Commerce, & Consumer Protection Committee and stakeholders, and develop legislation for the 2010 session. Such issues include: (1) exemptions from the definition of "foreign worker;" and (2) enforcement and penalties related to violations of the disclosure statement requirement.

**Project Title: Unemployment Compensation Modernization Incentive Payment**

**Project Goal:**

**Receive an update on the unemployment compensation modernization incentive payment (special Reed Act transfer) under the federal American Recovery and Reinvestment Act of 2009.**

**Project Description:**

The federal American Recovery and Reinvestment Act of 2009 provides up to \$7 billion for modernization incentive payments (special Reed Act transfers) to states that meet certain requirements. One-third of the incentive payment is contingent on state law providing for an alternative base period. Two-thirds is contingent on state law providing for at least two of the following: (1) No denial of benefits to part-time workers seeking only part-time work; (2) no disqualification from benefits for separating from employment for compelling family reasons, including domestic violence, an immediate family member's illness or disability, and the need to accompany a spouse to a place from which it is impractical to commute due to a change in the location of the spouse's employment; (3) continuation of weekly benefits for exhaustees in state-approved training; and (4) dependents' allowances of at least \$15 per dependent per week.

During the 2009 interim, the Committee will receive an update from the Employment Security Department on the incentive payment.

One of the bills, ESHB 1906, expands eligibility for the training benefits program. The expanded program will serve dislocated workers, as well as certain low-wage workers, military personnel and National Guard members, and persons who are disabled. The act requires a report to legislative committees on the program's status and outcomes by December 1, 2009, and each year thereafter.

The other bill, E2SSB 5809, creates incentives for education and training for individuals enrolled in training for high-demand and certain other occupations. The Employment Security Department (ESD) is directed to match funds provided by workforce development councils to increase training capacity and provide student financial aid. The act also requires the ESD to periodically bring together representatives of particular agencies, workforce development councils, business, labor, and the Legislature to review development and implementation of the high-demand training incentive program and the training benefits program.

During the 2009 interim, the Committee will monitor expansion of the training benefits program and development and implementation of the high-demand training incentive program.

A related 2009 bill, SB 6173, directs the task force to study the newly created seller's permit which will replace the resale certificate as a means to exempt businesses making wholesale purchases from the retail sales tax.

During the 2009 interim, the task force will identify, study, and make recommendations for reducing the underground economy in the state, including any changes to seller's permits.

**Project Title:** Climate Change Policies

**Project Goal:**

**Monitor federal and regional climate change and carbon emission policies and develop strategies to ensure Washington State interests are reflected in any regional or federal policies.**

**Project Description:**

In 2008 legislation was enacted requiring the following statewide greenhouse gases (GHG) emission reductions: by 2020 reduce overall GHG emissions in the state to 1990 levels; by 2035 reduce overall GHG emissions in the state to 25 percent below 1990 levels; and by 2050 reduce overall GHG emissions in the state to 50 percent below 1990 levels, or 70 percent below the state's expected GHG emissions that year.

In May 2009, the Governor enacted Executive Order 09-05, directing the Department of Ecology and the Department of Transportation to develop strategies and provide recommendations on several aspects of climate change policy. A number of reports will be written by state agencies outlining climate policy recommendations.

In 2007 the governors of Arizona, California, New Mexico, Oregon, and Washington formed the Western Climate Initiative (WCI). They were later joined by Montana and Utah, and the Canadian provinces of British Columbia, Manitoba, Ontario, and Quebec. Other U.S., Canadian, and Mexican states have joined as observers.

President Obama's budget contains items for creating a "clean energy economy." It recognizes an economy-wide GHG cap-and-trade program, sets targets for reducing emissions, and invests in new low-carbon technologies. The budget also calls for a trading system to be up and operating by 2012.

The Committee will monitor climate change and carbon reduction policies at the federal, regional, and state level, including a review of the economic consequences of climate change and carbon reduction policies, and develop strategies to ensure Washington State's interests are reflected in those policies.

**Project Title: Solid Waste Management**

**Project Goal:**

**Brief committee members on current statutes, policies and issues on solid waste and develop legislation for the 2010 Legislature.**

**Project Description:**

The Waste Not Washington Act of 1989 established a policy framework for waste reduction, reuse, and recycling that included setting a goal for the state to recycle 50 percent by 2007. Through the waste reduction and recycling efforts of the last 20 years, Washington is now diverting about 48 percent of the solid waste generated in the state to reuse, recycling and beneficial use applications.

The Beyond Waste Implementation Work Group of the Climate Action Team had a goal to make recommendations that would significantly expand source reduction, reuse, recycling and composting, and develop an environmentally and economically sustainable implementation plan targeting products and organic materials with the largest greenhouse gas reduction potential.

The Committee will focus on the education of committee members on current statutes, policies, and issues relating to solid waste. The Committee will identify barriers and opportunities to increase the reduction, reuse and recycling of solid waste and solicit input from industry, local governments, state agencies, and other stakeholders, including the Beyond Waste Implementation Work Group. The Committee will focus on issues that will lead to the development of legislation for the 2010 Legislature.

**Project Title:** Implementation of the Puget Sound Partnership

**Project Goal:**

**Project Description:**

The Puget Sound Partnership (Partnership) was created by legislation enacted in 2007. The Partnership's task is to restore the Puget Sound by the year 2020. The Partnership has several major components: (1) the Action Agenda, which states the goals and responsibilities of the Partnership; (2) the Leadership Council, which leads the Partnership; (3) the executive director, who administers the agency; (4) the Coordination Board, consisting of stakeholders, which serves as the communication link between the Partnership and local entities; and (4) the Puget Sound Science Advisory Council, consisting of technical and scientific representatives, which advises the Leadership Council and the executive director.

The Committee will review each of the requirements in the enabling legislation and the progress and degree to which the Partnership has met those requirements. The Committee will facilitate opportunities to inform committee members and provide input to the Partnership staff and Leadership Council. The Committee will determine if legislation is needed to improve efficiency and the targeting of resources, and if so, develop legislation for the 2010 legislative session.

**Project Title: State Environmental Policy Act**

**Project Goal:**

**Brief members on the State Environmental Policy Act, track local government and executive branch actions, and develop potential legislation for the 2010 Legislature.**

**Project Description:**

The State Environmental Protection Act (SEPA) requires all branches of government in the state, including state agencies, municipal and public corporations, and counties to include a detailed environmental impact statement (EIS) in every report or recommendation for major actions that significantly affect the quality of the environment. The EIS must include: (1) the environmental impact of the proposed action; (2) any adverse environmental effects that cannot be avoided if the proposal is implemented; (3) alternatives to the proposed action; (4) the relationship between local short-term uses of the environment and the maintenance and enhancement of long-term productivity; and (5) any irreversible and irretrievable commitments of resources that would be involved in the proposed action should it be implemented.

The Committee will focus on informing committee members on various aspects of the SEPA. The Committee will solicit information from the SEPA Implementation Group of the Climate Action Team, as well as other stakeholders and experts, to consider how the SEPA can incent more climate-friendly development. The Committee will also track local government ordinances and executive branch rulemaking and guidance documents to follow how they are incorporating climate change policies into the SEPA and to determine if there are additional policies that may utilize the SEPA.

Legislation enacted during the 2009 session (SSB 5571 - electronic filing/payment of taxes) requires monthly taxpayers to electronically file tax returns and pay taxes by electronic funds transfer or other electronic method. The Department may waive this requirement for any taxpayer for good cause. Taxpayers who file returns on a quarterly or annual basis may also file and pay electronically. Tax assessments, notices, and other information from the Department of Revenue to taxpayers will be electronically delivered unless the taxpayer does not have the equipment to receive the information. **Project Title:** Event Data Recorders in Auto Insurance

**Project Goal:**

Consider the current regulatory structure regarding insurer use of information from event data recorders and discuss possible legislation.

**Project Description:**

In 2009, the Legislature contemplated three bills that addressed the use of information gathered by event data recorders and other similar devices by insurers. Event data recorders (EDRs) are devices that may be installed in cars by the manufacturer or at a later date. The EDRs gather a variety of information that may include speed, direction, location of the vehicle, manner of driving (including acceleration, braking, and steering).

One bill (SSB 5708) concerned the confidentiality of insurer rating models that included this information. This bill was heard in the House Financial Institutions & Insurance Committee but was not voted on by the Committee. The other two bills (SSB 5574 and SHB 1500) were very similar but were not companions. Both SSB 5574 and SHB 1500 addressed the installment of these devices in vehicles by manufacturers, disclosures to buyers of those vehicles, and access to the information by third-parties. There were also provisions in both bills related to the use of the information by insurers in underwriting and in claims handling. Both bills went through the House Transportation Committee. SSB 5574 was enacted without the insurance provisions.

In addition to the use of information based on EDRs by insurers, the Committee will also discuss related "pay-per-mile" and mileage-based concepts in auto insurance.

The Committee will review the recent bills, review regulatory activity in other states, and will discuss regulatory and legislative options.

The second, required by 2SHB 1946, is an evaluation of the use of existing Information Technology resources at all public institutions of higher education. The Board must make recommendations on how to improve the efficiency, effectiveness, and quality of education relative to the use of technology. The board is also voluntarily undertaking a project to develop a framework that will guide the growth of higher education institutions.

The purpose of the Committee's work session is to better understand the connections between tuition policy, system expansion, and the use of technology in improving access, affordability, and quality of higher education. The HECB and the other higher education stakeholders will be asked to participate in a dialogue regarding the results of the HEBC's work to date, including an opportunity for the committee members to provide clear feedback regarding higher education committee member expectations prior to the reports being finalized.

**Project Title: Major Reports and Updates**

**Project Goal:**

**Receive updates from various agencies and institutions on projects assigned to them during the previous legislative session.**

**Project Description:**

The Higher Education Coordinating Board will be asked to provide an update on its system design plan, discussed at the October work session. While the October work session was held to inform the HECB and stakeholders of Higher Education Committee member expectations, this meeting will include the final report on the recommendations approved by the HEBC at its board meeting in November. The plan will provide a coordinated response to current regional and institutional demands for additional campuses, new degree programs, and expanded missions. The HECB's report will make specific recommendations to determine the role and scope of institutions and educational sectors; develop policies and procedures to plan and authorize growth and change; and recommend how growth and change should occur while making maximum use of existing resources.

The HECB will also make a preliminary progress report on the work group to improve the effective use of technology in higher education, pursuant to 2SHB 1946. The HECB was required to convene a work group to investigate efforts in other states regarding online learning technologies, personalized online student services, integrated administrative tools, shared library resources, methods for sharing digital content, methods for pooling and sharing enrollments in online classes, and methods for ensuring quality of online programs and classes. The report will include an update on the evaluation of these efforts in other states as well as preliminary results from a comprehensive audit of all information technology resources currently in use at institutions of higher education.

The State Board for Community and Technical Colleges (SBCTC) will provide a progress report on the implementation of "open course materials". Open course materials are openly-licensed textbooks and other educational material offered online by its author(s). The open license sets open textbooks apart from traditional textbooks by allowing users to read online, download, or print the book at no cost. The SBCTC was appropriated \$2.225 million in the operating budget to implement this technology throughout the community and technical college system in an effort to save students money and make college more financially accessible. The SBCTC's work will be closely linked with the HECB's work on the technology transformation taskforce.

Finally, the HECB was also required to conduct an evaluation of tuition policy, pursuant to ESHB 2344. The HECB will provide a report to the Committee on the findings of the evaluation, especially as they relate to impacts on students. The HECB will make recommendations to the committee on specific action steps necessary during the 2010 legislative session to implement changes to current tuition policy.

**Project Title:** Drowsy Driving

**Project Goal:**

**Examine the issue of drowsy driving, including the extent to which it is a public safety hazard, current methods available to combat drowsy driving, and whether a legislative response is needed.**

**Project Description:**

According to a report by the National Sleep Foundation (NSF), more than half of America's drivers admit to driving while drowsy and nearly two out of five (approximately 2 million people) admit to having actually fallen asleep at the wheel within the past year. According to some articles, fatigue, like alcohol, can slow reaction time, decrease awareness, and impair judgment. Statistics from the National Highway Traffic Safety Administration show that 100,000 drowsy driving crashes are reported to police each year, killing more than 1,500 people and injuring over 70,000. In Washington, there are about 30-40 deaths on average per year due to drowsy driving.

The Committee will have a work session to allow the Washington State Patrol, the Washington Traffic Safety Commission, and other stakeholder groups to present and discuss the issue of drowsy driving, and in particular explore: (1) how and to what extent drowsy driving is a public safety hazard; (2) how drowsy driving differs from distracted and impaired driving and whether the differences require a different approach to combating the issue; and (3) whether current traffic laws and criminal penalties sufficiently address drowsy driving or whether there is a need for a legislative response.

**Project Title:** Monitoring the Completion of the Ruckelshaus Center's Examination of Conflicts Between Agricultural Activities and Critical Area Ordinances

**Project Goal:**

Monitor and report on the final efforts of the Ruckelshaus Center to examine the conflicts between agricultural activities and critical area ordinances.

The project will include an examination of existing approval practices, the advisory role of the DCTED, and comparable land use planning approval practices utilized in other states. The project will include a work session at the December Committee Assembly.

**Project Title:** **Agency Monitoring and Status Reports**

**Project Title:** Delayed Sentencing for Sentences Under One Year

**Project Goal:**

Create a "delayed sentencing option" following the entry of a plea of guilty and presentence release conditions for offenders with a standard sentence range of one year or less.

**Project Description:**

By statute, the court must impose a sentence within 40 days following a conviction, unless either party makes a showing of good cause or the court on its own motion extends the time period for conducting the sentencing hearing. When a person is convicted of a crime, the court must generally sentence the offender within a standard range determined by the person's criminal history and the seriousness level of the crime. During the 2008 legislative session the Committee considered HB 2077 that would have created an alternative delayed sentencing option for certain offenders convicted of non-violent and non-sex offenses, with a standard sentence range of one year or less who would otherwise serve their sentence in a county jail.

The Committee will work with prosecutors, defense attorneys, and Superior Court judges to review and study whether a delayed sentencing option along with mandatory court-ordered conditions is an option that can be implemented within the state's judicial system.

**Project Title: Search and Rescue Activities**

**Project Goal:**

**Establish a volunteer search and rescue account to help fund the expenses of local search and rescue organizations that routinely assist law enforcement agencies.**

**Project Description:**

Search and rescue refers to the acts of searching for, rescuing, or recovering by means of ground, marine, or air activity any person who becomes lost, injured, or is killed while outdoors as a result of a natural, technological, or human caused disaster, including instances involving searches for downed aircraft when ground personnel are used. Search and rescue activities are generally initiated by local law enforcement agencies. In instances where a particular emergency event calls for assistance beyond local capabilities, the local emergency management organization calls upon the Department of Transportation (DOT) to assist. If further assistance is required, the DOT calls on the National Guard and federal emergency response agencies.

During the 2008 legislative session the Committee considered HB 1214 that would have established a Volunteer Search and Rescue Account, funded by a surcharge on all recreational licenses issued by the Department of Fish and Wildlife. The funds in this account were to have been used to provide reimbursement through the Emergency Management Division of the state Military Department to volunteer search and rescue organizations for expenses incurred in rendering assistance to law enforcement within the state. The Committee will work in conjunction with the appropriate stakeholders to determine whether establishing such an account is a viable solution to help fund search and rescue activities in the state.

**Project Title: Modifying the Criminal Sentencing Reform Act Grid and Broadening Judicial Discretion**

**Project Goal:**

**Amend the sentencing grid to allow judges greater discretion under the Sentencing Reform Act.**

**Project Description:**

Prior to 1984, courts were required to impose "indeterminate" sentences upon persons convicted of felonies. Under this system, a court would impose a minimum term and a maximum term. The Board of Prison Terms and Paroles (now called the Indeterminate Sentence Review Board) would evaluate the offender and determine whether he or she could be paroled prior to the expiration of the maximum term. Indeterminate sentencing still applies to offenders convicted of offenses committed prior to July 1, 1984. In 1981 the Legislature enacted the Sentencing Reform Act (SRA), which imposed "determinate" sentences on offenders who committed their offenses on or after July 1, 1984. Under determinate sentencing, a court must sentence an offender to a term within a standard range. Prior to 2004, a court could sentence, on its own initiative, an offender above or below the standard range if it found, by a preponderance of the evidence, that aggravating or mitigating circumstances existed. This type of sentence is known as an "exceptional sentence." In 2004 the U.S. Supreme Court ruled that sentencing an offender above the standard range in this manner is unconstitutional under *Blakely v. Washington*, 542 U.S. 296 (2004).

During the 2008 legislative session SB 6160 was considered by the Legislature that would have established a new sentencing grid, expanded the circumstances under which a mitigated exceptional sentence may be imposed, and changed the manner in which certain aggravated exceptional sentences were imposed. The Committee will review the bill and work with the necessary affected parties to try to work out many of the issues related to the bill prior to the 2010 legislative session.

**Project Title:** Guilty and Mentally III Offenses

**Project Goal:**

Establish a disposition for criminal defendants who are guilty and mentally ill.

**Project Description:**

The affirmative defense of not guilty by reason of insanity is established if a defendant proves, by a preponderance of the evidence, that at the time of the criminal offense, the defendant had a mental disease or defect which affected the defendant to the extent that either the defendant was unable to perceive the nature or the quality of the act with which the defendant is charged, or that the defendant was unable to tell right from wrong with reference to the particular act charged. A defendant who has been found not guilty by reason of insanity may be committed for treatment to a state hospital if the defendant presents a substantial danger to other persons, or a substantial likelihood of committing criminal acts jeopardizing public safety or security. To date thirteen states have established an offense of Guilty and Mentally III, including Alaska, Delaware, Georgia, Illinois, Indiana, Kentucky, Michigan, Montana, New Mexico, Pennsylvania, South Carolina, South Dakota, and Utah.

The Committee will consider the possible establishment of a new "Guilty and Mentally Ill" disposition. A defendant who has offered a defense of insanity at trial may be found "Guilty and Mentally ill" if the judge or jury finds that the state has proven the defendant guilty of the crime charged, the defendant has failed to prove the asserted insanity defense, and finds that the defendant has proven by a preponderance of the evidence that he or she was mentally ill at the time of the commission of the offense. A person who is found Guilty and Mentally Ill will be sentenced as if the person were found guilty. The person will be placed under the jurisdiction of the Department of Corrections, but will be committed to a secure mental health facility operated by the Department of Social and Health Services for mental health treatment.

**Project Title: Sex Offender Risk Level Classification and the State v. Ramos Case**

**Project Goal:**

Determine who should assign risk level classifications for certain offenders.

**Project Description:**

In the 2008 Division II case of State v. Ramos, the court held that the Legislature violated the separation of powers doctrine when it enacted RCW 4.24.550(6) because it requires local law enforcement to determine the risk level for certain offenders. Risk level is an element of the crime of Failure to Register under RCW 9A.44.130(7) that requires in-person registration every 90 days for risk level II and level III offenders. The court explains that establishing the elements of a crime is a legislative function and it is unconstitutional for the Legislature to abdicate or transfer its legislative function to others. In order to find someone guilty of failure to register as a risk level II or III offender, the court must find that the person is in fact a risk level II or III offender. In other words, an offender's risk level is an element of the crime of failing to register under this section, and in some instances, this determination is made exclusively by local law enforcement.

In the State v. Ramos case, the offender was released from Department of Corrections (DOC) custody in 1995, before the DOC was required by statute to evaluate the risk of re-offense upon release from custody. As such, the risk level determination was made exclusively by local law enforcement. Although there have been cases in which legislative delegation to the executive branch has been proper, the court found that “[t]he legislature inadequately defined the element of the crime at question (risk of reoffense) and did not provide standards to assist law enforcement agencies in establishing measurement procedures of the risk of reoffense.” As a result, the delegation of authority to law enforcement to make the risk level determination was inadequate.

The Committee will work in conjunction with prosecutors, defense attorneys, the Sentencing Guidelines Commissions' Sex Offender Policy Board, the Department of Corrections, and law enforcement to determine a possible resolution to classifying risk levels to certain offenders that were previously done exclusively by local law enforcement. The Washington Association of Sheriffs and Police Chiefs, the Department of Corrections, and Sex Offender Policy Board will be invited to provide the Committee with an update on sex offenders in general including, but not limited to sex offender registration laws and compliance in Washington, GPS monitoring, and the federal Sex Offender Registration and Notification Act (SORNA or otherwise known as the Adam Walsh Act).

**Project Title:** Exoneree Compensation

**Project Goal:**

**Review the exoneree compensation programs currently in place across the United States.**

**Project Description:**

Statutes have been enacted in 27 states and the District of Columbia and by the federal government to provide monetary compensation and services to those who have been wrongly convicted of a crime. The amount of compensation and the nature of the compensatory schemes vary by jurisdiction, but compensation is generally based on the number of years the individual was incarcerated for a crime that he or she did not commit. Washington does not have in place a program to compensate those who have been wrongly convicted. According to the Department of Corrections, all individuals released from total confinement are given access to the same benefits and services, without regard to the reason for release.

An individual's "actual innocence" may be established through a number of methods, for example through the use of forensic DNA testing, the presentation of new evidence, or a recantation of testimony by a key witness.

Forensic DNA testing was first used in an American courtroom to exonerate a wrongly convicted person in 1989. Since that time, such testing has been used to exonerate 238 people, and in 103 of these cases the test results have been used to identify the actual perpetrator or suspect of the crime. DNA-related exonerations have occurred in 33 states and the District of Columbia. The exonerated individuals averaged 26 years of age at the time of conviction, and served an average of 12 years of incarceration before release. The vast majority of criminal prosecutions do not involve biological evidence upon which DNA testing can be performed, and precise statistics for non-DNA related exonerations are not readily available. According to some studies, the primary causes of false or wrongful convictions include misidentification by eyewitnesses, unreliable or improper forensic science, false confessions or incriminating statements, and false testimony by informants.

The Committee will review the compensation programs currently in place across the United States. The multi-state analysis will include a summary of the kind and amount of compensation provided to exonerees, the legal process required for an exonerated person to obtain compensation, the criteria that must be met for an individual to qualify as an exoneree for purposes of the compensation programs, and the manner in which the compensation programs are funded in each jurisdiction.

**Project Title:** Quantity-Based Drug Sentencing

**Project Goal:**

**Review sentencing options that courts may consider that are based on the quantity of drugs found on an offender versus pure possession of drugs.**

**Project Description:**

A controlled substance is generally defined as a drug, substance, or immediate precursor that is included in the Uniform Controlled Substance Act and listed in various schedules with regard to its potential for abuse. Under the Uniform Controlled Substance Act, it is illegal for any person to possess, sell, manufacture, or deliver controlled substances. An offender convicted of a violation of the Uniform Controlled Substance Act (a VUSCA offense) will receive a standard sentence range based on the offender's prior criminal history and the seriousness of the current offense. In addition, in some instances judges have the option of sentencing offenders to the Drug Offender Sentencing Alternative program (DOSA). An offender may be eligible for the state's DOSA program if the current offense only involved a small quantity of drugs as determined by the court.

The Committee will review criminal justice sentencing options available for drug offenders who possess or sell controlled substances and those offenders who may be chemically dependent. In conducting the review the Committee will invite representatives from local law enforcement agencies, judges, defense attorneys, prosecutors, the Department of Corrections, the Department of Social and Health Services, and representatives from local drug and alcohol substance abuse and treatment programs to solicit views and technical assistance regarding possibly implementing quantity-based drug sentencing in Washington.

**Project Title:** State Interoperability Operations

**Project Goal:**

**Improve interoperability of public safety communications systems and identifiable benchmarks for achieving those goals.**

**Project Description:**

Interoperability is the ability for state, local, and federal agencies to communicate with one another through their radio systems. In 2003 the Washington State Information Services Board (Board) established the State Interoperability Executive Committee (SIEC) to promote statewide interoperability. The Washington State Patrol was appointed as the lead agency for SIEC interoperability operations in Washington. The goal of the SIEC is to coordinate the purchasing of all state wireless radio communications system equipment, to take inventory of and evaluate all state and local government-owned public safety communications systems, and to prepare a statewide public safety communications plan. The plan was to set forth recommendations for executive and legislative action to ensure that public safety communications systems can communicate with one another and conform to federal law and regulations governing emergency communication systems and spectrum allocation. The membership of the Committee, appointed by the Board, includes, but is not limited to, the following: the Washington State Patrol, the Military Department, the Department of Transportation, the Department of Natural Resources, the Department of Information Services, city and county governments, state and local fire chiefs, police chiefs and sheriffs, and state and local emergency management directors. The Committee will study the state's interoperability system, how multiple agencies respond to emergencies, and ways to improve interoperability communication across all levels of government in Washington.

**Project Title:** Domestic Violence Sentencing

**Project Goal:**

**Study and make recommendations for increasing punishment for repeat offenders committing domestic violence crimes.**

**Project Description:**

The crime of "domestic violence" generally occurs when one family or household member commits a crime against another. Domestic violence includes but is not limited to any of the following crimes: Assault in the first degree, Drive-by shooting, Reckless Endangerment, Coercion, Burglary, Criminal Trespass, Malicious Mischief, Kidnapping, Unlawful Imprisonment, Violation of the Provisions of a Restraining Order, No-Contact Order, or Protection Order, Rape, Residential Burglary, Stalking, and Interference with the Reporting of Domestic Violence.

During the 2008 legislative session HB 1220 was introduced which would have increased punishment for domestic violence offenders. The Committee will work in conjunction with the appropriate stakeholders to determine a resolution to dealing with chronic domestic violence offenders.

**Project Title:** Sexually Explicit Depictions of Minors on the Internet

**Project Goal:**

**Study and make recommendations regarding state statutes that relate to viewing and possessing child pornography over the Internet.**

**Project Description:**

A person who knowingly possesses visual or printed matter depicting a minor engaged in sexually explicit conduct is guilty of a class B felony. According to prosecutors, possession of child pornography on computer hard drives is more difficult to prove than the viewing of such material.

Bills were introduced during the 2009 legislative session that would have created the crime of Possession of Depictions of a Minor in the second degree, a class C felony. A person would be guilty of this crime if he or she intentionally engaged in a pattern of viewing over the Internet visual depictions of a minor engaged in sexually explicit conduct.

The Committee will review the proposed legislation and work with the necessary affected parties to determine whether similar legislation should be introduced in the 2010 legislative session.

**Project Title:** State v. Sutherby - Unit of Prosecution

**Project Goal:**

**Review the Unit of Prosecution statute as interpreted by the courts to determine whether a legislative "fix" to the Washington State Supreme Court's holding is warranted.**

**Project Description:**

The United States and Washington State constitutions protect a criminal defendant from being punished more than once for the same crime. A person generally may not be charged with multiple counts of an offense under one statute for the same conduct. In other words, the double jeopardy clauses prohibit multiple convictions if the defendant commits only one "unit" of the crime.

A person who knowingly possesses visual or printed matter depicting a minor engaged in sexually explicit conduct is guilty of a class B felony. Washington courts have recently considered the question of what constitutes a "unit" of the crime of Possession of Depictions of a Minor in the case of State v. Sutherby. In that case, the defendant was arrested pursuant to allegations that he had sexually abused his granddaughter, and after consenting to a search of two personal computers. Investigators discovered multiple images of minors engaged in sexual conduct and charged the defendant with 10 counts of possession of depictions of minors engaged in sexually explicit conduct. Upon conviction, the trial court determined that the proper unit of prosecution for this crime should be calculated based on the number of minors depicted in the images. For example, if 10 images were discovered and five different minors were depicted in the images, then five units of the crime may be charged. The Court of Appeals disagreed with this method of calculation and found the statute is ambiguous. The appellate court determined that the unit of prosecution must be determined based on the individual instances of possession of prohibited material, without regard to the number of minors depicted in the images.

In April, the Washington Supreme Court reviewed the case and interpreted the Possession of Depictions of a Minor statute, holding that the proper unit of prosecution under this crime is "one count per possession of child pornography, without regard to the number of images comprising such possession or the number of minors depicted in the images possessed."

The Committee will review the statute interpreted by the courts to determine whether a legislative "fix" to the Court's holding is warranted.

**Project Title: Federal Stimulus Update: Highways, Rail, and Ferries**

**Project Goal:**

**Update members on status of federal stimulus fund allocation, spending and grant applications.**

**Project Description:**

The American Recovery and Reinvestment Act (ARRA) provided approximately \$492 million to Washington for highway projects. Of that amount, about \$341 million may be spent by the state Department of Transportation (DOT) on projects that improve and preserve state roads. The remaining \$151 million is distributed to local governments via metropolitan planning organizations and counties. In addition, rail and ferries projects in Washington can compete for federal dollars through several grant programs, including urban, high-speed rail projects; discretionary grants; and ferry system grants. ARRA requires that at least half of the funds must be obligated within 120 days of enactment (which was February 21, 2009), and the remaining amount must be obligated within one year of enactment. For this reason as well as the fact that it was not possible to determine the precise cost of the projects, the state legislature authorized a list of stimulus projects with two "tiers." The first-tier projects are all expected to be constructed if possible; however, if for some reason the DOT cannot construct one or more of these projects within the given time-frame, or if additional stimulus funding is made available, the DOT is directed to build projects on the "second tier" project list.

During October Committee Assembly, the Committee will receive an update on the projects that have been funded by the federal stimulus and an update on projects in Washington that have applied for federal grants. The Committee will also be briefed on the costs of the projects that are completed or underway, whether the state is on track to meet the 120 and 365 day obligation deadlines, and whether any projects from the "tier two" lists of projects are expected to go to construction.

**Project Goal:**

Provide an update on the various link light rail projects.

**Project Description:**

The Committee will receive an update on the status of Sound Transit's link light rail lines and related projects approved by voters in the tri-county region (Snohomish, King, and Pierce) in 1996 and 2008.

In 2003, link light rail began operating in Tacoma, connecting the downtown to the city's transportation hub at the Tacoma Dome Station. A new link light rail line is scheduled to open in 2009 in two stages: a 13.9-mile segment from Westlake Station to the Tukwila International Boulevard Station will begin operating in July and a 1.7-mile extension to Seattle-Tacoma International Airport is scheduled to open by the end of the year. In November 2008, voters within the tri-county region approved expansion of the region's mass transit system, including an additional 36 miles of new light rail service.

This update is intended to inform the Committee about projected versus actual ridership, costs, and construction schedules of operating link light rail; the status of projects under construction and planned projects, including the University Link; and lessons learned from digging the Beacon Hill tunnel with a deep bore tunnel machine.

**Project Title:** Ferry Vessel Construction Update

**Project Goal:**

Update members on the status of Washington State Ferries vessel construction.

**Project Description:**

The 2009-11 transportation budget and its associated 16-year financial plan provided funding for the purchase of four vessels in the 2009-11 and 2011-13 biennia. The first three vessels will be Island Home class (64-auto) ferry vessels, and the fourth vessel will either be an Island Home class or a 144-auto ferry, depending on the timing and availability of funds. The budget begins funding for a fifth vessel, 144-auto capacity, in subsequent biennia.

During October Committee Assembly, the Committee will receive an update on the status of Washington State Ferries' vessel procurement program. By this time, Washington State Ferries is anticipated to be well into construction on the first Island Home vessel with an anticipated delivery date of June 2010, and to have issued an RFP for the second and third Island Home vessels.

**Project Title:** Joint Transportation Committee Toll Operations Study

**Project Goal:**

Update members on the results of the Joint Transportation Committee's Toll Operations Study.

**Project Description:**

Washington State recently returned to the use of tolling to pay for project construction when it financed the Tacoma Narrows Bridge. In addition, the state is experimenting with "congestion tolling" with the use of High Occupancy Toll lanes (or "HOT" lanes) on State Route 167. While tolling presents opportunities for financing construction projects and managing congestion, tolling also presents challenges in terms of operational complexities and costs. A recent Washington State Department of Transportation (WSDOT) study of tolling in other states found that in one case, more than half of the toll revenue collected was used for the costs of toll collection. In another case, 47 percent of the tolls collected were used for toll operations. The higher toll operations costs are, the less money is available for capital construction. Since the state is moving forward with plans to implement tolling on the State Route 520 floating bridge, the Joint Transportation Committee was tasked with convening an expert review panel to review the WSDOT's experience with and assumptions about tolling operations costs.

During December Committee Assembly, the Committee will receive a briefing on the Joint Transportation Committee's Independent Expert Review of toll operations costs. The review is expected to include analysis of transaction processing, operations and customer service, technology, toll enforcement, WSDOT administration, and the State Route 520 financial plan.

**Project Title: Federal Surface Transportation Funding Reauthorization**

**Project Goal:**

**Update members on the status of the reauthorization of the federal surface transportation authorization act (the ongoing source of federal transportation funds as differentiated from one-time federal stimulus funds).**

**Project Description:**

The federal Safe, Accountable, Flexible, and Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) will expire on September 30, 2009. The state currently receives allocations of federal funds authorized by the SAFETEA-LU through programs administered by the Federal Highway Administration and the Federal Transit Administration. The largest programs support bridge replacement and rehabilitation, capital and operating grants for transit agencies, flexible funds for state and local roads through the surface transportation program, formula funds for improvements to the national highway system, maintenance of the interstate system, and funds for congestion mitigation and air quality improvement. Current forecasts for federal funds to the state are expected to be \$962 million for the 2009-2011 biennium.

Based on current receipts, the Association of State Highway and Transportation Officials projects that the Highway Trust Fund can only support an \$8.7 billion nation-wide federal-aid highway program for federal Fiscal Year 2010 if the U.S. Congress does not act to increase transportation taxes or funnel more general tax revenues into the trust fund. This fiscal year, the federal-aid highway program was \$41 billion. The primary source of tax revenue for the Highway Trust Fund is gas taxes. Factors contributing to the revenue problem are the lack of an inflation adjustment to the tax and volatile gasoline prices which have resulted in declines in vehicle miles travelled and increased fleet fuel efficiency.

The discussion of reauthorization at the congressional level is addressing new funding sources (vehicle miles travelled fees, sales taxes on gasoline) as well as increases to the existing sources (additional gas taxes, indexing the gas tax). Additionally, the Congress is considering streamlining the funding streams to states, with the objective of reducing requirements that limit the ability of project sponsors to choose the best modal solution for transportation problems.

For the December Committee Assembly, invitations will be extended to Congressional staff, NCSL staff, and the Governor's Congressional Liaison for Transportation. The briefing to the Committee will address expectations for the types of funding streams, amounts of funding for Washington State, and the status of legislation. If the federal highway funding has been finalized, impacts on federal fund forecasts will be presented.

**Project Title:** Fuel Efficiency Standards

**Project Goal:**

Evaluate the impact to the state of proposed or adopted changes to vehicular fuel efficiency standards.

**Project Description:**

In 2005, legislation was enacted adopting vehicular emissions standards for greenhouse gases based on California's implementation of standards for vehicular greenhouse gas emissions that were adopted there in 2002. The California standards are not effective until the federal Environmental Protection Agency (EPA) grants a waiver allowing the state to regulate the emissions in a manner differently than the EPA. On January 26, 2009, President Obama directed the EPA to evaluate the waiver request. In addition, on May 19, 2009, the Obama administration proposed a new national policy on fuel economy standards and greenhouse gas emissions to accelerate the current federal policy to coincide with the California standards by 2016.

Changes to vehicular fuel efficiency standards would have broad implications for Washington consumers, businesses, and governments. For all drivers, the change in standards would mean improved vehicular emissions, as well as likely improved fuel economy. For government, the changes would facilitate achieving air quality goals, while at the same time likely reducing fuel tax revenues. An analysis of the impact to fuel tax revenues is essential for determining the amount of resources available from conventional sources in the near future. At the December Committee Assembly, staff will brief the Committee on the status of standards adoption and on the analysis of impacts to fuel tax revenues.

**Project Title: Transportation Revenue Update**

**Project Goal:**

**Update members on the November 2009 transportation revenue forecast.**

**Project Description:**

Washington law provides statutory direction for the preparation and adoption of economic and revenue forecasts. The forecasts are used by state policy makers to assess the availability of funding for current biennium appropriations and planning for transportation funding and projects over a 16-year horizon from 34 different transportation accounts. Each quarter the Transportation Revenue Forecast Council prepares a 16-year revenue forecast. The council is made up of representatives from: The Office of Financial Management; Office of the State Forecast Council; Office of the State Treasurer; House Transportation Committee; Senate Transportation Committee; Department of Licensing; Washington State Patrol; and the Department of Transportation.

The transportation appropriations for the 2009-11 biennium are \$7.518 billion and the revenues to support the budget is largely made up of motor vehicle fuel taxes; license permits and fees; ferry fares; tools; driver licenses and other related revenues; rental car tax; 0.3 percent sales tax on vehicles; and other miscellaneous revenues. For the remainder of the 16-year period, operating expenditures are projected using inflationary factors and transportation capital project lists.

For the December Committee Assembly, a transportation revenue update will be prepared and presented to the Committee. The questions to be answered are:

- How does the November 2009 forecast compare to the March 2009 forecast that was used to build the 2009-11 transportation budget?
- What are the current forecast trends and how will those trends affect current and future revenues?
- What are the time periods in which funding adjustments will need to be considered due to changes in projected revenues?

The Committee will begin building the 2010 transportation supplemental budget based on the November 2009 revenue forecast and will complete the budget based on the February 2010 revenue forecast.
