didn't hear all of the conversations but said she heard enough that it concerned her and she thought maybe these guys were planning some type of attack.

said she looked up Stewart Rhodes and Ryan Payne on google and found they were associated with the Militia and Oath Keepers. She said she recognized Stewart as the one doing most of the talking.
