Re: Return to Work Option for Retirees

At their November 20th meeting, the members of the PEPR coalition agreed to request that the SCPP support current legislation to address the needs of school districts, smaller counties and smaller cities to increase the availability of persons available for substitute, short-term contract, and project work.

Currently, retirees in PERS/SERS/TRS Plans 2 and 3 who elect to retire early using the 2008 early retirement factors lose their pension payment during any month in which they return to work for a public employer before age 65, making it financially impossible to accept periodic or short-term work. Other retirees in PERS/SERS/TRS can work up to 867 hours in a year before having their pension benefit suspended. These differences add complexity to our pension system, create inequities, and restrict quality personnel from filling critical needs of school districts and other entities.

Allowing early retirees to return to work under limited hours (867 is the maximum allowed for other DRS system retirees) would entail minimal costs to the State and yet help meet the needs that have been presented in writing and through testimony before the committee.

PEPR believes The Select Committee on Pension Policy (SCPP) should make a recommendation to the Legislature supporting, at a minimum passage of SHB 1737 which would help address the current shortage of substitute teachers school districts are experiencing. This bill passed the House during the 2015 session on a vote of 97:1.

School districts and smaller cities and counties have also identified issues with finding substitutes for classified school personnel positions and filling short-term positions in local governments. PEPR recommends that the SCPP consider expanding the positions and hours that could be covered under the provisions of SHB 1737 to include other school personnel and other local government employees.

We are pleased to see SCPP will be having a public hearing on SHB 1737, and urge the committee to act favorably on legislation addressing these needs and make a formal recommendation for legislative action.
