Our office, the Legislative Information Center, (LIC), maintains a listing of rentals for Legislative members, and staff, to rent for the session. Forms returned after December will not be included in the 2023 listing.

Changes of your rental such as price, can also be made during those months. We do not update the listing during interim.

If you have rented your property with us previously you will still need to complete this new form and send it to us no later than December. If we don't hear from you, your property will not appear in the 2023 listing.

The listing is posted on the House and Senate Intranet which is accessible by legislative members and staff only. This listing is not posted on the public website.

In order to keep our housing listings current please let us know when your rental is no longer available.

Please note that the sooner you place your rental on the list the better your opportunity to rent your property.
