

# Summer Intern Program

**Essential Information** 

#### Intern activities

Interns are generally assigned to one of the standing committees of the State Senate. Interns will conduct non-partisan legal, fiscal, and policy research for the committees, and may be asked to draft legislation and give presentations before the committees.

#### Nonpartisanship

Nonpartisanship is an essential distinguishing characteristic of SCS staff. We provide the same high-quality service and put forth the same effort for all senators regardless of political belief, affiliation, or rank. To ensure the appearance of nonpartisanship, staff should avoid public conduct that might lead an observer to believe we cannot provide impartial service to each senator.

## Training and education opportunities

An orientation will provide information on legislative organization and process. Regular seminars are held with state agency directors, lobbyists, judges, and appointed or elected officials.

Interns draft, analyze, and present bills at a mock hearing modeled after committee hearings held during the legislative session.

## Eligibility

Senate Committee Services actively recruits first-year and second-year law students, and first-year graduate students in public administration and other relevant programs.

#### Intern selection

Interns are selected based on demonstrated oral and written communication skills, research and analysis skills, interpersonal skills, and interest in public service.

# Internship length

The internship lasts a total of 10 weeks. Interns may choose a start date in June that works best for their schedule. Remote work options are currently available. Interns should expect to attend in person for a 1-2 week long bill drafting workshop.

## Compensation

Interns are paid up to \$3,637 per month. Interns do not receive additional employee benefits or paid time off.

#### Committee assignments

Interns are assigned to committees primarily based on the needs of the Senate. However, interns' personal interests are considered to some degree if assignments are available with the respective committees. Interns are typically assigned to 1 or 2 committees for the 10-week period. The committees currently include the following:
