- Use a variety of qualitative and quantitative research methods including legal research, statistical and economic analysis, interviews, surveys, performance measurement, and organizational assessment.
- Follow professional auditing standards to provide independent, objective, and accurate information that informs legislative decisions.
- Present findings and recommendations to legislators.
- Network! Interns work with JLARC analysts and staff from other legislative and executive branch agencies.
