When the Legislature is not in session the Hotline is open from 8 a.m. to 12 p.m. and 1 p.m. to 4:30 p.m. Monday through Friday.

The Hotline staff will also fulfill requests for bills and other legislative documents and can answer questions about the status of bills, committee meeting times and places, pending legislation and the legislative process.
