WHEREAS, The church has been a welcoming and inclusive community, committed to serving all in love;

NOW, THEREFORE, BE IT RESOLVED, That the House of Representatives hereby recognize and celebrate the 120th anniversary of Blaine Memorial United Methodist Church; and

Representative Barnard will replace Representative Volz as the ranking member of the Technology, Economic Development, & Veterans Committee. Representative Volz will remain on the committee.

There being no objection, the House adjourned until 9:55 a.m., Friday, January 24, 2025, the 12th Day of the 2025 Regular Session.
