MORNING SESSION

Senate Chamber, Olympia Wednesday, March 19, 2025

The Senate was called to order at 10:45 a.m. by the President of the Senate, Lt. Governor Heck presiding. No roll call was taken.

JOINT SESSION

The Senate was called to order at 11 o'clock a.m. by President Heck.

The Sergeant at Arms, Mr. Andy Staubitz, announced the presence of the House of Representatives at the Chamber door.

The President called upon the Sergeant at Arms of the Senate and the Sergeant at Arms of the House to escort the Honorable Laurie Jinkins, Speaker of the House, to a seat on the rostrum. Members of the House were invited to seats within the Chamber.

Pursuant to Senate Concurrent Resolution No. 8403, the President called the Joint Session to order. The Secretary called the roll of the members of the Senate. The Secretary called the roll of the members of the House of Representatives. The President declared that a quorum of the Legislature was present.

The President welcomed and introduced the following honored guests and elected officials who were present on the dais: Supreme Court Justice Sheryl Gordon McCloud, Supreme Court Justice Salvador A. Mungia, Secretary of State Steve Hobbs, Insurance Commissioner Patty Kuderer, and State Treasurer Mike Pellicciotti.

The Sergeant at Arms Honor Guard was composed of personnel of the Washington State Patrol. The Honor Guard consisted of: Trooper Kyle Flaig, Sergeant Jeffrey Bridges, Trooper Matthew Gagley, Trooper Michael Farkas, and Trooper Dean Gallanger.

Page Mr. Henry Newlean led the Joint Session in the Pledge of Allegiance. Mr. Newlean is the grandson of Senator King.

Councilmember Jeremy Takala from the Yakama Nation offered the invocation.

INVOCATION

Councilmember Takala: "[*rings bell*] (Yakama language to be sent by Mr. Takala) This morning it's an honor to be here with our distinguished guests, the House, the Senate, speakers, families and relatives, and friends. My name is Jeremy Takala. I come from the Yakama Nation that consists of the 14 tribes and bands in central Washington state. It is an honor to be here to join many of us here who are in mourning, who are remembering our loved ones who have passed on, but yet to continue as we go forward to share the stories, to follow the footsteps of those that have made this state, this region a better place for our people. That today I would like to share a song and open in the way here in honor of those who have passed on but also for the strength and guidance and inspiration that each of us need in our day to day walk. At this time I would like to share a song, we'll go three versus with the bell.

[rings bell and sings]

I just want to thank our relatives, our friends here for this time to be here to join each and every one of you and to share a little bit of a prayer here that has sustained our people since the beginning of time. And as we lose people we know that they are still with in our heart, they live with in our hearts, our minds and in our body. That each day that we take a step, we wake up, we

give thanks for a new day to be amongst our friends, our colleagues, our folks that we work with and to celebrate life and to enjoy the companionship, the relationship for one another here in this space. And that we look forward to the seasons, as they come the Spring is coming. For our people this is a very special time but yet we never forget those that have passed on. That we are thankful for each day, each season, and each year. So, I share this much and to give a little bit of strength and guidance with the song here that has shared with our people for many of the different ceremonies to take care of us and to share this teaching to our children. So, thank you for your time and I will ring the bell three times to close out this section.

REMARKS BY THE PRESIDENT

President Heck: "Honored statewide elected officials, justices of the supreme court and members of the legislature, ladies and gentlemen, family members and visitors:

The purpose of the joint session is to conduct a memorial service in memory of members of the legislature who have passed from among us. This has been our longstanding custom: indeed, for more than a century the Senate and House have met as we meet today -- to pay special and fitting tribute to the lives and service of these valued public servants.

Despite the abundant work that we have before us, we pause upon this sad occasion and reflect upon the course we have traveled and pay homage to the disappearing generations of men and women who aided in strengthening and multiplying the powers and opportunities, the pleasures and possibilities of the people who constitute this great state. It's a somber occasion. In some way sobering. Every single person sitting at this floor, every one of you, will someday have a bell rung for you and a candle lit for you in this chamber. And looking out at this group it is evident that the overwhelming majority of you have way more yesterdays than you do tomorrows.

Just a fact.

But the point is, let that sober reality steel your resolve that one of the ways in which you will honor the memory of the men and women who we are here today to acknowledge. Let that steel your resolve to do your very best, to uphold that sacred oath of office that you took not that long ago. It is in the best tradition of honoring them if we do that.

On behalf of the Senate and the House of Representatives, I would like again to extend a warm welcome to the family members, friends and colleagues who have joined us today and offer our deepest sympathies for your loss."

Trooper Dean Gallanger performed "Amazing Grace" on the bagpipes.

The President introduced Speaker Laurie Jinkins.

REMARKS BY THE SPEAKER

Speaker Jinkins: "We gather today to commemorate the lives of the distinguished former members of the Washington State Senate and House of Representatives who have passed from among us. The people of our state are grateful for their public service.

Elder Brown: "Father God, We thank You for this time together today to remember those that You have allowed to serve before us. We thank You for this opportunity to reflect on those who have made the ultimate sacrifice and many sacrifices along the way. For those family members who have stood beside them along the way, that have inspired us God, to continue to go forth. Inspired us that we must continue to do this together, and that together we win. They have ran their race. They have finished their course. They have fought the good fight. And we thank You for the strength and inspiration we have now to go forth and to win, united.

In Jesus name we pray.
