Diane,

I'm happy to help where I can, but there's probably not a lot of information available. For example, there is no official work plan for session. In fact, the SCPP almost never meets during the legislative session. They have the authority to call special meetings, but those are rare. The next regularly scheduled meeting is May 20, 2025.

Staff is working on final summaries of the SCPP's work from this interim (including bill drafts the committee recommended), and we anticipate posting them <a href="here">here</a> in the next few weeks. I've also attached the slides from a presentation that went out to members (via email since the December meeting was cancelled) explaining the limitations on staff support during the legislative session.

That's about all I know, but if you'd still like to talk I'm available 8-2pm tomorrow, or 8-10am on Wednesday.
