The House was called to order at 9:55 a.m. by the Speaker (Representative Fitzgibbon presiding).

Reading of the Journal of the previous day was dispensed with and it was ordered to stand approved.

WHEREAS, On January 29, 2025, Harry R. Anderson of Bainbridge Island, Washington, became the first person in history to both fly and sail solo to all seven continents; and

WHÉREAS, Harry has flown solo in his small, single-engine airplane, a Lancair Columbia 300, tail number N788W, around the world twice, once eastbound in 2011 and once westbound in 2019. Harry has been awarded Circumnavigator Diplomas from the Federation Aeronautique Internationale (FAI) in Switzerland for those flights; and

WHEREAS, On January 31, 2014, Harry landed his aircraft in Antarctica, becoming only the fifth person to fly solo to all seven

WHEREAS, On July 16, 2018, Harry flew solo in his aircraft over the North Pole from Resolute, Canada, to Longyearbyen in the Svalbard Islands, Norway. A transpolar flight of 10.5 hours covering more than 1,600 nautical miles; and

WHEREAS, On January 29, 2025, Harry arrived back in the United States of America, completing his solo voyage to all seven continents and a circumnavigation of the earth. He spent 350 days at sea, traveling over 38,000 nautical miles on his 43-foot sailboat, an Allures 40.9 named *Phywaye*; and

an Allures 40.9 named *Phywave*; and WHEREAS, Harry's courageous solo flying and sailing achievements can serve as an inspiration to other adventurers in the State of Washington and around the World;

NOW, THEREFORE, BE IT RESOLVED, That the Washington State House of Representatives recognize and honor the flying and sailing achievements of Harry R. Anderson, and

WHEREAS, In the spring of 1975, the withdrawal of American troops from Vietnam and the reduction of aid displaced hundreds of thousands of Southeast Asian refugees; and

WHEREAS, In response, Governor Daniel Evans of Washington state recognized the humanitarian crisis and took decisive action to welcome refugees seeking safety and new opportunities; and

WHEREAS, President Gerald Ford initiated Operation Babylift to bring Vietnamese orphans to the United States, with a Pan Am 747 carrying 407 orphans landing at Seattle-Tacoma International Airport on April 6, 1975; and

WHEREAS, Washington Secretary of State Bruce Chapman emphasized America's moral obligation to support displaced people and provide them with opportunities for resettlement; and

WHEREAS, Governor Evans declared Washington's readiness to accommodate refugees, creating a task force to oversee their resettlement and ensure their successful integration; and

WHEREAS, On May 20, 1975, the first group of 34 refugees arrived at Camp Murray, where pre-World War II cottages were refurbished to provide temporary housing; and

refurbished to provide temporary housing; and
WHEREAS, The Washington community demonstrated
extraordinary support by donating resources, volunteering, and
establishing host family programs; and

WHEREAS, President Ford provided support for the nationwide relocation of refugees and appointed Governor Evans to a Presidential Refugee Advisory Committee; and

to a Presidential Refugee Advisory Committee; and
WHEREAS, By Christmas 1975, 4,052 Southeast Asian
refugees had settled in Washington, making it home to the fifthlargest Indochinese refugee population in the United States; and

WHEREAS, Additional waves of Indochinese refugees, including 1.6 million *Boat people*, resettled to third-party countries between 1975 and 1997; and

WHEREAS, Upwards of 600,000 individuals lost their lives due to economic sanctions and political persecution; and

WHEREAS, Recognizing the ongoing need for support, refugee leaders convened in 1977 for the first conference focused on continued assistance and integration efforts; and

WHEREAS, A third wave of refugees resettled in the 1980s, further enriching the cultural and economic fabric of Washington State; and

WHEREAS, Governor Evans declared that closing the door to refugees would be "the worst kind of hypocrisy," reaffirming Washington's long-standing commitment to humanitarian efforts and inclusion;

NOW, THEREFORE, BE IT RESOLVED, That the Washington State House of Representatives commemorate the 50th anniversary of the Vietnamese, Lao, Cambodian, and Hmong refugee resettlement in our state; and

BE IT FURTHER RESOLVED, That Washington State continue to uphold the values of compassion and inclusion and support refugees who seek safety, a bright future, and the promise of America.

WHEREAS, He played a key role in building Washington's sports community, known for his effectiveness, smile, positive attitude, humor, and wit with segments like the KING 5 "Wrestling Hold of the Week"; and

WHEREAS, In 2004, he joined the Seattle Seahawks as the Digital Media Host and was the on-camera host for the Seattle Sounders; and

WHEREAS, His work behind the scenes to support local businesses and his countless community service activities often went unnoticed or unknown; and

WHEREAS, Throughout his over 40-year career in the media, Mr. Ventrella still found time to speak at nonprofits, schools, churches, and assisted living centers, and volunteer in his community by starting a community theater program, hosting fundraisers, mentoring young people, and staffing the local fruit and produce stand in Newcastle; and

WHEREAS, After four decades in broadcasting and community service, Mr. Ventrella served on the City of Newcastle Community Activities Commission from 2016 to 2019, was elected to the Newcastle City Council in 2020, and served as Deputy Mayor until 2021; and

WHEREAS, In 2022, Mr. Ventrella continued his lifelong career of connecting Washingtonians through storytelling, doing interviews with elected leaders and community members for King County TV's "Community Conversations" program; and WHEREAS, Mr. Ventrella passed away from cancer on

WHEREAS, Mr. Ventrella passed away from cancer or October 19, 2024, at the age of 80; and

WHEREAS, He is remembered by one of his favorite quotes, "People may forget what you say to them, but they will never forget how you made them feel";

"NEW SECTION. Sec. 1. (1)Washington state institute for public policy must conduct a study regarding Washington state's current system of alcohol taxes and fees and alcohol administrative fees and produce a final report as described in this section.

(2) The final report must include the following information:

(a) The specific types of state alcohol taxes and fees applicable to spirits, beer, and wine, by product category, and including general taxes such as sales and business and occupation taxes;

(b) Current and historical alcohol tax

and fee rates by tax or fee type;
(c) Annual sales in the state of spirits, wine, and beer in total and per capita from 2015 to 2024;

(d) Annual spirits, wine, and beer tax and fee revenues generated in the state from 2015 to 2024 in total and by tax or fee type;

(e) Annual spirits, wine, and beer tax and fee revenues per capita generated in the state from 2015 to 2024 in total and by tax or fee type;

(f) To the extent practicable, all of the

following:

(i) An analysis of total and per capita spirits sales and related alcohol tax and fee revenues in other states, differentiated by whether the sale of off-premises spirits is controlled by the state or allowed by licensed private entities;

(ii) An analysis of total and per capita sales and related tax and fee spirits revenues in other states and countries differentiated by whether spirits taxation based on volume, price, alcohol or content;

(iii) An analysis of total and per capita spirits, beer, and wine sales and tax and fee revenues in this state and other states by each applicable unit of measurement of alcohol content and volume, differentiated by product category;

(iv) An analysis of administrative fee amounts to determine the sufficiency of each fee to cover reasonable costs for efficient administration enforcement. This shall include for either increases recommendations or decreases in any alcohol administrative fee pursuant to the findings of the study;

(v) An analysis of the impact of alcohol and fees on prices and consumer taxes consumption;

(vi) The information required in (c), (d), and (e) of this subsection ranging from 2008 to 2020;

(vii) Estimated costs to transition to an alcohol tax system in the state where alcohol tax rates are determined solely by the alcohol content of products, the estimated annual costs to administer this system, and the estimated tax revenue of this system;

(viii) Estimated tax rates for spirits, beer, and wine that would have to be applied to maintain a revenue neutral tax system in the state if tax rates were based solely on

the alcohol content of products; and

(ix) An analysis of the economic impact of the state's breweries, wineries, and distilleries, and potential changes to the economic impact if alcohol tax rates were based solely on the alcohol content of products. For the purposes of this subsection, "economic impact" includes the number and average wage of local jobs.

(3) The Washington state institute for public policy must submit a final report to the relevant committees of the legislature

by June 30, 2026.

- (4) The liquor and cannabis board and department of revenue must cooperate with the Washington state institute for public policy to provide data relevant to this study.
- (5) The definitions in this subsection apply throughout this section unless the context clearly requires otherwise.
- (a) "Alcohol taxes and fees" means alcohol taxes and fees where the amount of the tax or fee is based on the sales price, sales volume, or alcohol content of an alcohol product; and
- (b) "Alcohol administrative fees" means any liquor license, liquor permit, or liquor endorsement fee set either by statute or by rule and administered by the liquor and cannabis board, including fees for retail licenses.
 - (6) This section expires July 1, 2026."
