AN ACT Relating to increasing the accessibility of a required school director governance training program by making it available at no cost and virtually; and amending RCW 28A.345.120.

AN ACT Relating to solid waste and establishing the local government solid waste assistance account; amending RCW 82.18.020 and 82.18.040; and adding a new section to chapter 82.18 RCW.

<u>HB 2019</u> by Representatives Street, Walen, Ormsby, Macri, Pollet, Ramel and Scott

AN ACT Relating to making the estate tax more progressive; amending RCW 83.100.040; reenacting and amending RCW 83.100.020; creating new sections; and declaring an emergency.

AN ACT Relating to compensation in frontier one counties for deer and elk damage; and amending RCW 77.36.100.

AN ACT Relating to authorizing fire protection districts to dissolve existing civil service systems with approval from the civil service employees; and amending RCW 52.30.040.

AN ACT Relating to partial confinement eligibility and alignment; amending RCW 9.94A.030, 9.94A.030, 9.94A.6551, 9.94A.733, 9.94A.728, and 72.65.210; creating new sections; providing an effective date; and providing an expiration date.

SB 5223 by Senators Wagoner, Holy and Nobles

AN ACT Relating to criminal offense fingerprinting; and amending RCW 10.98.050 and 43.43.735.

AN ACT Relating to nonresident vessel permits; amending RCW 88.02.620 and 88.02.640; providing an effective date; and providing an expiration date.

SSB 5282 by Senate Committee on Law & Justice (originally sponsored by Wellman, Dhingra, Frame, Krishnadasan, Nobles, Riccelli, Saldaña, Trudeau, Valdez and Wilson, C.)

AN ACT Relating to reestablishing the advisory board for the missing and exploited children task force; and adding a new section to chapter 13.60 RCW.

Referred to Committee on Community Safety.

ESB 5313 by Senators Pedersen, Goehner, Cleveland, Hasegawa, Nobles and Valdez

AN ACT Relating to adding to the list of provisions prohibited from rental agreements; and amending RCW 59.18.230.

Referred to Committee on Housing.

ESB 5471 by Senators Goehner, Bateman, Chapman, Frame, Liias, Nobles and Saldaña

AN ACT Relating to authorizing middle housing in unincorporated urban growth areas, certain limited areas of more intensive rural development, and fully contained communities; reenacting and amending RCW 43.21C.495 and 36.70A.280; and adding a new section to chapter 36.70A RCW.

SJM 8008 by Senators Krishnadasan, Pedersen, Hasegawa, Nobles and Trudeau

Rescinding prior applications for a constitutional convention to propose amendments to the Constitution of the United States.

Referred to Committee on State Government & Tribal Relations.
