The minutes for the June 12, 2023, Board meeting were approved.

There were two Employment Disclosure forms reviewed. Both of the forms were filed by Rep. Kristine Reeves. One form involved her consulting firm's work as a subcontractor with CSE who is submitting a proposal with the Department of Commerce. The Board saw no conflict with this employment disclosure. The second disclosure form involved work as a subcontractor with CSE but the proposal would be submitted to the Joint Transportation Committee. The Board was concerned about the inherent conflict with a legislator's consulting firm working with a legislative agency. Board counsel was directed to convey the Board's concern to Rep. Reeves.

The Board reviewed the Board's 21-23 budget expenditures. Tom Hoemann indicated that the Board ended the fiscal year with a \$77,000 balance. The proposed 23-25 budget was discussed and Board counsel was directed to provide that budget to the members for their review.

The Board continued its discussion about the Advisory Opinions analyzing RCW 42.52.120. It was decided that Board counsel should work on a definition of the term "beneficial interest" as that term is used in the opinions and not defined.

The Board discussed the Summary of Advisory Opinion 2023-1. This request was submitted by the Office of Legislative Labor Relations. Board counsel drafted suggested answers to the questions posed in the request. The Board discussed opining that the professional lobbyist retained by the union selected to represent the employees could lobby the legislature but the individual legislative employees would continue to be prohibited from lobbying as provided in *In*

re House and Senate Staff, 2022 – No. 11. Board counsel was instructed to prepare a draft opinion which will be discussed at the Board's next meeting in September.

The Board discussed Board Rule 1 (C)(1) which provides that complaint investigations will be limited to the allegations contained in the complaint. The Board agreed that this Rule was appropriate at the time it was passed almost 30 years ago but to follow the letter of it would require the Board to ignore violations that have arisen as part of an investigation into the allegations in the complaint. It was suggested that a subcommittee should be formed to look at all of the Board's rules. The chair will work with Board counsel to arrange such a subcommittee.

There was no public testimony.

The Board moved into executive session to discuss pending complaints.

The Board discussed the latest draft of Advisory Opinion 2023 – No. 1. There was some concern expressed that the language in response to Question 6 in the draft was not clear enough. Board counsel was instructed to edit that section to clearly state that whatever duties the EEB opinion allows should be clearly stated in our opinion as being permitted activities.

Member O'Ban raised the issue of the ability to issue a separate opinion in this matter as he disagreed with the majority on some of the responses to the questions. The Board discussed the ability of a member to issue a separate opinion in an Advisory Opinion. There is nothing in the rules that would prohibit it and the board determined that the procedures governing the circulation of a separate opinion in a complaint opinion should be followed in this matter.

A motion was made to adopt the draft *Advisory Opinion* 2023 – No. 1 as written including the new language to be drafted by Board Counsel. The motion was seconded but not voted upon. Member O'Ban moved to divide the question and Member Hoff seconded the motion. The following are the votes for each question posed in the Advisory Opinion request:

LEGISLATIVE ETHICS BOARD MINUTES December 4, 2023 Meeting Held Virtually

The chair called the meeting to order at 9:05 am.

The minutes for the October 27, 2023 Board meeting were approved.

There were no Employment Disclosure forms to review.

The Board discussed the proposed changes to the Rules. Board counsel reviewed with the Board the substantive changes to the proposed rules that had been made since the last Board meeting in October. Those changes were reflected in the chart of rule changes prepared by Board counsel. One of those changes in the proposed rules is that only Advisory Opinions unanimously supported by the Board members would be published. Sen. Pedersen remarked that advisory opinions are designed to provide future guidance on ethics issues and are not terribly useful if the Board is divided in its response.

Jeannie Gorrell raised some concern about the elimination of Example 3 in the proposed rules. The Board indicated that the example was eliminated because it did not reflect current practice. The Board determined that the example would be updated to reflect the current practice and left in.

Sen. Gildon commented that the terms "confidential report" in Rule 1 probably is not of much value in light of the Supreme Court's decision regarding the legislature's responsibilities under public disclosure law. He suggested that that phrase could be replaced with "attorney-client privilege." There was some discussion that Board counsel does have an attorney client privilege with the board and that relationship can be raised in possible public disclosure requests.

The Board continued its discussion of Advisory Opinion 23-1. Member O'Ban clarified that his dissent applied to the entire proposed majority opinion not just to a particular question in the Advisory Opinion Legislative Ethics Board Meeting Minutes

request. Sen. Pedersen stated that although the proposed rule change requiring that advisory opinions be unanimously agreed to has not yet passed, and because the report by the Office of Legislative Labor Relations (OLLR) (to which this opinion was to have assisted) has already been submitted, there is no benefit at this point to publish this advisory opinion. Sen. Pedersen moved to not issue an opinion on this request; Member O'Ban seconded the motion. The vote on the motion was 5 for and 2 against. Board counsel was instructed to draft a statement explaining the Board's decision to OLLR which shall also be posted on the Board's website. The statement is to be circulated to all Board members for comment before being posted.

The Board discussed Rep. Corry's response to the Board's request for further information. Changes in the position description submitted by Rep. Corry appear to be responsive to the request for further information by the Board. No further action to be taken at this time.

The Board discussed the recently received request for an Advisory Opinion 2023-3 from House Counsel. Board counsel summarized the request. The chair deferred further discussion of the opinion request to executive session.

There was no public testimony.

The public portion of the meeting was adjourned at 10:05 am.

The Board moved into executive session to discuss pending complaints.
