

#### PREFACE

This "Pictorial Directory of 1951 Washington State Legislature" is designed to provide biographical material about the members of the legislature and its officials for the information of the general public.

Many states publish official "Blue Books" containing information about their public officials. Since lack of funds makes this impossible in Washington, we offer this smaller volume.

I hope that members of the 32nd Legislature will find this a useful reference work and a memento of their service in this body.

#### The State Legislature

The legislature is the paramount branch of American government. It makes the state laws, controls the expenditures and determines the duties which the administrative authorities perform.


Without action by the state legislature, there would be no elections, no registration, no public schools and no municipalities.

It regulates the citizen's civil rights and duties, secures him in the tenure of his property, and makes most of the rules that govern his daily movements.

In this sense, the state legislature is the pivot of our entire governmental system.

ARTHUR B. LANGLIE (Republican) was born in Lanesboro, Minnesota, July 25, 1900. Moving with his family to Bremerton, Washington, in 1909, he was educated in the Bremerton public schools and the University of Washington. Working his way through the University, he was graduated from its law school in 1926.

After nine years in private law practice in Seattle, he began his career of public service in 1935 as a Seattle city councilman. Elected mayor of Seattle in 1938, he was re-elected by the largest majority in the city's history in March, 1940. He was elected governor of the State of Washington in November, 1940, and served in that post until January, 1945.

Immediately after leaving office, Governor Langlie went into active duty in the United States Navy and served in the Pacific theatre of operations. He was elected to his second term as governor in November, 1948, and inaugurated January 12, 1949. Governor Langlie was married in 1928 to Evelyn Baker, and they have two children--Arthur Sheridan and Carrie Ellen.

#### The Lieutenant-Governor



VICTOR A. MEYERS (Democrat) born in Little Falls, Minnesota, September 7, 1898, came to the State of Washington in his early youth and through his interest in music he became a member of several orchestras, finally achieving nation-wide renown as a leader of his own orchestra.

In 1930 he entered politics as a candidate for mayor of Seattle and though strictly a "dark horse" put on such a colorful campaign that he ran a strong third in the race. In 1932 he won the nomination on the Democratic ticket for Lieutenant Governor and was elected in the great Democratic landslide of that year. He was re-elected in 1936, 1940, 1944 and 1948 and is now in his 19th year of office, holding the distinction of being the oldest Lieutenant Governor in point of service in the United States.

Mr. Meyers is a member of the Elks, Eagles, Knights of Columbus, Youngmen's Business Club, Seattle Chamber of Commerce and the 101 Club. His recreation favorities are golf, tennis and sail boating. His long years as presiding officer of the State Senate have made him a recognized expert in parliamentary procedure.

# The Secretary of State



EARL COE (Democrat) was born in Minneapolis, Minnesota, on September 12, 1892 and was educated in the public schools of that city. He was married to Byrdie Miller on November 20, 1912.

Greatly impressed by the spectacular natural beauty of Washington and by the future prospects of the State, following a visit to the Alaska-Yukon Exposition in Seattle, Mr. Coe brought his bride to this State in 1913.

Mr. Coe engaged in various enterprises in the State including orchards, cold storage and shipping and lumbering. In 1938 he was elected State Representative from the 16th District, comprising Skamania, Klickitat, Benton and Franklin Counties and was elected State Senator in 1944. In 1946 he was the unsuccessful candidate for Congress in the Fourth District, following which he was named State Democratic Chairman. Following the death of Belle Reeves, Secretary of State, Mr. Coe was named to the vacancy by Governor Mon Wallgren and was elected to the post in 1948 by a majority of more than 136,000 votes.

#### The State Treasurer



TOM MARTIN (Democrat) was born in Hoquiam, Washington, in 1899 and was educated in the schools of Grays Harbor and Lewis County and attended the University of Washington. A charter member of the American Legion, Mr. Martin is a veteran of the First World War.

Mr. Martin first entered politics in Lewis County following a career of school teaching. He was elected County Auditor of Lewis County and was then named Deputy State Auditor by Cliff Yelle, a position which he held for many years. In 1945 he was named Director of State Parks, serving in that capacity until he resigned to run for the office of State Treasurer.

He is a member of the Masons, Scottish Rite, Shrine, Grange, Kiwanis and Boy Scouts. He has also been prominent in school affairs serving as president of the Chehalis Education Association, as a member of the Board of Regents of Centralia Junior College, and as a member of the Olympia School Board.

#### The State Auditor



CLIFF YELLE (Democrat) is now in his 5th term as State Auditor of the State of Washington. Mr. Yelle's first elective office was that of Auditor of Whitman County. He was first elected to the position of State Auditor in 1932. During the 18 years that he has held the office, the Legislature has named him examiner for nearly 100 additional state offices, departments and bureaus. Mr. Yelle's office now examines all state, county and municipal divisions of government. In addition, his office audits all state vouchers and pay rolls and issues upwards of 1,550,000 warrants annually, covering all state appropriation expenditures and keeping control ledger accounts for all elective and appointive offices, commissions, boards and departments including the State Legislature.

Mr. Yelle enjoys the distinction of being the only man from the western section of the United States who has been elected President of the National Association of State Auditors, Comptrollers and Treasurers and is at present a member of the executive committee of the National Association.

## The Attorney-General



SMITH TROY (Democrat) was born in Olympia, Washington, where he received his public school and high school education. He is a graduate of the University of Washington Law School, where he was active in varsity athletics and was president of the student body. Admitted to the Bar in 1930, he was deputy prosecuting attorney of Thurston County from 1931 to 1934 and Prosecutor from 1934 to 1940.

He was appointed Attorney General by Governor Clarence D. Martin in June, 1940. He was re-elected in 1944 in absentia while serving overseas as Judge Advocate of the 30th Infantry Division, First Army and was again re-elected in 1948. He is a member of the Washington State and American Bar Associations and of the executive committee for the Western Division, National Association of Attorneys General.

Smith Troy comes from a prominent Democratic background, his father, the late P. M. Troy, a well-known Olympia lawyer, having been a Democratic Party leader from pioneer days and his uncle, John Troy, having been governor of Alaska. Mr. Troy was the first president of the Thurston County Democratic Club in 1932 and was the keynote speaker at the 1942 Democratic State Convention. He is married and has one daughter, Stephanie.

# The Superintendent of Public Instruction



MRS. PEARL WANAMAKER (Non Partisan) has established a distinguished record in the public life of the State of Washington. She was first elected a member of the House of Representatives in 1928 and served in the sessions of 1929, 1933, 1935 and the special session of 1934. She was elected to the State Senate in 1936 serving in the legislative sessions of 1937 and 1939. In 1940 she was elected Superintendent of Public Instruction and has served in that capacity ever since.

Mrs. Wanamaker was a member of the post-war Educational Mission to Japan to study the educational system. She is a member of the United States Commission for UNESCO and was advisor to the United States delegation to UNESCO at its first conference held in Paris in 1946. She is a member of the Advisory Committee of the Legislative Commission of the National Education Association, President of the State Board of Education and Chairman of the State Board of Vocational Education.

## The Commissioner of Public Lands



JACK TAYLOR (Democrat) was born in Brainerd, Minnesota, June 17, 1906. He moved with his family to Seattle, Washington, and was educated in the Seattle schools.


Operating a successful grocery business, he was for eight years elected President of the Price-Rite Independent Grocers in this State. In 1934 he entered public service and by overwhelming vote was twice elected as County Commissioner of King County and served as chairman of County Commissioners.

He was elected Commissioner of Public Lands in November, 1940 and served for four years, after which he was appointed director of the newly created Pollution ControllCommission for a four year term. He was elected to his second term as Commissioner of Public Lands in November, 1948 and took office January 12, 1949. Commissioner Taylor is married and has one child.

# The Insurance Commissioner



WILLIAM A. SULLIVAN (Democrat) was born in Ireland, migrating to the United States. He first secured the post of inspector in San Francisco for the pioneer firm of Pope and Talbot and subsequently engaged in the insurance and real estate business. In 1917 he entered active war time service in the United States Aviation Corps, serving until 1919. Upon his return to civilian life, Mr. Sullivan re-entered the insurance and real estate business as President of William A. Sullivan and Company. In 1922 he organized the Continental Mutual Savings Institutions in Seattle, of which he was Secretary until 1928. In 1932 Mr. Sullivan was elected to the office of State Insurance Commissioner and was re-elected in 1936, 1940, 1944 and 1948. Mr. Sullivan was accorded nation-wide recognition in 1936 through his election as National President of the Insurance Commissioners of the United States.

BARGREEN, HOWARD (Democrat), Senator from the 38th District, Snohomish County, was born at Everett in 1906 and is 44 years of age. He was first elected to the Senate in 1940, serving 2 terms. In 1941 he served as Chairman of the Commerce and Manufacturing Committee and in 1943 of Liquor Control, as in 1945. He is a graduate of the University of Washington and is a merchant in Everett. He is affiliated with the Elks, Mason, Redman, Sons of Norway, Yacht Club and Rotary. Was married in 1931 and has four children, Sharron, Claudette, Tom and Howard.





BARLOW, RUSSELL C. (Republican) Senator from the 26th District of Pierce County, was born in Tacoma in 1893 and is 57 years of age. First elected in 1950 he is serving his first term in the Senate. Attended the Tacoma Public Schools and then receiving his B.S. Degree in 1915 from the University of Washington. He is President of C.S. Barlow & Sons, Inc. Building Materials. Served as a 1st Lieutenant in World War I. He is affiliated with the Mason, Scottish Rite, York Rite, Shrine, Elks club and Sigma Alpha Epsilon fraternity. Married in 1917 he has three children, Robert C., Mrs. Anne Finnigan, William R.

BROWN, VAUGHAN (Democrat) Senator from the 42nd District of Whatcom County was born at Bellingham in 1893 and is 57 years of age. He holds an A.B. Degree from the University of California, is a graduate of the University of Washington and is an attorney. He served in the first World War from May 1917 until May 1918. He was Postmaster at Bellingham for five years, served on the Library Board and for eleven years was U.S. referee of Bankruptcy. He married E. Floy Strong in 1946.





CLARK, ASA V. (Republican) Senator from the 9th District of Whitman County, was born in Whitman County in 1899 and is 61 years of age. He was first elected to the House in 1940 and served five regular terms and two special sessions. In 1941 he was Chairman of Educational Institutions and Chairman of Appropriations in 1947. Mr. Clark was appointed to the Senate to fill the vacancy left by the appointment of Ernest C. Huntley to the Tax Commission and was elected again in 1950. He attended Washington State College and was a member of the State Guard. He is married and has three children, Barbara Jean, Asa V. Jr. and D. Girard.



COPELAND, HENRY J. (Republican) Senator from the 11th District of Walla Walla County, was born in Walla Walla in 1885 and is 66 years of age. He was first elected in 1934 and has served seven terms and two special sessions in the Senate and one term in the House. In 1941 he was Chairman of Appropriations and in 1947 was Chairman of Public Utilities and Vice Chairman of Appropriations. He was County Commissioner from 1928 to 1934. He attended the Walla Walla Public Schools and Walla Walla College. A farmer, he is a member of Odd Fellows, Elks and Masons. He is married and lives at 1204 Portland Ave., Walla Walla.

COWEN, DAVID C. DR. (Democrat) Senator from the 7th District of Spokane County, was born at Portland, Oregon, in 1901 and is 50 years of age. He was first elected to the House in 1934 and has served four terms in both House and Senate. In 1937 he was Chairman of Appropriations in the House; in 1943 Chairman of Public Buildings and Grounds and in 1947 of Public Morals in the Senate. He was re-elected in 1950. He is a graduate of the University of Oregon Dental College. He served in the S.O.T.C. in 1917 and is a Mason, Shriner, Elk and Moose.





DAHL, BJARNE J. (Republican) Senator from the 2nd District of Stevens and Pend Oreille Counties, was born in Norway in 1898 and is 52 years of age. First elected to the Senate in 1942, he is serving his third term. During the sessions of 1943, 1945 and 1947 he was Chairman of Mines and Mining. Now a newspaper publisher, he has been a city councilman and served overseas in World War I. He attended high school and college and is a member of Sigma Delta Chi, American Legion, Kiwanis and Chewelah Chamber of Commerce. He is married and has two children, Gregory and Dahleen.

DIXON, GERALD G. "GERRY" (Democrat) Senator from the 28th District of Pierce County, was born in London, England, in 1884 and is 66 years of age. First elected to the House in 1934, where he served three sessions, he is now serving his fifth regular session in the Senate. He has been Chairman of the Labor, Education and Public Morals Committees. He was Democratic State Committeeman from 1941 to 1944. A locomotive engineer, he has had one year of college and served with the Selective Service System during World War II. Married, he has three children, Helen, Jessie and Geraldine.



EASTVOLD, DONALD W. (Republican) Senator from the 29th District of Pierce County, was born at Minneapolis, Minnesota in 1919 and is 31 years of age. This is his first term in the Senate. He is a graduate of St. Olaf with a B.A.Degree and received his LL.B. from the University of Washington in 1948 He is a practicing attorney. A veteran of World War II having served 3 years with the Army Air Corps. He is a member of the Eagles, Elks, Sons of Norway and Scandinavian-American Fraternity. He is married and has four children.





EDWARDS, A. E. (Democrat) Senator from the 41st District of Whatcom County, was born in Canada, in 1879, and is 71 years of age. 





