## RESOLUTION

WHEREAS, The Persian New Year, or Nowruz, which originated in the Iranian plateau more than 3,000 years ago and is celebrated annually marking the Spring Equinox in the northern hemisphere, this year will fall on March 20th at 2:01 a.m.; and

WHEREAS, Nowruz is a significant cultural holiday that is celebrated by nearly 300 million people across the globe of different faiths and cultures, including individuals in Iran, Afghanistan, Tajikistan, Uzbekistan, Azerbaijan, Turkmenistan, the Hazara community, and many other communities and countries including more than 1 million Americans, including tens of thousands in Washington state; and

WHEREAS, Nowruz welcomes spring and regrowth after winter and periods of cold and dormancy and it celebrates nature, life, and opportunity for regrowth and blossoming; and

WHEREAS, In this time where mistrust and fear often threaten to divide us, the spirit of Nowruz inspires us to realize our commonalities and strive for new levels of compassion, understanding, and love for our fellow human beings irrespective of religion or ethnicity; and

WHEREAS, Many Middle Eastern and Central Asian individuals immigrate to Washington to flee persecution for their beliefs, seeking personal and religious freedoms in the United States; and

WHEREAS, Middle Eastern and Central Asians are an important part of our communities and continue to make noteworthy and lasting contributions to Washington state through their leadership in business, government, higher education, medicine, military service, law, social justice, and many other arenas; and

WHEREAS, Nowruz presents a fitting opportunity to recognize these contributions and the resilience of the Middle Eastern and Central Asian communities who continue to advocate for their communities; and

WHEREAS, Nowruz is a time for all of us to come together to reflect on the year that has passed and celebrate the universal values of generosity, compassion, selflessness, and community stewardship in the year ahead;

NOW, THEREFORE, BE IT RESOLVED, That the House of Representatives celebrate the honored holiday of Nowruz; recognize the historical and cultural significance thereof; stand with the communities that celebrate Nowruz in times of crisis and in times of celebration; and wish a happy and prosperous new year to all.

With the consent of the House, HOUSE RESOLUTION NO. 4635 was adopted.

### JOINT SESSION

The Senate was called to order at 11 o'clock a.m. by President Heck.

The Sergeant at Arms, Mr. Andy Staubitz, announced the presence of the House of Representatives at the Chamber door.

The President called upon the Sergeant at Arms of the Senate and the Sergeant at Arms of the House to escort the Honorable Laurie Jenkins, Speaker of the House, to a seat on the rostrum. Members of the House were invited to seats within the Chamber.

Pursuant to Senate Concurrent Resolution No. 8403, the President called the Joint Session to order. The Secretary called the roll of the members of the Senate. The Secretary called the roll of the members of the House of Representatives. The President declared that a quorum of the Legislature was present.

The President welcomed and introduced the following honored guests and elected officials who were present on the dais: Supreme Court Justice Sheryl Gordon McCloud, Supreme Court Justice Salvador A. Mungia, Secretary of State Steve Hobbs, Insurance Commissioner Patty Kuderer, and State Treasurer Mike Pellicciotti.

The flags were escorted to the rostrum by the Washington State Patrol Honor Guard consisting of: Trooper Kyle Flaig, Sergeant Jeffrey Bridges, Trooper Matthew Gagley, Trooper Michael Farkas, and Trooper Dean Gallanger.

The Pledge of Allegiance was led by Page Henry Newlean, grandson of Senator King.

The invocation was offered by Councilmember Jeremy Takala, from the Yakama Nation.

### REMARKS BY THE PRESIDENT

President Heck: "Honored statewide elected officials, justices of the supreme court and members of the legislature, ladies and gentlemen, family members and visitors: The purpose of the joint session is to conduct a memorial service in memory of members of the legislature who have passed from among us. This has been our longstanding custom: indeed, for more than a century the Senate and House have met as we meet today -- to pay special and fitting tribute to the lives and service of these valued public servants.

Despite the abundant work that we have before us, we pause upon this sad occasion and reflect upon the course we have traveled and pay homage to the disappearing generations of men and women who aided in strengthening and multiplying the powers and opportunities, the pleasures and possibilities of the people who constitute this great state. It's a somber occasion. In some way sobering. Every single person sitting at this floor, every one of you, will someday have a bell rung for you and a candle lit for you in

this chamber. And looking out at this group it is evident that the overwhelming majority of you have way more yesterdays than you do tomorrows.

Just a fact.

But the point is, let that sober reality steel your resolve that one of the ways in which you will honor the memory of the men and women who we are here today to acknowledge. Let that steel your resolve to do your very best, to uphold that sacred oath of office that you took not that long ago. It is in the best tradition of honoring them if we do that.

On behalf of the Senate and the House of Representatives, I would like again to extend a warm welcome to the family members, friends and colleagues who have joined us today and offer our deepest sympathies for your loss."

### REMARKS BY THE SPEAKER
