WHEREAS, On this 29th day of January in 2025, the people of the great state of Washington unite to celebrate Lunar New Year, joining to distinguish Asian American joy, cultures, and beautiful diversity; and

WHEREAS, The Lunar New Year has been celebrated for thousands of years, first recorded in the 200s BC and begins on the first new moon of the lunisolar calendar; and

WHEREAS, This year is designated as the Year of the Snake, an animal characterized by transformation, renewal, and growth, bringing symbols of adaptability and prosperity to the year; and

WHEREAS, Washington acknowledges both the rich heritage and historical trauma of our Asian American, Native Hawaiian, and Pacific Islander ancestors; and

WHEREAS, We deeply appreciate the many contributions of the Asian American, Native Hawaiian, and Pacific Islander communities that have made Washington a vibrant place for us all to call home, through building and supporting their communities despite the persistent discriminations and violence they may have faced in the past and present; and

WHEREAS, The history of Asian Americans in the United States is marked by exclusion and prejudice, from the Chinese Exclusion Act to the internment of Japanese Americans during World War II, and the scars of these events still resonate today; and

WHEREAS, Despite these challenges, the Asian American, Native Hawaiian, and Pacific Islander communities have enriched our nation with countless contributions in science, technology, arts, and culture, weaving themselves into the very fabric of Washington; and

WHEREAS, Recognizing and celebrating Lunar New Year affirms the value of Asian American, Native Hawaiian, and Pacific Islander communities and fosters a deeper understanding of our diverse traditions, sending a signal to future generations that their heritage is respected and celebrated; and

WHEREAS, In 2024, legislation was passed in Washington state to establish Lunar New Year as a state-recognized holiday, sending a clear message that inclusion matters; and

WHEREAS, We highlight the solidarity and strength of the Asian American, Native Hawaiian, and Pacific Islander communities rooted in the culture that respects its ancestry and supports its descendants; and

WHEREAS, The Lunar New Year is a time to reflect, to celebrate family and community, and to learn and understand the past as we look towards renewal and growth; and

WHEREAS, We step into the Year of the Snake not just as individuals, but as a family united in compassion and community stewardship;

NOW, THEREFORE, BE IT RESOLVED, That the House of Representatives stand with the Asian American, Native Hawaiian, and Pacific Islander communities in times of crisis and in times of celebration, we come together now to reflect on the year past and

envision new beginnings in acknowledgment of the Lunar New Year; and

BE IT FURTHER RESOLVED, That this Lunar New Year sends a message of hope and unity, reaffirming our commitment to creating a nation where every individual feels valued and respected, and where the dark chapters of our past serve as reminders of the future for which we must strive.

HOUSE RESOLUTION NO. 2025-4609, by Representative Kloba

WHEREAS, Data privacy is critical to safeguard personal integrity, promote trust in digital interactions, and uphold the fundamental rights of individuals in an increasingly data-driven world; and

WHEREAS, Vast amounts of data about consumers are harvested daily around the globe, and with the collection and processing of this data comes great responsibility; and

WHEREAS, Many people do not understand the ways in which their private activities on their computers, phones, and connected devices generate data that is being used and stored digitally, with or without their knowledge; and

WHEREAS, Across the world, 50 countries observe Data Privacy Day to draw attention to best practices and innovative discussions that promote individual control over personally identifiable information, responsible privacy practices, and compliance with privacy laws and regulations; and

WHEREAS, The Council of Europe first recognized Data Privacy Day in 2007, and the U.S. Congress followed suit in 2009; and

WHEREAS, Data Privacy Day is recognized as an educational initiative focused on raising awareness among businesses, governments, and individuals about the importance of respecting individual privacy and protecting personal information; and

WHEREAS, The pervasive use of data collection and generating technologies in our homes, in our everyday activities, in schools, and in our workplaces give rise to the potential compromise of personal privacy if appropriate care is not taken to protect personal information; and

WHEREAS, The growth of Generative AI technologies and the potential risks of their expanded use raises the importance of privacy as more data is needed to train, build, and maintain new AI foundational models; and

WHEREAS, Data Privacy Day's celebrations offer opportunities for collaboration among governments, industry, academia, nonprofits, privacy professionals, and educators; and

WHEREAS, The recognition of Data Privacy Day encourages Washingtonians to become aware of personal information privacy concerns, to take steps to protect the privacy of their own data, and advocate for better data privacy protections;

NOW, THEREFORE, BE IT RESOLVED, That the Washington State House of Representatives recognize Data Privacy Day on January 28th, as established by the United States House of Representatives, to highlight the importance of data privacy and data protection and raise awareness of and promote privacy and data protection best practices.

WHEREAS, Under Dr. Hiyane-Brown's guidance, the Washington State Board of Community and Technical Colleges and the State Legislature designated WCC as the Washington State Cybersecurity Center of Excellence; and

WHEREAS, Dr. Hiyane-Brown helped WCC grow its physical campus to better support students and educators; and

WHEREAS, WCC has received numerous commendations during accreditation visits, a direct result of Dr. Hiyane-Brown's leadership; and

WHEREAS, WCC has expanded its partnerships and community connections during her tenure, including the Writers Workshop, the Community Transitions program with Bellingham School District, the home of the Area Health Education Center — one of two health education centers in Washington State, and joint student activities with Northwest Indian College, Bellingham Technical College, and Western Washington University; and

WHEREAS, Dr. Hiyane-Brown has left her mark on higher education beyond the WCC campus, including serving as a founding and executive committee member of the National Asian Pacific Islander Council, a member of the Higher Education Research and Development Institute West Advisory Board, and a member of the Council for Adult and Experiential Learning Advisory Board, leadership roles with the National Initiative for Cybersecurity Education, the American Association of Community Colleges (AACC) and AACC's Presidents Academy Executive Committee, membership in the Washington Association of Community and Technical Colleges, the Northwest Workforce Council Board, and the Rotary Club of Bellingham;

NOW, THEREFORE, BE IT RESOLVED, That the House of Representatives congratulate Dr. Kathi Hiyane-Brown on an illustrious, impactful, and remarkable career in service to community college students and the larger education community, and wish Dr. Kathi Hiyane-Brown a deserved and well-earned retirement with the knowledge and contentment of a stellar career that helped numerous students achieve a better future; and
