**Key**

**Procedural**—Refers to Committee processes. Action may or may not be required.

**Informational**—Provides the Committee with information. Action is not required.

**Annual Update**—Regular updates from entities involved in pensions, such as the Department of Retirement Systems and the Washington State Investment Board.

While not expressly required, many policy-related agenda items follow a three-step process:

1. **Initial Briefing** (background and scoping).
2. **Policy Analysis** (develop options; potential pricing).
3. **Public Hearing/Action Item**.

Please note that each of the three steps can sometimes take more than one meeting.
