AGRICULTURE, WATER, NATURAL RESOURCES & PARKS

HB 1153 PROHIBITING OCTOPUS FARMING

Prime Sponsor: Representative Peterson

C 45 L 24 Effective date 6/6/2024

- Prohibits a person from participating in octopus farming in the state of Washington.

HB 1226 PROVIDING FOR RECREATIONAL LICENSING OF SMELT, CRAWFISH, AND CARP

Prime Sponsor: Representative Chapman

(SB 5854 Senator Salomon)

C 77 L 24 Effective date 6/6/2024

- Provides that a person must obtain a recreational fishing or shellfish license in order to fish for carp, smelt, and crawfish.
- Specifies a recreational fishing license is not required to fish for carp in Moses Lake or Vancouver Lake.

HB 1752 MODIFYING THE APPLICATION OF THE ANNUAL CONSUMPTIVE QUANTITY CALCULATION TO CHANGE APPLICATIONS RELATED TO CERTAIN WATER RIGHTS HELD BY THE UNITED STATES BUREAU OF RECLAMATION

Prime Sponsor: Representative Dye

C 108 L 24 Effective date 6/6/2024

- Authorizes the United States Bureau of Reclamation to apply for and obtain approval for a change in the number of acres that may be irrigated with water rights held by the Bureau for water use within the boundaries of the Columbia Basin Project if certain criteria are met.

SHB 1818 CONCERNING THE EXCLUSION OF COMPENSATING TAX WHEN LAND IS SOLD TO A GOVERNMENTAL ENTITY INTENDING TO MANAGE THE LAND SIMILARLY TO DESIGNATED FORESTLAND OR TIMBERLAND

Prime Sponsor: Representative Tharinger

C 109 L 24 Effective date 6/6/2024

- Creates an exception to the imposition of additional and compensating tax for certain sales or transfers of designated forestland or timberland to a governmental entity.

SHB 1919 MODIFYING THE PROCESS BY WHICH A PRIVATE MOORAGE FACILITY MAY SELL AN ABANDONED VESSEL FOR FAILURE TO PAY MOORAGE FEES

Prime Sponsor: Representative Bronoske

C 110 L 24 Effective date 6/6/2024

- Modifies the process and reduces the timelines required before a private moorage operator may sell an abandoned vessel for failure to pay moorage fees.

SHB 2045 CREATING AN ADOPT A FISH BARRIER PROGRAM

Prime Sponsor: Representative Waters

C 227 L 24 Effective date 6/6/2024

- Authorizes the Washington State Department of Transportation and local governments to participate in Adopt-A-Fish Passage programs for the purpose of fish barrier removal.

SHB 2147 CONCERNING AGRICULTURE PEST AND DISEASE RESPONSE

Prime Sponsor: Representative Dent

(SB 6036 Senator Muzzall)

C 228 L 24 Effective date 6/6/2024

- Establishes the Agricultural Pest and Disease Response Account.
- Modifies the procedure for appointing emergency advisory committee members.

SHB 2165 CONCERNING THE AUTHORITY OF THE DEPARTMENT OF NATURAL RESOURCES TO DETERMINE RECREATIONAL USE FEES FOR ACTIVITIES ON AGENCY-MANAGED PUBLIC LANDS

Prime Sponsor: Representative Kloba

(SB 6043 Senator Salomon)

C 18 L 24 Effective date 6/6/2024

- Provides that a permit, license, or any related application or processing fee, issued by the Department of Natural Resources for an organized event or commercial use is not considered a fee for the purposes of the recreational immunity statute.

SHB 2293 STUDYING THE EFFECTS OF AVIAN PREDATION OF SALMON

Prime Sponsor: Representative Wilcox

C 72 L 24 Effective date 6/6/2024

- Creates an Avian Salmon Predation Work Group to identify avian species contributing to predation of threatened and endangered juvenile salmon and to identify remedies.

**SHB 2424 UPDATING COOPERATIVE AGREEMENTS BETWEEN THE
STATE AND FEDERALLY RECOGNIZED TRIBES FOR THE
SUCCESSFUL COLLABORATIVE MANAGEMENT OF
WASHINGTON'S WILDLIFE RESOURCES**

Prime Sponsor: Representative Kretz

C 260 L 24 Effective date 6/6/2024

- Requires the Washington Department of Fish and Wildlife (WDFW) to engage with the Confederated Tribes of the Colville Reservation on a government-to-government basis to identify potential updates and recommend modifications to the 1998 cooperative fish and wildlife management agreement.
- Directs WDFW to report to the Legislature regarding updates and modifications to the agreement subsequent to approval and ratification by the Fish and Wildlife Commission and the Confederated Tribes of the Colville Reservation.

2ESSB 5150 CONCERNING THE BEEF COMMISSION

Prime Sponsor: Senator Shewmake

C 155 L 24 Effective date 6/6/2024

- Increases the Beef Commission's levied assessment, beginning July 1, 2024, from \$1 to \$1.50, to \$2.00 beginning January 1, 2025, and to \$2.50 beginning January 1, 2026, with a portion not collected at the first point of sale for calves identified with green tags.
- Allows a producer or owner of cattle to request a refund of a certain portion of the assessment.
- Provides that the Commission may fund, conduct, or otherwise participate in scientific research related to beef.

**SSB 5306 AUTHORIZING THE DEPARTMENT OF FISH AND WILDLIFE TO
ESTABLISH DISEASE INTERDICTION AND CONTROL CHECK
STATIONS**

Prime Sponsor: Senator Short

C 318 L 24 Effective date 6/6/2024

- Authorizes the Washington Department of Fish and Wildlife to establish voluntary disease interdiction and control check stations that may be signed from state highways and interstates.

SB 5508 PROMOTING LOCAL AGRICULTURE THROUGH GREENHOUSES

Prime Sponsor: Senator Short

C 19 L 24 Effective date 6/6/2024

- Provides that the State Building Code does not apply to any temporary growing structures used solely for the production of horticultural plants.
- Establishes that a temporary growing structure is not considered a structure under the State Building Code.

**SSB 5667 CONCERNING ELIGIBILITY, ENROLLMENT, AND
COMPENSATION OF SMALL FORESTLAND OWNERS
VOLUNTEERING FOR PARTICIPATION IN THE FORESTRY
RIPARIAN EASEMENT PROGRAM**

Prime Sponsor: Senator Muzzall

(HB 1740 Representative Orcutt)

C 158 L 24 Effective date 6/6/2024

- Increases the amount the Small Forest Landowner Office shall offer a small forest landowner from 50 percent to 90 percent of the value of qualifying timber in the Forestry Riparian Easement Program (FREP).
- Reduces lease terms for the FREP from 50 years to 40 years.
- Increases FREP payments for qualifying timber on unstable slopes from \$50,000 to \$150,000.

**2SSB 5784 CONCERNING DEER AND ELK DAMAGE TO COMMERCIAL
CROPS**

Prime Sponsor: Senator Van De Wege

C 264 L 24 Effective date 6/6/2024

- Increases the annual compensation limit for commercial crop damage claims caused by deer or elk paid from the state general fund from \$30,000 to \$300,000.
- Establishes a limit of \$30,000 for an appeal of a decision of the Washington Department of Fish and Wildlife (WDFW) addressing deer or elk damage to commercial crops.
- Increases the limit for an individual damage claim from \$10,000 to \$30,000.
- Creates a three-year pilot program at WDFW to collar and monitor elk in South Central Washington in an effort to prevent crop and property damage.

Partial Veto Summary:

- Removed a three-year pilot program between WDFW and tribal co-managers to collar and monitor elk in South Central Washington in an effort to prevent crop and property damage.

SSB 5785 **CONCERNING DEPARTMENT OF FISH AND WILDLIFE
AUTHORITY WITH REGARD TO CERTAIN NONPROFIT AND
VOLUNTEER ORGANIZATIONS**

Prime Sponsor: Senator Warnick

C 160 L 24 Effective date 6/6/2024

- Authorizes the Washington Department of Fish and Wildlife to enter into cooperative agreements with any nonprofit or volunteer organization to carry out activities benefitting department managed lands.

SB 5799 **CONCERNING THE SALE OF HALAL FOODS**

Prime Sponsor: Senator Wilson, C.

(HB 2059 Representative Stearns)

C 245 L 24 Effective date 6/6/2024

- Provides that no person may sell or offer for sale any food product labeled or represented as halal when that person knows that the food product is not halal and the representation is likely to cause the purchaser to believe that it is halal.
- Establishes that the sale or offer for sale of a food product marked as halal when that person knows the product is not halal constitutes a violation of the Consumer Protection Act.

SSB 5972 **CONCERNING THE USE OF NEONICOTINOID PESTICIDES**

Prime Sponsor: Senator Liias

C 338 L 24 Effective date 6/6/2024

- Prohibits a person from using neonicotinoid pesticides on nonproduction outdoor ornamental plants, trees, and turf beginning January 1, 2026, unless the application is made as part of a licensed application, a tree injection, or during the production of an agricultural commodity.
- Allows the Director of the Washington State Department of Agriculture to authorize the use of restricted neonicotinoid pesticides upon identification of an urgent pest threat.

BUSINESS, FINANCIAL SERVICES, GAMING & TRADE

ESHB 1097 CONCERNING THE SALE OF COSMETICS TESTED ON ANIMALS

Prime Sponsor: Representative Walen
C 107 L 24 Effective date 1/1/2025

- Makes it unlawful for manufacturers to sell a cosmetic developed or manufactured using cosmetic animal testing that was conducted or contracted for by the manufacturer or its supplier, subject to exceptions.
- Establishes fines for manufacturer violations up to \$5,000 per violation.

SHB 1870 PROMOTING ECONOMIC DEVELOPMENT BY INCREASING OPPORTUNITIES FOR LOCAL COMMUNITIES TO SECURE FEDERAL FUNDING

Prime Sponsor: Representative Barnard
C 223 L 24 Effective date 6/6/2024

- Requires the Department of Commerce to assist local communities by providing technical assistance with federal grant applications, prioritizing applications for federal funds in an existing grant program, and creating a resource guide for federal grant applicants, subject to appropriations.

HB 1920 MODIFYING THE PUBLIC ACCOUNTANCY ACT

Prime Sponsor: Representative Robertson *(SB 5887 Senator Stanford)*
C 13 L 24 Effective date 6/6/2024

- Updates and consolidates terms in the Public Accountancy Act.
- Removes statutory requirements regarding experience necessary for certified public accountant (CPA) licensure.
- Requires the Board of Accountancy to establish experience requirements for CPA licensure.
- Adds causes for potential license revocation or nonrenewal.

HB 1982 CONCERNING THE AUTHORITY OF THE COMMUNITY ECONOMIC REVITALIZATION BOARD WITH RESPECT TO LOANS AND GRANTS TO POLITICAL SUBDIVISIONS AND FEDERALLY RECOGNIZED INDIAN TRIBES FOR BROADBAND

Prime Sponsor: Representative Waters
C 86 L 24 Effective date 6/6/2024

- Authorizes the Community Economic Revitalization Board to make broadband loans and grants to governmental entities in rural and underserved areas for economic or community development.

E2SHB 2000 RENEWING WASHINGTON'S INTERNATIONAL LEADERSHIP

Prime Sponsor: Representative Mena

(SB 6168 Senator Stanford)

C 336 L24 Effective date 6/6/2024

- Requires the Office of International Relations and Protocol (OIRP) to develop a strategic international engagement plan.
- Establishes that OIRP and the Legislative Committee on Economic Development and International Relations (LCEDIR) are responsible for determining jurisdictions of strategic importance.
- Creates an interparliamentary exchange with British Columbia, led by LCEDIR.
- Increases the number of legislative members on LCEDIR from 12 to 16.
- Removes the prohibition on reimbursing travel and lodging expenses from the Legislative International Trade Account.

Partial Veto Summary:

- Removed changes to certain duties of the OIRP.

**HB 2137 CONCERNING TECHNICAL CHANGES TO ALLOWABLE
EXEMPTIONS FOR TOURISM PROMOTION AREA ASSESSMENTS**

Prime Sponsor: Representative Berg

(SB 6202 Senator Kauffman)

C 68 L 24 Effective date 6/6/2024

- Allows the legislative authority of a local government to designate exemptions to the area's lodging charge in a tourism promotion area.

**SHB 2329 CONDUCTING A STUDY OF THE INSURANCE MARKET FOR
HOUSING PROVIDERS RECEIVING HOUSING TRUST FUND
RESOURCES**

Prime Sponsor: Representative Macri

C 74 L 24 Effective date 6/6/2024

- Requires the Office of the Insurance Commissioner to conduct a study of property and liability coverages available to housing providers receiving housing fund trust resources and serving extremely low-income households.

ESHB 2482 REINSTATING SEMICONDUCTOR TAX INCENTIVES

Prime Sponsor: Representative Harris

(SB 6137 Senator Cleveland)

C 261 L 24 Effective date 3/26/2024

- Reinstates six expired tax incentives for semiconductor manufacturing through 2034, conditional on new investments of at least \$500 million.
- Extends the expiration date for two existing tax incentives for semiconductor manufacturing through 2034.

SSB 5798 EXTENDING CERTAIN INSURANCE NOTICE REQUIREMENTS

Prime Sponsor: Senator Kuderer

C 244 L 24 Effective date 7/1/2025

- Extends the written notice requirement for cancellation or nonrenewal of health, and property and casualty insurance policies from 45 days to 60 days.

ESSB 5801 CONCERNING SPECIAL DEPOSITS

Prime Sponsor: Senator Dozier

C 23 L 24 Effective date 7/1/2024

- Establishes that a special deposit is a debt owed to the beneficiary.
- Establishes certain restrictions around a special deposit during a creditor process.
- Clarifies a bank's rights for seeking recoupment on a debt when holding a special deposit.

**SSB 5806 CONCERNING THE CONFIDENTIALITY OF INSURANCE
COMPANY DATA**

Prime Sponsor: Senator Kuderer

C 123 L 24 Effective date 6/6/2024

- Excludes from public disclosure under the public records act certain information pertaining to emergencies and hazard mitigation received by the Office of the Insurance Commissioner (OIC) from insurance entities or the federal government.
- Allows state agencies to receive confidential and privileged information from the OIC if confidentiality is maintained.
- Establishes that the OIC may prepare and publish reports using certain data from property and casualty companies if the data is in aggregate.

**SB 5842 RESTRICTING THE USE OF SOCIAL SECURITY NUMBERS BY
INSURANCE COMPANIES FOR THE PURPOSE OF DETERMINING
CHILD SUPPORT DEBT**

Prime Sponsor: Senator Kuderer

C 126 L 24 Effective date 6/6/2024

- Minimizes the use of an insurance claimant's social security number in the process of determining whether they owe past-due child support by first establishing the claimant's identity through other personal identifying information.

SSB 6025 PROTECTING CONSUMERS FROM PREDATORY LOANS

Prime Sponsor: Senator Stanford

(HB 1874 Representative Walen)

C 249 L 24 Effective date 6/6/2024

- Makes any attempt to evade the provisions of the Consumer Loan Act a violation of the act.

SB 6027 **CONCERNING THE INSURANCE HOLDING COMPANY ACT**

Prime Sponsor: Senator Stanford

C 42 L 24 Effective date 6/6/2024

- Requires insurance holding companies to provide certain information regarding solvency at registration.
- Establishes certain rules and requirements around confidential treatment of information regarding solvency.
- Allows an insurance holding company's solvency information to be shared with a designated third-party consultant if certain conditions are met.

SB 6080 **SIMPLIFYING THE FUNDING PROVISIONS OF THE STATEWIDE
TOURISM MARKETING ACCOUNT**

Prime Sponsor: Senator Boehnke

(HB 1896 Representative Ryu)

C 130 L 24 Effective date 7/1/2025

- Removes the requirement that the deposit to the Statewide Tourism Marketing Account may only occur if the Legislature authorizes the deposit in the Biennial Omnibus Appropriation Act.

ESJM 8005 **ADDRESSING "DE-RISKING" BY FINANCIAL INSTITUTIONS**

Prime Sponsor: Senator Hasegawa

SFiled Sec/St

- Requests federal legislation to address actions taken by financial institutions in terminating or restricting business relationships with certain customers to avoid regulatory concerns.

SSJM 8009 **CONCERNING THE FEDERAL HARBOR MAINTENANCE TAX**

Prime Sponsor: Senator Hasegawa

SFiled Sec/St

- Requests that the federal government reform the Harbor Maintenance Tax.

EARLY LEARNING & K-12 EDUCATION

HB 1146 NOTIFYING HIGH SCHOOL STUDENTS AND THEIR FAMILIES ABOUT AVAILABLE DUAL CREDIT PROGRAMS AND ANY AVAILABLE FINANCIAL ASSISTANCE

Prime Sponsor: Representative Paul

C 44 L 24 Effective date 6/6/2024

- Requires school districts to provide information about dual credit programs and any financial assistance available to reduce dual credit and exam costs for students and their families.

3SHB 1228 BUILDING A MULTILINGUAL, MULTILITERATE WASHINGTON THROUGH DUAL AND TRIBAL LANGUAGE EDUCATION

Prime Sponsor: Representative Ortiz-Self

C 202 L 24 Effective date 6/6/2024

- Creates grant programs for establishing or expanding dual language and tribal language education programs, subject to appropriation.
- Requires literacy supports in service of American Indian and Alaska Native students.
- Modifies requirements related to the seal of biliteracy and the Transitional Bilingual Instruction Program.
- Requires various agency reports from the Office of the Superintendent of Public Instruction, the Professional Educator Standards Board, and the Paraeducator Board on specified topics.

E4SHB 1239 ESTABLISHING A SIMPLE AND UNIFORM SYSTEM FOR COMPLAINTS RELATED TO, AND INSTITUTING A CODE OF EDUCATOR ETHICS FOR, CONDUCT WITHIN OR INVOLVING PUBLIC ELEMENTARY AND SECONDARY SCHOOLS

Prime Sponsor: Representative Santos

C 219 L 24 Effective date 6/6/2024

- Directs the Office of the Education Ombuds to create a simple and uniform access point for the receipt of complaints involving the elementary and secondary education system.
- Requires the Professional Educator Standards Board and the Paraeducator Board to report to the Legislature on a code of educator ethics.
- Modifies the defense for use of force on children with respect to teachers and other school staff.

ESHB 1248 CONCERNING PUPIL TRANSPORTATION

Prime Sponsor: Representative Stonier

C 313 L 24 Effective date 6/6/2024

- Provides that school districts may only enter into, renew, or extend pupil transportation services contracts with private nongovernmental entities that provide employee health and retirement benefits comparable to those received by school employees.
- Directs the Office of the Superintendent of Public Instruction to reimburse school districts for increased costs due to providing these benefits and provides a formula for calculating the reimbursement.

**ESHB 1277 IMPROVING THE CONSISTENCY AND QUALITY OF THE
IMPLEMENTATION OF THE FUNDAMENTAL COURSE OF
STUDY FOR PARAEDUCATORS**

Prime Sponsor: Representative Donaghy

C 173 L 24 Effective date 6/6/2024

- Directs the Paraeducator Board to update rules and publish guidance related to the paraeducator fundamental course of study.
- Requires school districts to provide to each paraeducator two days of the four-day fundamental course of study in person by specified deadlines, unless the school district is granted an exemption by the Paraeducator Board.

E2SHB 1368 REQUIRING AND FUNDING THE PURCHASE OF ZERO EMISSION SCHOOL BUSES

Prime Sponsor: Representative Senn

(SB 5431 Senator Shewmake)

C 345 L 24 Effective date 6/6/2024

- Requires the Department of Ecology to administer the Zero-Emission School Bus Grant Program, and prioritize grants to districts serving communities highly impacted by air pollution and with buses manufactured prior to 2007.
- Provides that once the total cost of ownership of zero emission school buses is at or below the total cost of ownership of diesel school buses, school districts may only receive reimbursement for the purchase of zero emission school buses and may only contract with pupil transportation service providers that use zero emission school buses to transport students for the district, with some exceptions.
- Requires the Office of the Superintendent of Public Instruction to survey school districts about the adoption of zero-emission school buses.

**2ESHB 1377 POSTING OF APPROVED COURSES AND PROVIDERS OF
CONTINUING EDUCATION**

Prime Sponsor: Representative Santos

C 221 L 24 Effective date 6/6/2024

- Requires the Professional Educator Standards Board (PESB) to approve clock hour providers through a revised application process and adds organizations approved by the PESB to the list of entities that may provide continuing education.
- Requires education agencies to post on their websites a list of approved subject matter experts on government-to-government relationships with federally recognized tribes.
- Requires PESB, in consultation with the Office of the Superintendent of Public Instruction, and by December 1, 2024, to submit a report to the Legislature on how to implement an auditing system of continuing education providers and other recommendations for improving the clock hour system.
- Directs PESB to develop a process for the temporary or permanent revocation of providers of certain continuing education by September 1, 2024, and specifies the criteria by which provider status may be revoked, including the entities authorized to submit a complaint.

**ESHB 1608 EXPANDING ACCESS TO ANAPHYLAXIS MEDICATIONS IN
SCHOOLS**

Prime Sponsor: Representative Bronoske

C 81 L 24 Effective date 6/6/2024

- Requires the Secretary of Health or designee to issue a statewide standing order prescribing epinephrine and epinephrine autoinjectors to any school district or school for use by a school nurse or other trained school personnel for any student or individual experiencing anaphylaxis.
- Amends requirements related to school supplies of autoinjectors to also include epinephrine and to reference the statewide standing order.

**HB 1879 NAMING THE CURRICULUM USED TO INFORM STUDENTS
ABOUT TRIBAL HISTORY, CULTURE, AND GOVERNMENT
AFTER JOHN MCCOY (LULILAŠ)**

Prime Sponsor: Representative Lekanoff

C 200 L 24 Effective date 6/6/2024

- Names the curriculum used to teach public school students about tribal history, culture, and government as the John McCoy (lulilaš) Since Time Immemorial curriculum.

**SHB 1916 CONCERNING FUNDING FOR THE EARLY SUPPORT FOR
INFANTS AND TODDLERS PROGRAM**

Prime Sponsor: Representative Senn

(SB 5933 Senator Frame)

C 284 L 24 Effective date 6/6/2024

- Changes the definition of when a child is receiving early intervention services for the purposes of Early Support for Infants and Toddlers program funding.
- Specifies that a child must receive services within the same month as the monthly count day instead of the month prior, and that the monthly count day is the last business day of the month instead of the first business day.

**SHB 1945 STREAMLINING AND ENHANCING PROGRAM ACCESS FOR
PERSONS ELIGIBLE FOR FOOD ASSISTANCE**

Prime Sponsor: Representative Alvarado

*C 225 L 24 Effective date 6/6/2024**

- Requires the Department of Children, Youth, and Families to determine that income eligibility requirements for the Working Connections Child Care program are met if the applicant or consumer is eligible for or receiving basic food benefits beginning November 1, 2024.
- Allows children meeting age criteria for the Early Childhood Education and Assistance Program (ECEAP) and Birth to Three ECEAP to enroll in these programs if they are eligible for or receiving basic food benefits and space is available beginning November 1, 2024.
- Makes children eligible for or receiving basic food benefits eligible for ECEAP beginning August 1, 2030.

**E2SHB 1956 ADDRESSING FENTANYL AND OTHER SUBSTANCE USE
PREVENTION EDUCATION**

Prime Sponsor: Representative Leavitt

(SB 5923 Senator Wellman)

C 201 L 24 Effective date 3/19/2024

- Directs the Department of Health to develop, implement, and maintain a statewide drug overdose prevention and awareness campaign to address the drug overdose epidemic and to submit an annual report on the campaign beginning June 30, 2025.
- Tasks the Office of the Superintendent of Public Instruction (OSPI), in collaboration with other agencies, with developing and updating age-appropriate substance use prevention and awareness materials for school and classroom use aligned with the statewide campaign.

ESHB 2003 CONCERNING AN EXEMPTION TO THE LEASEHOLD EXCISE TAX FOR LEASES ON PUBLIC LANDS

- Adds the First Approach Skills Training (FAST) program to the list of telephone access lines that the Health Care Authority must implement.
- Adds the FAST program to the funding model for the Partnership Access Line and Psychiatric Consultation Line.

2SHB 1929 SUPPORTING YOUNG ADULTS FOLLOWING INPATIENT BEHAVIORAL HEALTH TREATMENT

C 175 L 24 Effective date 6/6/2024

- Authorizes the court, upon motion of a person on community custody, to amend substantive conditions of community custody imposed by the court if there has been a substantial change in circumstances such that the condition is no longer necessary for community safety.

SHB 2368 ASSISTING REFUGEES AND IMMIGRANTS

C 153 L 24 Effective date 6/6/2024

- Codifies the Office of Refugee and Immigrant Assistance within the Department of Social and Health Services (DSHS).
- Designates DSHS as the lead state agency responsible for the development, review, and administration of the Washington State plan for refugee settlement.

**HB 2415 EXPANDING ECONOMIC ASSISTANCE FOR INDIVIDUALS WHO

C 154 L 24 Effective date 1/1/2025

POLICY OUTCOME EVALUATION REQUIREMENT**

C 156 L 24 Effective date 6/6/2024

C 38 L 24 Effective date 6/6/2024

- Allows the presiding judge of a superior court to authorize an administrative process to waive outstanding debt.
- Authorizes the clerk of the superior court to seek a judicial order to waive outstanding debt in a specified manner.

E2SSB 6068 REPORTING ON DEPENDENCY OUTCOMES

C 326 L 24 Effective date 6/6/2024

- Directs the Administrative Office of the Courts, in consultation with other agencies and entities with relevant data or expertise, to identify measures of relational permanency and child well-being and report its findings to the Legislature by July 1, 2025, subject to appropriations.

SB 6079 MAKING JUVENILE DETENTION RECORDS AVAILABLE TO MANAGED HEALTH CARE SYSTEMS

C 99 L 24 Effective date 6/6/2024

- Allows managed care organizations and behavioral health administrative services organizations to access records of a person confined in a county juvenile detention facility for care coordination activities.

E2SSB 6109 SUPPORTING CHILDREN AND FAMILIES

C 328 L 24 Effective date 6/6/2024

- Requires courts to give great weight to the lethality of and public health guidance from the Department of Health (DOH) regarding high-potency synthetic opioids during certain stages of child welfare proceedings when the court is determining whether a child should be removed from a parent.
- Includes child abuse or neglect resulting from a high-potency synthetic opioid in a nonexhaustive list of what may establish the basis for a determination of imminent physical harm when a child is removed from a parent by court order, law enforcement, or a hospital.

SHB 1249 REGARDING LIMITS ON THE SALE AND POSSESSION OF RETAIL CANNABIS PRODUCTS

C 9 L 24 Effective date 6/6/2024

(ESB 5340 Senator King)

- Authorizes a licensed cannabis retailer to sell additional amounts of cannabis-infused product in liquid form to a retail customer under certain conditions.
- Allows a person 21 years of age or older to possess and, subject to requirements in the law, transfer additional amounts of cannabis-infused product in liquid form to another person or persons 21 years of age or older.

SHB 1453 PROVIDING A TAX EXEMPTION FOR MEDICAL CANNABIS PATIENTS

C 79 L 24 Effective date 6/6/2024

SHB 1880 CONCERNING ARCHITECTURE LICENSING EXAMINATIONS

C 49 L 24 Effective date 7/1/2024

(SB 5794 Senator King)

- Removes the provision requiring applicants for architect certificates of registration to pass all sections of the exam within five years.
- Requires applicants to pass all sections of the exam as prescribed by the State Board for Architects.

SHB 1889 ALLOWING PERSONS TO RECEIVE PROFESSIONAL LICENSES AND CERTIFICATIONS REGARDLESS OF IMMIGRATION OR CITIZENSHIP STATUS

RETURN TO WORK**

C 90 L 24 Effective date 1/1/2025

- Modifies certain workers' compensation programs involving injured workers staying at work or returning to work.

- Allows L&I to authorize payments for basic skills development for qualifying injured workers.

- Increases the maximum number of hours of unused vacation leave a state employee may accrue from 240 hours to 280 hours.

OR SUPPLY OF ALCOHOL TO MINORS**

C 71 L 24 Effective date 6/6/2024

(SB 6201 Senator King)

- Allows the Liquor and Cannabis Board (LCB) to impose civil penalties on individuals for selling, gifting, or supplying liquor to individuals under the age of 21 from a business licensed by the LCB, and an employee of the business, and establishes the penalty amounts.

EHB 2266 **CONCERNING SANITARY CONDITIONS FOR CONSTRUCTION
WORKERS WHO MENSTRUATE OR EXPRESS MILK**

C 258 L 24 Effective date 6/6/2024

(SB 6107 Senator Cleveland)

- Requires the Department of Labor and Industries to adopt rules applicable to construction industry employers to address safety and health issues for workers performing construction activities who menstruate or express milk, or both.

2SHB 2320 **CONCERNING HIGH THC CANNABIS PRODUCTS**

Prime Sponsor: Representative Davis
C 360 L 24 Effective date 6/6/2024

(SB 6220 Senator Salomon)

- Provides legislative intent for funding to the Department of Health (DOH) for public health messaging and social media campaigns directed toward individuals most likely to suffer negative impacts of high-tetrahydrocannabinol (THC) products.
- Requires DOH to develop optional training for retail cannabis staff and a notice that cannabis retailers must conspicuously post at the point of sale for consumers, related to possible health risks and impacts of high THC cannabis and available resources for quitting or reducing consumption.
- Requires the Health Care Authority, subject to funding, to request a proposal and contract with an entity to develop and implement guidance and health interventions for health care providers and certain patients related to cannabis products; and provide a report to the Legislature.

C 357 L 24 Effective date 6/6/2024

- Prohibits an employer from taking any adverse employment action against an employee for refusal to attend an employer-sponsored meeting, listen to speech, or view communications, when the primary purpose is to communicate the employer's opinion concerning religious or political matters.
- Prohibits an employer from taking any adverse employment action against an employee as a means of requiring an employee to attend a meeting or participate in communications, when the primary purpose is to communicate the employer's opinion concerning religious or political matters, or because the employee makes a good faith report of a violation, or suspected violation.

C 356 L 24 Effective date 1/1/2025

SSB 5935 CONCERNING NONCOMPETITION COVENANTS

C 36 L 24 Effective date 6/6/2024

- Amends the definition of noncompetition covenant to include agreements that directly or indirectly prohibits the acceptance or transaction of business with a customer; and exclude covenants involving the sale or purchase of goodwill or a business interest to apply if the person signing the covenant acquires or disposes a 1 percent or more interest in the business.
- Limits nonsolicitation agreements to current customers.
- Makes changes related to circumstances under which noncompetes are void and unenforceable; causes of action by aggrieved persons; displacement of other laws; and statutory construction.

SB 5952 ALIGNING DEPUTY INSPECTOR CREDENTIALS WITH NATIONAL STANDARDS

C 167 L 24 Effective date 6/6/2024

- Changes the required credentials for deputy boiler and pressure vessel inspectors to require deputy inspectors meet the qualification requirements for a commission as set forth by the National Board of Boiler and Pressure Vessel Inspectors.

SB 5979 **CONCERNING ACCRUED LEAVE FOR CONSTRUCTION WORKERS**

Prime Sponsor: Senator Keiser

C 39 L 24 Effective date 3/13/2024

- Limits the requirement for a construction industry employer to pay a separating construction worker for unused sick leave if the worker has not met the 90-day eligibility to a worker who performed service, maintenance, or construction work on a jobsite, in the field, or in a fabrication shop using the tools of the worker's trade or craft.

SSB 5980 **CONCERNING THE TIMELINE FOR ISSUING A CITATION FOR A VIOLATION OF THE WASHINGTON INDUSTRIAL SAFETY AND HEALTH ACT**

C 40 L 24 Effective date 6/6/2024

- Requires the Department of Labor and Industries (L&I), until June 30, 2026, to make a good faith effort to notify the employer or owner within ten working days if an inspection identifies a hazard at a residential building construction worksite.
- Requires L&I to provide a report to the Legislature regarding inspections when timely notice was not provided.

ESB 5997 **MAKING TECHNICAL CORRECTIONS TO PLUMBING SUPERVISION AND TRAINEE HOURS REPORTING**

C 97 L 24 Effective date 6/6/2024

- Removes a provision that a plumbing trainee failing to report hours worked is subject to an infraction and results in nonrenewal of the trainee certificate.
- Removes a provision requiring plumbing trainees to be on the same jobsite as the supervising plumber and allows trainees performing residential service plumbing to be at separate jobsites, subject to certain conditions.

C 132 L 24 Effective date 6/6/2024

- Excludes minor league baseball players covered by a collective bargaining agreement from the Minimum Wage Act and the meal and rest break requirements under the Industrial Welfare Act.

ESB 6089 **ELIMINATING CERTAIN MINIMUM REQUIREMENT
EQUIVALENCIES FOR ELECTRICAL INSPECTORS**

Prime Sponsor: Senator King

C 196 L 24 Effective date 6/6/2024

- Removes, for the purposes of the minimum requirements for electrical inspectors, a provision allowing an electrical inspector to have two years of electrical training in a college of electrical engineering and four years of practical electrical experience in installation work, or four years of electrical training in a college and two years of practical electrical experience.
- Requires the Department of Labor and Industries and the Association of Washington Cities to work with cities that issue their own electrical permits and perform their own inspections to identify appropriate pathways to qualify as an electrical inspector.

ESSB 6105 **CREATING SAFER WORKING CONDITIONS IN ADULT
ENTERTAINMENT ESTABLISHMENTS**

PUBLIC AND PRIVATE CONSTRUCTION PROJECTS**

C 199 L 24 Effective date 6/6/2024

- Adds private construction projects to the statute requiring issuance of a change order no later than 30 days after satisfactory completion of any additional work on public works projects.
- Adds subcontractors and suppliers to the change order statute.
- Provides that a contractor or subcontractor that requests a change order from the project owner is not liable for any interest on unpaid amounts for additional work if the project owner has not issued the requested change order.

2SHB 1205 RESPONSIBILITY FOR PROVIDING SERVICE BY PUBLICATION OF A SUMMONS OR NOTICE IN DEPENDENCY AND TERMINATION OF PARENTAL RIGHTS CASES

C 312 L 24 Effective date 1/31/2026

- Provides that in a child dependency or termination of parental rights proceeding, the petitioner, rather than the court clerk, is responsible for publishing notice in a legal newspaper where notice by publication is required.

SHB 1241 ADDRESSING HARASSMENT

C 292 L 24 Effective date 3/26/2024

- Creates the Class C felony of harassing election officials.
- Allows election workers who are harassed to apply for the address confidentiality program.

ESHB 1300 CONCERNING FRAUD IN ASSISTED REPRODUCTION.

C 220 L 24 Effective date 6/6/2024

- Creates a new alternative method of committing the crime of assault in the third degree whereby a licensed health care provider implants their gametes or reproductive material into a patient who is under the health care provider's care.
- Classifies a licensed health care professional implanting their gametes or reproductive material into a patient as unprofessional conduct under the Uniform Disciplinary Act.

HB 1455 ELIMINATING CHILD MARRIAGE

C 10 L 24 Effective date 6/6/2024

(SB 5695 Senator Stanford)

- Voids a marriage entered into in which either person has not attained the age of 18 years.
- Eliminates provisions authorizing a court to waive the age requirement on a showing of necessity.

ESHB 1493 CONCERNING IMPAIRED DRIVING

Prime Sponsor: Representative Goodman
C 306 L 24 Effective date 1/1/2026

- Amends provisions relating to the definition of serious traffic offense, ignition interlock licenses, and ignition interlock device restrictions.
- Authorizes a person who participates in a deferred prosecution for a gross misdemeanor driving under the influence (DUI) or actual physical control of a vehicle under the influence (PC) charge to participate in a second deferred prosecution only in certain circumstances and provides that a second deferred prosecution for a DUI or PC offense counts as one point on a defendant's offender score.
- Modifies requirements for participation in a deferred prosecution depending on the nature of the petitioner's underlying problem.
- Changes the period for reviewing prior convictions of impaired driving from a ten-year period to a 15-year period for determining whether the current offense of impaired driving is a felony.

- Establishes requirements for the use of oral fluid roadside tests and instruments used as part of the enforcement of driving under the influence laws.

POLICE DOGS**

(SB 6023 Senator Van De Wege)

C 305 L 24 Effective date 6/6/2024

- Requires the Criminal Justice Training Commission to develop model standards for the training and certification of canine teams to detect fentanyl by July 1, 2025.
- Provides that a state or local government or law enforcement agency is not strictly liable for damages resulting from the lawful application of a police dog.

ESHB 1652 CONCERNING CHILD SUPPORT PASS THROUGH

C 174 L 24 *Effective date 1/1/2026*

- Requires the Department of Social and Health Services to pass through to a family receiving Temporary Assistance for Needy Families all current child support collected each month on behalf of the family.

SYSTEM FOR BETTER COORDINATION AND RECOGNITION

- Expands the crime of rape in the first degree and removes the statute of limitations for rape committed by first responders who use their position to facilitate the commission of the offense.

- Updates statutes concerning firearms background checks to refer to the Washington State Patrol firearms background check program.

C 296 L 24 Effective date 6/6/2024
